Inaugural Session of the Seminar was inaugurated by the then Shri Narender Singh Tomar, Minister of Agriculture, GOI. Shri B.L. Verma, State Minister of Cooperation, Shri Dinanath Thakur, National President Sahakar Bharti, Shri Sunil Gupta, Rashtra Mantri, Sahakar Bharti and other dignitaries were also present on the occasion. Shri Ashok Chhibber, President, Shri Rustam Bali, Treasurer and Shri Surinder Bakshi, Member, Management Committee of the Bhai Mati Dass Cooperative Urban Thrift & Credit Society also attended the Seminar.

Dr. Udhav Joshi, Sahakar Bharti National Mantri, described the importance of Credit Societies in the economic development of the country and the problems being faced by the Credit Societies. This seminar was organized for development and growth of Credit Societies in India and to prepare the charter of demands to be presented to the Govt of India. Shri B.L. Verma, Minister of State for Cooperation, GOI, told that Shri Narender Modi, Hon'ble Prime Minister of India had decided to give importance to cooperative sector, by creating Cooperation Ministry after separating it from Agriculture Ministry. Many changes in the Multistate Cooperative Societies Act have been made and many more shall be made in the near future. Shri Narender Modi, Hon'ble Prime Minister of India's vision on cooperative is Sahakar Se Samridhi (सहकार से समृद्धि). He promised that central government shall do its best to resolve the long pending problems of cooperative sector.

The following charter of demands were raised by Sahakar Bharti for development of Cooperative Sector:

- 1. Deposit/investment in Credit Societies be covered by deposit insurance.
- 2. Income Tax Section 80(2)P and 269 and 269T to cover all credit societies.
- 3. To include credit societies in National Payment System.

- Bhai Mati Dass Cooperative Urban Thrift & Credit Society 4. Credit Societies should also have 'CIBIL' as per banks.
 - 5. For recovery purpose, Credit Societies may also be included in SARFAESI Act 2002 as applicable for banks.
 - 6. Credit Societies may also be allowed to invest in government bonds.
 - 7. CBDT and self-regulation rules be introduced.
 - 8. GST exemption.

Shri Ashish Sinha, Director CBDT also addressed the gathering and assured to consider the problems of Credit Societies. Shri Bhagwat Karad, State Minister of Finance, GOI also assured the delegates to consider the problems of income tax, GST etc. related to his ministry.

Credit Societies from different states of India were awarded mementoes by Sahakar Bharti on this occasion. Four (4) Credit Societies which are more than 100 years in the Cooperative Credit Sector were honoured. Two societies namely, Bhai Mati Dass Cooperative Urban Thrift & Credit Society Ltd, Mehrauli, New Delhi and Vision Cooperative T&C Society from Delhi were also honoured. Memento on behalf of Sahakar Bharti was given by Shri Bhagat Karad, Minister of State for Finance, GOI to Shri Ashok Kumar Chhibber, President, Bhai Mati Dass Cooperative Urban Thrift & Credit Society Ltd. and on this occasion Sh. Rustam Bali, Treasurer, Shri Surinder Bakshi, Member, Management Committee and Smt. Mansi Tiwari, President, Jan Dhan Cooperative Thrift & Credit Society were also present.

IN MEMORIAM

Shri Sant Dass Vaid

■ On 18th January, 2024, it will be 20 years since Shri Sant Dass Vaid Ji, passed on from this earthly domain. His



warm, generous and loving nature lives on in the memories of all who were blessed to be part of Sant Dass Ji's life. And his contributions to nation building are honoured by all those who admired his hard work and dedication.

Born on 10th June, 1925 in Mirpur, Sant Dass Ji was son of Smt Ramrakhi and Shri Naraindas Vaid. He grew up in Lahore and earned an MA

in Economics from Forman Christian College, Lahore. From his youth he was loving and caring person. Throughout his life people admired him for his integrity and kindness. He got great joy from hosting parties and gathering filled with songs. He was deeply devoted to the singing of K. L. Saigal, who was the 'Sangeet Samrat' of that age. Even late in life he often re-watched Saigal films. He was known to cycle from Lahore to Amritsar, just to visit the peaceful Golden Temple.

In 1949 Sant Dassji, joined the Reserve Bank of India as an assistant in the Agriculture Credit Department. In October 1949 he was married to Pushpa, daughter of Smt Parmeshwari and Rai Saheb Bakshi Tekchand Dutt. A dedicated worker who put in long hours, Sant Dass Ji soon became a sectional head of ACD and rose further in the ranks when this department was expanded. With his wife Pushpa Ji's active support Sant Dass Ji went on to become an Internationally recognized expert in rural credit systems. RBI sent him on deputation several times. In 1969 he spent one year working as a consultant at the Asia Development Bank. In 1971 the Food and Agriculture Organization (FAO) selected him to work with the Jamaica Development Bank in Jamaica, West Indies. In 1977 the World Bank selected Sant Dass Ji and he spent three years working in the Asia Pacific department of the bank.

In 1980 he turned down the offer from the World Bank to permanently join their staff and returned to his parent organization – the Reserve Bank of India. He was part of the team that drafted the act of Parliament which created the National Bank for Agriculture and Rural Development (NABARD) which is now the largest public sector institution in the field of agriculture. From 1982 to 1985 Sant Dass Ji served as the first Managing Director of NABARD. After retirement Sant Dass Ji actively worked as a consultant for International organizations and these assignments took him to many countries in Africa and the Asia Pacific.

Sant Dassji is survived by his wife Pushpa, who lives in Mumbai, son Rajiv who lives in Kingston, Jamaica, son Bobby who lives in Los Angeles and daughter Rajni who lives in Mumbai.

In the family, and an extended circle of friends, he is lovingly remembered for his high thinking and simple living. 



- Yatri's coming for Asthivisajaran will be given one room on complementary basis, and complementary langar for all members who return back same day after Asthivisajaran .
- There is no room service meals have to be taken in the Dinning Hall of the Ashram.
- Pets (Animals) are NOT allowed in the premises of the Ashram.
- Yatri's are requested to bring alongwith them their photo identity — same is required for each occupant, of each room.
- 12. Yatri's are requested not to keep the mortal remains (Asthis) of their near and dear ones in their rooms in the Ashram. In order to avoid inconvenience to guests coming from long distances, four lockers have been installed at Mohyal Ashram Haridwar.
- 13. Rooms in Sewa Sadan, Haridwar can be booked for one month, extendable by 15 days depending on availability of accommodation, only on written request by the senior citizens giving details of their permanent postal address and next of kin, alongwith their medical fitness certificate.
- 14. Yatri's are responsible for safe custody of their belongings.
- 15. All payments to the Food Contractor will be made only through coupons issued by the Manager of the Ashram.
- Facility of free langar, is available only to yatri's staying in the Ashram.
- 17. Premises of the Ashrams are meant only for boarding / lodging of the Yatri's and No other activity is permitted.
- 18. In case of any inconvenience, Yatri's are requested to speak to the Manager of the Ashram / Office bearer of GMS. Yatri's are requested to fill the feedback form before their departure.
- 19. Yatri's are requested to help in keeping the rooms and the premises of the Ashram clean. Yatri's are also requested to maintain decorum, while dealing with the staff posted at the Ashrams.
- Donars are requested to furnish their mobile numbers, and preferably PAN / Aadhar number, irrespective of the amount of the donation.
- 21. Yatris are requested to follow Covid 19 guidelines as per existing orders of the local government authorities.

संघर्ष से सफलता की पहली सीढ़ी

मैंने 2015—2018 में दिल्ली विश्वविद्यालय से बी.ए. पूरा किया। अब तक मुझे नहीं पता था कि जिंदगी कौन सी दिशा में जाएगी। इसके बाद मैंने अमेटी यूनिवर्सिटी, नौएडा से एलएलबी की, उस समय निजी जीवन में काफी कठिनाइयां आईं,



लेकिन में मेहनत करने से नहीं रुका। मैं वास्तव में अपने प्रोफेसरों को धन्यवाद देना चाहता हूँ जिन्होंने मेरा समर्थन और मार्गदर्शन किया। जिससे मुझे लंदन से एलएलएम की पढ़ाई करने और दुनिया के सर्वश्रेष्ठ विश्वविद्यालय में गिने जाने वाले Queen Mary University of London तक पहुँचने का अगला कदम मिला। यह निश्चित रूप से आकर्षक लगता है लेकिन एक मध्यम वर्ग और मेरी माँ के लिए, बिना किसी साधन के अपने बेटे को विदेश भेजना बहुत कितन था। मुझे विदेश में पढ़ने के लिए लोन लेने के लिए भी बहुत मुश्किलों का सामना करना पड़ा। लेकिन मैं अपने लक्ष्यों के लिए भावुक और प्रेरित था। उसके लिए मेरे बुजुर्गों का आशीर्वाद मेरे साथ था और भगवान ने भी मुझे सही रास्ता दिखाया। इसलिए मैंने लंदन जाने का फैसला लिया, जिसमें मेरी माँ हर कदम पर मेरे साथ खडी रहीं।

वहाँ आमतौर पर दो तरह की अलग-अलग दुनिया होती हैं। एक, जो आमतौर पर पोस्ट ग्रेजुएट कोर्स के नाम पर छुट्टियों पर आते हैं और दूसरे, जो वास्तव में पढ़ाई और एक्सपोजर

के लिए जाते हैं। इसलिए जो लोग दूसरी श्रेणी में आते हैं, उनके लिए जीवन आसान नहीं है। पढ़ाई महत्वपूर्ण है लेकिन मध्यम वर्गीय परिवार से होने के कारण सरल जीवन जीना भी एक चुनौती है। मेरी मेहनत रंग लाई और मुझे व्हां रहने के पहले महीने ही नौकरी मिल गई। इस नौकरी ने मुझे लंदन में सहारा और इज्ज़तदार ज़िंदगी दी। लंदन दुनिया की सबसे महंगे शहरों में से एक है। लंदन पहुँच कर एलएलएम पढ़ना काफी अनूठा अनुभव था। दुनिया के बहुत सारे औद्योगिक विशेषज्ञों से मिलने का मौका मिला। एलएलएम समाप्त करने के बाद मेरे सामने दो विकल्प आए। पहला, वहाँ नौकरी लेकर काम करना या अपने देश भारत वापस आना। शुरुआत में मैंने वहां एक कॉर्पोरेट नौकरी की। लंदन मुझे जिस तरह का जीवन दे रहा था उससे मैं रोमांचित और संतुष्ट नहीं था। लंदन में ही रहते हुए मेरा चयन भारत के ओ.पी जिंदल ग्लोबल यूनिर्विसिटी में हो गया। इसलिए मैंने अपने दिल की बात मानने का फैसला किया, और वकीलों के लिए अकादिमक (Academic) क्षेत्र में सबसे अच्छी नौकरियों में से एक के साथ भारत वापस आ गया।

इसलिए, आज 25 साल की उम्र में, मैं O.P. Jindal Global University में Assistant Lecturer और Assistant Dean के रूप में काम कर रहा हूँ, जो Law के लिए देश के सर्वश्रेष्ठ विश्वविद्यालयों में से एक है। 2015 में एक छात्र के रूप में विश्वविद्यालय में अपना जीवन शुरू करने से लेकर विश्वविद्यालय में पढ़ाने तक, मैं एक बात निश्चित रूप से कह सकता हूँ, यदि आप कड़ी मेहनत करते हैं तो कुछ भी असंभव नहीं है। मैं हमारे समुदाय के युवाओं से अपील करता हूँ कि मेहनत से आपके बड़े से बड़े सपने भी संभव हो सकते हैं। मैं युवाओं से अनुरोध करूंगा कि वे अपनी जिंदगी में उच्च शिक्षा ग्रहण करें और उच्च पदों पर पहुँचे और मोहयाल बिरादरी का नाम विश्व में रोशन करें।
