



# A REPORT ON GMS MANAGING COMMITTEE ELECTIONS 2021

The election process for the GMS Managing Committee elections started on 8th March 2020 when the Managing Committee at its meeting held on the said date unanimously constituted the Election Committee consisting of the following:

(i) Rzd K.K. Bali, Convener (ii) Dr. Subhash Datta (Member)

(iii) Brig Arun Bali (Member)

(Rzd K.K. Bali had tendered his resignation from the membership of the Managing Committee via email soon after his appointment as Convener).

The Election Committee could not commence its work due to lockdown on account of first wave of Covid-19 which prevented holding of meetings. It was at the Virtual Meeting of the Managing Committee held on 13 December 2020 that the President Lt Gen G.L. Bakshi with the unanimous approval of the House announced holding of elections of the Managing Committee whose extended tenure was expiring on 19th December 2020. Rzd K.K. Bali, Convener, who was also invited to join the virtual meeting, assured the House that he and his team – Dr. Subhash Datta and Brig Arun Bali were committed to hold the elections in a transparent, fair and free manner and the secrecy of the voters will be maintained. He said that the membership of GMS closes on 13th December 2020 and that the existing Committee and the office bearers shall continue in office till the new Management Committee is elected as laid down in the GMS Constitution. He further added that Election Schedule will be notified after receipt of updated GMS Voters List and keeping in mind the precautions to be taken and in view of Covid-19 pandemic enough time will be given to members to participate in the Elections.

As the situation improved the Election Committee held its first meeting on 17 February 2021. Meanwhile the Committee came to know that Shri Sunil Kumar Vaid had filed Civil Suit No 773 of 2020 for permanent injunction against GMS challenging the Constitution and declaring it illegal and restraining the Society from conduct of elections. He also filed a writ petition in the High Court for appointment of a court observer to monitor the elections. However he was allowed to withdraw his petition and allowed to approach the trial court vide order dated 03.03.2021.

The Election Committee however went ahead to finalize the Election Schedule and notified the same on 5 March 2021 which was uploaded on GMS Website and also published in Mohyal Mitter in its March 2021 issue. The Election Committee also introduced changes in the Nomination Form by requiring the Contestants to affix a photograph and also to provide self introduction details for the benefit of voters. While considering the Code of Conduct and Guidelines for Voters, the Committee took innovativesteps to streamline the voting procedure with a view to ensuring that the identity of the voters which, in its opinion was sacrosanct must be protected at all costs.

For achieving this objective the Committee decided to lay down procedure to be followed by voters for return of Ballot Paper to ensure secrecy requesting them to follow steps 1, 2, & 3 by using Pink, White & Yellow coloured envelopes specially devised for this purpose. As a 1st step the completed Ballot was to be inserted in Pink envelope marked "Ballot Paper only" which was to be closed and as a 2nd Step to be inserted in White Envelope on which a voter was required to provide his personal details with a self attested copy of Aadhar Card or Election Card or Driving Licence, as a 3rdand last step the closed white envelope was to be placed in the yellow self addressed and stamped envelope and return the same to the Election Officer so as to reach him not later than 27 August 2021as per revised schedule.

As per election schedule notified on 5 March 2021 the last date of submission of Nomination Form was 20 April 2021 but a day before that date on 19 April 2021 the lockdown was imposed by Delhi Govt. due to alarming spread of Covid-19 pandemic. The Election Committee therefore extended the last date of submission of Nomination Forms to 26 April 2021. Since the lockdown was being extended by Delhi Govt on a weekly basis the Election Committee after reviewing the situation decided on 28 April 2021 to put on hold the election process till further order.

As soon as the situation improved the remaining election process was partially re-started on 28 June 2021 by -

(a)	Scrutiny of Nomination on	2 July 2021
(b)	Withdrawal of Nomination on	6 July 2021
(c)	Display of Names of Eligible Contestants on	8 July 2021

All the 56 Nomination Forms received by the due date i.e. 26th April 2021 were accepted. Shri K.C. Chhibber who had deposited the Security on 19 April 2021 without Nomination Form had approached the Election Committee on 2 July 2021 the day of Scrutiny with his Nomination Form with a request to accept the same. The Election Committee after careful consideration decided not to accede to his request at that stage.

It is interesting that one of the contestants namely Shri Sunil Kumar Vaid had while submitting his Nomination Form, just like other contestants, had given an undertaking as under:

("I undertake to serve the Community wholeheartedly and abide by the GMS Constitution")

and had simultaneously filed a Suit No 733 of 2020 for permanent injunctionagainst GMS challenging the Constitution and declaring it as illegal and to stop it from holding elections. He also impleaded the Election Committee on 03.07.2021. Not satisfied with the Trial Court he approached the High Court which while allowing him to withdraw his petition termed his approaching the High Court "nothing short of Forum Shopping" and "repeatedly approaching this court reflects the conduct of petitioner in poor light" and was made to pay cost of Rs 5000/- in the lawyers welfare fund.

As the situation further improved the remaining election process was started and a revised Election Schedule was notified and uploaded.

All the Ballot Papers were dispatched on 26 July 2021 duly signed by the Election Officer by Speed Post / Air Mail (for members abroad). Daily record of receipt of ballots received By Post/ By Hand and received Undelivered was kept by entering in the Register maintained for the purpose and Ballot papers in yellow envelopes were dropped in the sealed and locked iron box.

Ballot papers were received till closing hours (1700 hrs) on 27 August 2021. Thereafter the space for dropping ballots on the top of iron box was also sealed under signatures of three members of Election Committee and the register closed by drawing a line under signature of the Election Officer. A summary of the Ballots received by Post/By Hand / Email as recorded in the register was prepared and signed by the Election Officer.

Meanwhile the petition filed by Shri Sunil Kumar Vaid in the Trial Court for appointment of Court Observer to monitor elections was dismissed by order dated 17.08.2021. He however approached the High Court vide CM (M) No 50/2021 against the judgment of the trial court. The Hon'ble High Court vide its judgment dated 24.08.2021 refused to interfere on the ground that the election process was already in progress and was at it fag end and dismissed the same as disposed of.

This judgment of the Hon'ble High Court rejecting the writ petition of Shri Sunil Vaid for appointment of a Court Observer was welcomed by the Election Committee which proceeded to complete the election process by organizing counting of votes on 30 August 2021, as per Revised Election Schedule.

On 30 August 2021 at 1000 hrs (as scheduled) in GMS Conference Hall in the presence of contestants / authorized nominees the sealed ballot box was examined by four contestants to ensure that the seals were intact. The box, was got unsealed by Shri Sunil Kumar Vaid and all the envelopes taken out and counted which matched with the summary as per register announced by Election Committee as detailed below. A certificate to this effect was signed by 4 contestants (which included Shri Sunil Kumar Vaid) and counter signed by the three members of the Election Committee

Thereafter yellow envelopes were cut, white envelope was taken out and cut and pink envelope was taken out and, ID paper stapled with the white envelope and kept aside. The pink envelope was cut and the Ballot Paper taken out to be passedonin lots of 50 Ballotsto the counters for processing / scanning. After all the Ballots were taken out from Pink envelopes and processed electronically, the Ballots received by email (22) were processed by taking a print out from each email. Final result was declared and announced by the Election Committee at around 2200 hrs which included number of votes polled by each candidate and the Names of Forty Managing Committee Members so declared elected.

All the Ballots, envelopes, email and undelivered Ballots and relevant record of receipt of Ballots were resealed in the Box in the presence of all.

The Election Committee would like to convey its thanks to all the contestants, thousands of esteemed Members of GMS who participated in the Election process by casting their valuable vote and the GMS staff for their support and co-operation towards ensuring free, fair and transparent election in a very smooth manner.

# SHRI VINOD KUMAR DUTT UNANIMOUSLY ELECTED PRESIDENT GMS

### Date 05 Sep 2021

#### Venue Mohyal Foundation

#### In Chair Rzd K K Bali, Election Officer (Convener) alongwith Brig Arun Bali (Retd), Members of Election Committee (Dr Subhash Datta the other member could not attend being unwell)

As the newly elected members of the Managing Committee entered the Hall one by one they offered floral tributes to Bali Sahib by placing rose petals. Rzd K.K. Bali, Election Officer accompanied by Brig Arun Bali, Member of Election Committee arrived exactly at 11.30 am and were greeted by loud shouts of JAI MOHYAL who after bowing before the photograph of Bali Sahib had taken their seats.

The meeting commenced with recitation of Mohyal Prayer led by Smt Neelima Datta Mehta. Rzd K.K. Bali told the newly elected members to treat Mohyal Prayer as their oath taking.

At the very outset Rzd K.K. Bali remarked that the Team lead by Shri Vinod Kumar Dutt, which has won the elections with thumping majority, had already declared Dutt Sahib as their Presidential nominee which was in their capacity as contestants. Since as per GMS Constitution, power of electing President and others office bearers is vested with the elected members of the Managing Committee we will follow the Constitution and invite the nominations shortly. But before that he would like to say a few words, how he got involved and how the Election process progressed.

Rzd K.K. Bali then narrated how Lt Gen G.L. Bakshi, PVSM (Retd), President of GMS, after the January 12, 2020 meeting of the Managing Committee called him in his chamber and asked him to help GMS in the conduct of Management Committee Elections which after initial reluctance, but due to his forceful persuasion and inspiration from Rzd B D Bali whose photograph he saw on the side table he most humbly gave his consent to undertake this difficult and challenging task.

He thanked Lt Gen G L Bakshi, PVSM (Retd), President and the GMS Managing Committee for bestowing this honour on him and other two members of the Election Committee and reposing their confidence and trust on them on behalf of the community for conduct of elections in a free, transparent and smooth manner.

The Election Committee constituted, was unanimously approved in the Managing Committee meeting held on 8 March 2020, which he did not attend. Soon thereafter he tendered his resignation from the membership of the Management Committee via email as he was unable to send it by post because of lockdown. It was in the virtual meeting held on 13 December 2020 to which he was also invited that the President announced holding of elections and assured the House that the Election Committee was committed to hold the elections in a transparent manner maintaining secrecy of voters. The Committee held its first meeting on 17 Feb 2021 and notified the Election Schedule on 5 March 2021, with 20 April 2021 as the last date of filing of nominations. On the 19 April 2021, lockdown was imposed by Delhi Govt due to 2<sup>nd</sup> wave of Covid-19 and the Election Committee extended the date for submission of nomination upto 26 April 2021. As the lockdown was being extended on weekly basis the Election Committee decided on 28 April 2021 to put the election process on hold till further orders. After reviewing the situation, the Election Committee partially restarted the process by (a) Scrutiny of Nomination on 2 July 2021 (b) Withdrawal of Nomination on 6 July 2021 (c) Display of Names of Eligible Contestants on 8 July 2021.

In this context it is interesting to note that much before the start of election process one Shri Sunil Kumar Vaid had filed a suit questioning the legality of GMS Constitution and demanding to stop GMS to hold elections of Managing Committee and also filed a writ petition in the High Court for appointment of a court observer to monitor the elections based on the observer's comments at the time 2015 elections.

Ironically Shri Sunil Kumar Vaid who had termed the GMS Constitution as illegal in his suit, had filled his nomination form and had given an undertaking as under-

#### "I undertake to serve the community wholeheartedly and abide by the GMS Constitution".

Not only that he had got sent by request on email as many as 48 Nomination Forms to his choicest candidates and paid Rs 100/- each from his account without their consent consequently only 16 candidates had filed nomination form and had paid security deposit of Rs 2000/- each whereas remaining 32 candidates did not bother to use them and just stayed away from him thereby causing him loss of Rs 3200/-. It is pertinent to inform here that during the course of election process Shri Sunil Kumar Vaid tried his best to have a court observer appointed but every time both the Trial Court and the Hon'ble High Court dismissed his plea and had termed his frequent attempts as "Forum Shopping and repeatedly approaching this court reflects the conduct of petitioner in poor light".

As the situation further improved remaining process were commenced and a revised Election Schedule was issued and uploaded.

The Ballot papers were sent to voters on 26 July 2021 as per revised schedule and guidelines in Pink envelope with "Ballot Paper Only" marked on it to protect identity of voters, white envelope for inserting pink envelope in it and providing voters particulars on it and a self addressed and stamped yellow envelope for return of ballots by 27 August 2021 which were recorded in the register on daily basis and then dropped in a sealed and locked in steel box.

The Election Committee was glad to know that the Hon'ble High Court has dismissed the writ petition filed by Shri Sunil Vaid seeking appointment of a court observer to monitor the elections vide its judgment dated 24 Aug 21.

The sealed box was opened in the presence of contestants/nominee. The box seals were got checked from Shri Sunil Kumar Vaid and other 3 contestants and the box unsealed by Shri Sunil Kumar Vaid by breaking the seals and opening the locks. The Yellow Ballot envelopes were taken out counted and the figure of 2116 tallied with figure as per register. A certificate to this effect was signed by four contestants including Shri Sunil Kumar Vaid and countersigned by the Election Committee Members. 9 Ballots received late on 28.08.2021 were accepted with the consent of contestants. In addition 22 Ballot papers were received by email, print out for which were downloaded in the presence of contestants.

After counting the votes, secured by each candidate were recorded and then a list of winning 40 candidates inclusive of 5 ladies was drawn and result announced by the Election Committee announcing the number of votes secured by each winner. The records of receipt of Ballots were resealed in the Ballot Box in the presence of all present.

The Election Committee thanked all the contestants and thousands of GMS Members who wholeheartedly participated in GMS Elections.

Rzd K.K. Bali expressed his special thanks to Lt Col L R Vaid (Retd), Secretary General for placing the GMS Staff at the disposal of the Election Committee for the entire duration of Election process and gave all help to the committee in accomplishing its task in smooth manner.

Brig Arun Bali then called upon the newly elected members of Managing Committee to propose the names of Office Bearers starting with the President. There was overwhelming enthusiasm among the members who vied with each other to propose and second the name of Shri Vinod Kumar Dutt for the Post of President. There being no other candidate for this post Shri Vinod Kumar Dutt was declared elected unopposed, as President, unanimously. Regarding Election of other Office Bearer the House was of the unanimous view that Shri Vinod Kumar Dutt be authorized to nominate his team of Office Bearers. Thereafter Shri Vinod Kumar Dutt announced the following names of Office Bearers who were given a big round of applause by the House:

We have had suggestions to hold GMS events outside Delhi, therefore we clubbed, Presidents and Secretaries Meet and Mohyal Milan, which has been organized by Mohyal Sabha Chandigarh today. Col Vaid, than requested, Shri Vinod Kumar Dutt (National Awardee), President GMS, to give the welcome address and share his vision for the growth and well being of the Community.

Following points emerged after discussion

- (b) Offers were received for provision of Air Conditioners from Shri Ramesh Bali, Mumbai and from Shri Rit Mohan, Panipat for provision of Linen at the Ashrams.
- (c) Members give on voluntary basis, the standard donations (non Mohyal rates) when they book rooms for their stay at the Ashrams.
- (d) Review donations to be given for room bookings at the Ashrams.
- (e) Review donation to be given for Langar Funds.
- (f) Start a drive to increase the membership of GMS, which should include underprivileged members.
- (g) Local Sabhas should also financially help widows of their area.
- (h) Local Sabhas should help youth to get loans for education and their members to get Health Insurance Schemes, through existing Government Schemes.
- Applications for grant of Financial aid to widows and children should be properly scrutinized and needy identified.

Shri P K Dutta, Sr Vice President GMS, in his vote of thanks, expressed his satisfaction and happiness, in the manner, the meeting was conducted, and said that the points raised by the members will be followed up. After this, the members proceeded to attend the Mohyal Milan organized by MS Chandigarh.



### MOHYAL ASHRAMS HARIDWAR AND VRINDAVAN

- 1. Rooms can be booked 30 days in advance, which can be done online, on telephone and also at the counter, in the respective Ashrams.
- 2. Rooms can be booked on twin sharing basis (2 adults and a child below 12 yrs) for a maximum of 3 days. Check in / Check out time is 12 noon.
- 3. Room bookings will be confirmed, only after payment of 50% of room donation. The amount will be forfeited if booking is not cancelled at least 48 hrs before booking date. The donation can be kept in suspense for two months for future booking, if cancellation is done 48 hrs in advance.
- 4. Bulk booking (more than 3 rooms) can be done only after prior written approval of GMS.
- 5. Room donors can donate 25% of the standard room rates (non mohyal rates) or pay the prevalent room donation as per their discretion.
- 6. Donations can be made only in Indian currency.
- 7. Consumption of tobacco, liquor and non-vegetarian food in the premises of the Ashrams is strictly prohibited.
- 8. Persons in inebriated condition will be denied entry to the Ashrams.
- 9. There is no room service meals have to be taken in the Dinning Hall of the Ashram.
- 10. Pets (Animals) are NOT allowed in the premises of the Ashram.
- 11. Yatri's are requested to bring alongwith them their photo identity same is required for each occupant, of each room.
- 12. Yatri's are requested not to keep the mortal remains (Asthis) of their near and dear ones in their rooms in the Ashram. In order to avoid inconvenience to guests coming from long distances, four lockers have been installed at Mohyal Ashram Haridwar.
- 13. Online booking facility for rooms in Sewa Sadan, Haridwar is not available. Rooms can be booked for one month, extendable by 15 days depending on availability of accommodation.
- 14. Yatri's are responsible for safe custody of their belongings.
- 15. All payments to the Food Contractor will be made only through coupons issued by the Manager of the Ashram.
- 16. Facility of free langar (all meals), is available only to yatri's staying in the Ashram.
- 17. Premises of the Ashrams are meant only for boarding / lodging of the Yatri's and NO other activity is permitted.
- 18. In case of any inconvenience, Yatri's are requested to speak to the Manager of the Ashram / Office bearer of GMS. Yatri's are requested to fill the feedback form before their departure.
- 19. Yatri's are requested to help in keeping the rooms and the premises of the Ashram clean.
- 20. Yatri's are also requested to maintain decorum, while dealing with the staff posted at the Ashrams.

# SHRI O.P. MOHAN (Om Prakash) THE SENIOR MOST MOHYAL IN THE MOHYAL FRATERNITY

Few weeks back a historical event took place in the Mohyal Community when Mohyal Gaurav and current Mohyal Conference President, completed his hundred years (100 years) on October, 6, 2021.

Shri OP Mohan had started taking keen interest in the activities of the GMS in the year 1978 around the

time late Mohyal Ratan Rzd. B.D. as its President. At that time, in the two Mohyal stalwarts senior in age each, both born in 1920. on October, 6, 1921 at the residence of his maternal grandfather at a village called Domeili about 50 miles from the Jehlum town. Do meili in Urdu means where the two meet. The two streams/rivers meet there. The Govt. of Pakistan have now constructed a medium sized Dam there about 3 kms from the Domeili village. Domeili these days is right on the highway between Lahore and Islamabad. In olden days, it was on the trading route between India and Central Asia.

Mehta Tirath Ram Mohan father of Shri OP Mohan was working as Head Clerk in the Dept. of Military Grass Farms. Those were the days when there were no tanks in the Army. After infantry, the other important branch of the army was the cavalry with great number of horses, mules, camels and other milching cattles. To feed these vast number of animals the Britishers had started the Dept. of Military Grass Farms. Mehta Tirath Ram Mohan father of OP Mohan Ji got a job in the Grass Farms through the influence of Bakhshi Ram Das Chhibber. Father of Rzd. BD Bali was another such beneficiary and had joined the Military Grass Farms. During earlier days, Mehta Tirath Ram Mohan who was married to Smt. Ram Rakhi (nee Chhibber) of Domeili where O P Mohan Ji was born was posted at Quetta When OP Mohan Ji was around 2 years very unfortunately his biological mother passed away leaving besides OP Mohan a daughter elder to him. There was no arrangement to look after such small children so Tirath Ram Mohan Ji remarried Smt. Kesra Devi Ji from a Dutt family of Lahore. It is this lady who brought up OP Mohan Ji as her own son and most of the credit for the success of Mohan Ji in his life goes to her care and guidance. Shri Tirath Ram Mohan Ji was transferred from Quetta to Lahore Cant. Tirath Ram Ji was suffering from an ailment for which there was hardly a cure during those days. He was admitted to a sanitorium at Kasauli but all efforts failed and Tirath Ram Ji expired in July 1929 when OP Mohan Ji was not even eight yet. The British Government were generous to grant a small pension of around Rs. 40/- to the mother of Mohan Ji and also a scholarship of Rs. 4/- each to the then three children. Elder sister of OP Mohan Ji also expired within months of the death of their father.

Shri OP Mohan Ji received his primary education at Quetta, at Pind Dadankhan with his paternal grandfather and middle school at Lahore where he passed his matriculation with very high marks from the University of Punjab. During his school days Mohan Ji was a very active Scout in the Scouts and Guides Movement. It is during his scouting days that Mohan Ji, experienced, learnt and developed his

habit of doing social service and helping anybody and everybody very actively during all his life. Because of his academic performance OP Mohan Ji was able to get admission into the most prestigious Hailey College of Commerce for a three years B. Com. Course. Another aspect of the life of Shri OP Mohan, was his role in the Quit India Movement and as a freedom fighter. He and his group of people which included Shri Yudvir, son of Mahasha Khushal Chand (later Anand Swami) owner of daily Urdu Newspaper 'Milap' used to prepare anti-British posters and pamphlets. It was Om who used to paste these posters and pamphlets on the walls of the Lahore City. Mohan Ji was apprehended and kept at the Police Station and Lahore Fort for one week each. Fortunately there was a Mohyal DIG (CID), Rai Bahadur Bakhshi Badri Nath Chhibber later resident of 11, Pusa Road, South Patel Nagar, New Delhi who was very helpful and nothing serious was proved against Shri OP Mohan. A condition was imposed on him to report at the Police Station every Sunday morning for one year.

Mohanji married Shakuntla Dutta of Kanjrur Duttan in December, 1945. The marriage party went from

After graduating in Commerce Shri O.P. Mohan joined service with a big Industrial House Bharat Carbon and Ribbons Co. who had their factory at Karachi. He had started at Lahore on a salary of Rs. 40/- with Rs. 25/- as Dearness Allowance. Later he was transferred from Lahore to Delhi. Subsequently he was transferred to Bombay where he worked for 9 years from 1951 to 1960. Mohan Ji who had started at a lower rank in 1943 worked very hard and ultimately became a General Manager and a Director on a salary of Rs. 3,500/-. He did the marketing of their products both in India and abroad. In a very unfortunate accident in 1971, the boss of Mohan Ji and the son of the boss both died in a car accident. Wives of both of them who were on the back seat survived. Since the two ladies did not consider it possible to manage the affairs of the Company they handed over its management to another group, Karam Chand Thaper and Co. The new managers wanted Shri Mohan to continue to work with them. With the death of owners of the Company. Mohan Sahib who had worked for the Company for 28 years was very much disheartened and resigned. The managers did not want to accept the resignation and suggested a better way of allowing him to retire with all the retirement benefits including three months salary in lieu of notice. Mohan Sahib retired amicably in 1972. Mohan Sahib had lot of experience both in the management of a business company and in marketing both locally as well as abroad. He hired an office space in Connaught Place, New Delhi and first started two Companies Kiran International and Kiran Exports in consultation with one of his friends, whom I also know, namely Narender Singh Sethi. The very first supply order he got was worth US Dollars 600,000 for the supply of wooden elephant carving from M/s Matsushita (National), a very big Japanese Company. Mohan Sahib, with his vast experience, was able to arrange the funds from a bank and delivered the consignment within the prescribed time by lifting the goods by air to Japan. This was acclaimed by the Government of India and he won many awards. Mohan Ji also set up a packaging unit in Noida. He became so popular in the industry that he was elected President of the Packaging Association and arranged many Conferences and get-togethers. He also became a very successful member of the Notary Club. Since long he is a member of National Sports Club of India, Air Force Club and the Golf Club, Noida.

Mohan Sahib is a very religious person. This trait he inherited from his mother who also used to arrange Kirtans. He has gone on many pilgrimages. Char Dham, Tirupati, Dhianpur – Gaddi of Bawa Lal Dial Ji (2012), Kailash Mansrover (2002) Kedar Nath (2006), Haridwar functions. He spends most of his time at Sidbhari, Dharamsala where he has a special residential unit. Shri OP Mohan Ji has always been and is till today the biggest contributor of funds ever throughout the history of the GMS. When late Shri Sri Krishan Chhibber arranged the allocation of half an acre plot in the institutional area, the major role for the arrangement of payment of Rs. 3,00,000 was Mohan Ji.



At one stage in the history of the GMS, we did not have any funds to plaster or put windows in our semi constructed Foundation. Fortunately we came in touch with ITC Hotels who were in desperate need of accommodation. They agreed to take our property on as it is and agreeing to finish all the construction work themselves without charging even a single paisa from us. We got on the spot payment of Rs. One crore and eighty lakh. ITC Hotels had a very good Administrator, Col. Rao who was a very good friend of OP Mohan Ji because of which we had very good tenant and owner relationship throughout nine years of our association. After ITC Hotels had moved to their own constructed building, I and Mohan Sahib called on Col. Rao in Gurgaon. He gave as a parting donation by cheque of Rs. 1,00,000 for our on-going work at Inderpuri.We were very much interested in starting a vocational institute, Col. Rao helped us in starting Hotel Management class. It did not progress for lack of accommodation but there was no expenditure from our side The Merit Classes were originally started by Shri OP Mohan Ji with the assistance of another Mohyal, Shri V.K. Bali Shri OP Mohan Ji air-conditioned and renovated the Meditation Hall at Haridwar completely at his own cost. He also installed Shiv Ling there.and furnished the Library at Vrindavan.

I have already written something about the age of Shri OP Mohan and his blessed health. It is not right for anybody amongst us to compare our age with that of Shri O.P. Mohan. It is only the people who were born in 1921 or near about who can do so. In 1921 when Shri OP Mohan Ji was born, the average span of life at birth was only 25 years. In other words the life expectancy of people born in 1921 was only 25 years. Mohan Sahib had already exceeded this limit by 75 years and may exceed by more years in future. There is no secret about the longevity of Mohan Sahib. It is his way of living which we all should follow. I tell these few points here.

- Mohan Sahib lives a very simple and disciplined life. He gets up very early in the morning and regularly goes for morning walks.
- He always eats to live and not live to eat. He always consumes natural and healthy food little less than his hunger point.
- He does not have the dirty habit of always snacking or you may call it grazing. He always eats for nourishment and not to satisfy his taste buds.
- He may have taken moderate quantities of alcohol during his official working obligation but has never exceeded the limit or taken it as a habit.
- Once a week he observes fast and gives rest to his body. He sleeps on time.
- He is always calm and does not speak ill of anybody. He is fully regular and punctual in his prayers and meditation.
- He keeps his body clean both outside and inside.
- He is never under any stress or strain. If this happens sometime he passes it on to the God Almighty having full faith that the problem shall be taken care of.

There is much to write but I end it here with wishing my friend and brother a very happy and healthy life without any worries. Om.

**Felicitations** Shri Nand Lal Vaid on being elected as Member Working Committee GMS wascongratulated by one and all.

Shri Ashok Dutta handed over the stage to our Youth Wing Convenor Shri SandeepChhibber for further conduct of the proceedings. Shri Chhibber requested the VicePresident Shri GK Bali to present the financial papers before the house and also todeclare the Election Schedule.

**Financial Accounts** Shri Bali informed the house that Jalandhar Mohyal Sabha (Regd) was the only Mohyal Sabha that had well maintained its Account Books and Bank Account in a very transparent manner and the accounts were duly audited and passed in the AGM of Sabha every year. But due to Corona spread in the last year 2020 and its continuance during 2021, we could not hold the AGM during 2020 and during 2021 it was delayed. Shri Bali also informed the house that our Sabha had

gained a highreputation in the eyes of top brass of General Mohya Sabha New Delhi. Then Shri Bali presented the Audited Financial Accounts of the Sabha for the last twoyears one by one. He read out and explained in detail each and every entry appearing in the financial papers of both the years. Shri Bali gave the house an opportunity to raise any question or clarification on any entry while presenting the Financial Papers of each year separately, but there was no question raised. The house expressed great satisfaction at the transparency in the accounts. The house appreciated that each andevery donation was accounted for and 99% of payments made during construction of Bhawan were by Cheques. There was a vigorous clapping when Shri Bali informed that an amount of approximately Rs 40 lac was spent on construction of the Bhawan. **Elections for the Post of President** Shri Bali explained that present team of Jalandhar Mohyal Sabha under the able leadership of the current President Shri N L Vaid worked in complete cooperation andunison for the growth and development of community during its tenure. The teamremained in constant touch with the community members. The team put in concerted efforts to collect funds for the construction of Mohyal Bhawan and completed theBhawan in a record time of seven months during the severity of Corona Pandemic inthe year 2020.

The Sabha honoured Brilliant Mohyal Children who passed classes X and X+2 with Marks 75% and above with Cash Awards, Certificates and Medals every year. The Sabha celebrates birth anniversary and Punya Tithi of our great martyr Bhai Mati Dass every year. Recently we organized an Onlime Dance, Painting and Poem Recitation Competition for two groups of Mohyal Children of age groups 10 years and above 10 years. All the children were given Cash Awards, Certificates and Medals. We have regularly conducted monthly General Body Meetings and Executive Committee Meetings despite Lockdowns observing Covid Guidelines. Elections had to be postponed due to ongoing construction work of Mohyal Bhawan and demand of members to hold elections only when Covid Restrictions wererelaxed.

So it was decided to declare the elections in the Annual General Body meeting of theSabha on 26th Sept 2021. As such Shri Bali declared to hold the elections to the post of President on Sunday the 31<sup>st</sup>of October 2021 giving one month notice as per the Constitution of Sabha. Shri Bali further said that this team will work as Care Taker Team and will not take any major decisions except for making statutory paymentslike Electricity and Water Supply Bills or clear the pending dues of expenses already incurred or donations upto Rs 5000/- to any Mohyal Sabha for Mohyal Milans. Only the new team elected on 31<sup>st</sup> Oct 2021 will take all other decisions. Shri Bali also declared that Capt SK Dutta and Dr M B Bali are appointed as Chief Election Commissioner and Election Commissioner respectively to conduct theelections. ## करयाला-एक दृष्टि

टाइटल ''भाई'' से सम्मानित ''छिब्बर'' जाति मोहयाल (सारस्वत ब्राहमण) का गाँव करयाला से अटूट सम्बन्ध रहा है। वर्तमान में पिण्ड (गाँव) करयाला जिला चकवाल (अब पाकिस्तान) में है।



इस पवित्र गाँव की नींव पराक्रमी सूरवीर बाबा परागा जी महाराज द्वारा रखी गई थी। उन्होनें धर्म की रक्षा हेतू कई लड़ाईयाँ भी लडीं। करयाला पाकिस्तान के पंजाब प्रांत में स्थित है। चकवाल जिला सन् 1985 में बनाया गया, पूर्व में यह तहसील हआ करती थी। चकवाल सन 1525 में बसा था।

सन 1947 में पंजाब का विभाजन हुआ था भारत को पंजाब का 44.8 प्रतिशत व पाकिस्तान को पंजाब का 56 प्रतिशत भाग मिला। पंजाब के विभाजन का आधार रेडक्लिफ़ रेखा द्वारा हुआ। पाकिस्तान वाले पंजाब में लगभग 36 जिलों और 146 तहसीलें हैं। तक्षशिला विश्व का सबसे प्राचीन एवं प्रसिद्ध विश्वविद्यालय रहा है। श्री ननकाना साहिब व प्रसिद्ध कटासराज शिव मंदिर इसी पंजाब में है। कटासराज को संस्कृत में ''रोती हुआ आँख'' कहते हैं। ऐसा कहा जाता है कि पार्वती जी के वियोग में शिवजी में जब रुदन किया तो उससे धरती पर उनके आँसुओं से दो कुण्ड बन गए थे, इनमें एं कुंण्ड पुष्कर राजस्थान में ब्रहम सरोवर, तथा दूसरा की कृपा माननी चाहिए। वह भगवान की कृपा को बहुत ऊँचा सरोवर कटासराज मन्दिर में स्थित है।

सम्राट अशोक द्वारा निर्मित स्तूप भी यहाँ स्थित है। महाराजा हरीसिंह नलवा की हवेली सन् 1867 में यहीं बनी थी। चकवाल की सीमा से बड़ा गाँव भूआना–भूवन स्थित है। कटासराज में पवित्र तालाब स्थित है तथा इसका जल पहाड़ों से आता है। तालाब की गहराई लगभग 50–60 फुट है। स्वतन्त्रता के पूर्व वहाँ अंग्रेजों का थाना हुआ करता था। यहार के गूलाब का अर्क ''चौवर्का'' प्रसिद्ध रहा है। कटासराज मन्दिर लगभग 900 साल पुराना है। यह महाभारत कालीन प्राचीन मन्दिर है। यह लाहौर से 270 किलोमीटर की दूरी पर चकवाल जिले में स्थित है। चकवाल में लगभग 730 गाँव हैं। छप्पर बाजार व बैलों की दौड प्रसिद्ध रही है।

चकवाल पूर्व में जिला झेलम का भाग था तथा यह तहसील थी। चकवाल अमीर क्षेत्र रहा है इसकी कुछ दूरी पर खेवड़ा, साल्ट माइन्स है, जो पुराने और डण्डौत की कोयला खानों में है। ज़िला चकवाल पंजाब प्रान्त के उत्तर में स्थित है। ग्राम करयाला–में बाबा परागा जी महाराज की पवित्र समाधी (थली) स्थित है। जिसकी सेवा व देखभाल भाई रविन्द्र कुमार छिब्बर जी कर रहे हैं।


