TEMPLES OF MOHYALS

My dear brothers and sisters,

By the Grace of Almighty we have three operational Ashrams at Haridwar, Vrindavan and Goverdhan. While the Ashram at Haridwar has become very popular with Mohyals as well as Non Mohyals with 100% occupancy during

the season and it has been highly appreciated for environment, cleanliness and sumptuous food being served there, the Ashram at Vrindavan which has been recently completed and is gaining popularity slowly and steadily and I am very confident that it will also catch the imagination of the community. The Ashram at Goverdhan is still in its infancy and we are looking at various options for its optimum utility.

We had conceived these Ashrams as sacred places – like the temples and it becomes utmost necessary to maintain their sanctity by following the laid down norms. It is imperative that all of us including the members of the staff to maintain proper decorum by being polite, courteous and strictly follow the rules, specially the timings, so



proper decorum by being polite, courteous and strictly follow the rules, specially the timings, so that the local Establishment is able to provide better service to the visitors. Unfortunately many instances have been brought to our notice where the rooms are booked, but not cancelled resulting in financial loss to the organisation and inconvenience to other guests on the waiting list. We are giving 50% concession to our Mohyal brothers in room maintenance charges and it has been brought to our notice that some Mohyal brothers accompanied by their non-Mohyal friends insist on their friends also being charged the concessionary rates which is not only unethical but also results in loss of revenue to the community.

Smoking and drinking is strictly prohibited in the Ashrams, but unfortunately few instances have been brought to our notice where the drunk visitors have tried to create nuisance in the Ashrams. We try to keep the Ashrams premises neat and clean but this cannot be done without the active cooperation of the guests and their families. The Ashrams belong to you all and the entire community and the same must be used like our own homes with utmost care. There have also been instances when the guests come at unearthly hours even at midnight, expecting reception and even meals which, you will agree, is not possible. For security reasons the doors of the Ashrams are closed at 11 PM and one should not expect to be received beyond that time excepting under emergent circumstances and by prior intimation. Norms and byelaws governing the Ashrams have been circulated from time to time but on the basis of our experience over the years, I consider it imperative to make it as subject of my editorial.

On our part we are doing our best to make the stay of our guests comfortable and enjoyable. For the comfort and convenience of our guests , we are shortly going to introduce online booking facilities at our Ashrams so that we can bring in more efficiency in reservation of the rooms which, I am sure, will be greatly appreciated.

We have a beautiful laid out meditation hall at Haridwar where we have installed statues of our Sapt Rishis and murtis of our various deities and made some provision at Varindavan also for some rituals and Artis. We have engaged Panditji both at Haridwar and Vrindavan who perform Aarti and I beseech all of you to join the Aarti at the appointed time when you are at the Ashrams to invoke the blessings of Almighty for yourself, your families and the community.

I am not only sure but feel confident of full cooperation from all the members of the community who visit these Ashrams which, I can assure you, by following the laid down norms, will add to your enjoyment and relaxation. However, if there is any genuine complaint at any time it can be put in writing with the Manager of the Ashram with a copy to the GMS Secretariat to take such remedial measures as may be necessary.

He said we as a community have to deal with each other in a humane manner and be more understanding. The Ashram is not designed to provide food round the clock and to receive Guests at odd timings. The staff needs advance notice on time of arrival of guests, number of guests to make the food arrangements and rooms required. The House agreed with him and felt that standing instructions be prepared on basic norms to be followed, to avoid inconvenience to guests & the limited staff.

The lunch was hosted by Smt. Amba Bali on the occasion of her daughter Smt. Pomela Bali Prasad being promoted as Principal Chief Commissioner Income Tax Delhi. Smt. Pomela Bali Prasad who accompanied her mother said that she was pleased to see the community united and doing so much in developmental activity.

The meeting ended with a vote of thanks to the Chair and recitation of *Gavatri Mantar*.

MICRO FINANCE THROUGH CO-OPERATIVE SOCIETY

The co-operative institutions ensure upliftment of financially weak individuals who have meagre resources individually and cannot employ their resources in useful manner to compete with rich. Jointly in a co-operative, they can themselves promote their economic interest by self help and mutual help. The purpose of co-operative, therefore, is to pool the resources of otherwise weaker people and to make a suitable place for them in a society with dignity. The co-operatives are not formed for earning huge profit but to help every individual member to improve his economic condition.

The thrust is on earning profit but profit is not the real motive of co-operation.

A co-operative society is a union of persons established according to the principles of equality, number of whose members is unlimited and the purpose of which is by the joint performance of economic arts, to improve the financial position of its members or the conditions under which they carry on their profession, by means of either self-help or with government support provided that all profits made by the joint action shall be distributed in proportion to which each member has taken part in business and not in proportion to the capital invested.

For purpose of micro finance, we need to form a credit co-operative society where we can do all finance related work. We can accept deposit from members and give loan to members on a particular interest rate. Bhai Mati Dass Co-operative Urban Thrift & Credit Society Ltd is such society which is registered under Delhi Co-operative Societies Act and its area of operation is Delhi. This society was initially registered with 31 members with share capital of Rs.3100j - in 1987 and now has more than 3500 members and working capital of 18 crores. The society has also been awarded best cooperative award in 2000, 2004 & 2009. The Managing Committee of this society is of all mohyal. The Main objects of the society are to promote the economic, social and cultural interest of the members and more particularly to arrange:

- (i) To create funds to be lent to its members for various purpose. $\label{eq:pose}$
- (ii) To undertake Thrift & Credit Business by mobilizing deposits from members.
- (iii) To own lands and buildings or to take them on lease or rent for the business of the society.
- (iv) To undertake welfare activities particularly for the members and employees and their children for the promotion of their moral, educational and physical improvements.
- (v) To undertake other measures designed to encourage in the members the spirit and practice of thrift, self help and mutual help.
- (vi) To do all such things as are incidental or conductive to the attainment of any or all of the above objects.

A large number of mohyal families live in and around Delhi, Gurgaon, Sonipat, Faridabad, Panipat, Kamal, Yamuna Nagar &Ambala in Haryana, Ghaziabad, Meerut, Agra in Uttar Pradesh, Jalandhar, Ludhiana, Khanna in Punjab etc. We need tell the mohyal families to join & form a Multi State Co-operative Credit Society under Multi State Co-operative Societies Act 2002 as it has been done in Delhi . For this purpose an application for registration of a Multi State Co-operative Society shall be made in the prescribed form -form-I and form-2. Form-I, we need the details of minimum 60 members from at least 2 states each with their signatures. In form 2, we need the details of all members with their signatures. Rule-3 of Multi State Co-operative Societies Rule 2002 gives detail of the procedure to be followed for registration of Multi State Cooperative Society. Model Byelaws for such societies are available on websites which can be discussed and be adopted suitably as per our needs. A number of Multi State Cooperative Societies are already registered in Delhi including Health Care & Hospitality Co-operative Ltd. I request, all Mohyals to join and form a unique Multi State Mohyal Co-operative Society to serve Mohyals.

Note: This article is being published as per discussions during the Presidents /Secretaries Meet during the Youth Camp at Vrindavan held in March 2014. Sabha's may contact Shri Ashok Kr. Chhibber for any query and initiate action as they deem fit.



It is believed that the origin of Datt is from Rishi Bhardwai. Their Gotra is also named after him. His son Gaj Bhavan is also considered related to Datts.

As per the history of Mohyals, Rehbab Datt is the founder of the modern Datt clan. He lived in Iraq and was a friend of Prophet Mohammed Sahib's relative. During the Karbala War, Rehbab Datt, with his seven sons, fought on Mohammed Sahib's relative's side and were killed. Thereafter, their families fled and migrated to Afganistan, and there spread in mainland.

Datt family produced many warriors, who served in various courts. One of them, Diwan Bhim Sen Datt, was the Minister and Supreme Commander of Raja Suchet Singh, younger brother of Raja Gulab Singh of Kashmir. Diwan Jawahar Mal was the younger brother of Diwan Bhim Sen.

Diwan Jawahar Mal Dutt had two sons. Diwan Ram Bhai & Jawahar Mal. Diwan Jawahar Mal lived at Gullian (Rawalpindi). Diwan Ram Bhaj had three sons, Diwan Diwan Chand, Diwan Amin Chand & Ram Rattan.

Diwan Amin Chand had three sons, Wazir Chand, Fateh Chand and Prithivi Chand.

Wazir Chand had three sons, Dr. Liaq Chand, Avtar Chand and Hakikat Rai. Dr. Liaq Chand was issueless.

Avtar Chand had three sons, Satish Chander, Suresh Chander and Sudhir Chander.

Diwan Hakikat Rai had three sons, Ashok Kumar, Permod Kumar and Parveen Kumar.

Diwan Amin Chand's third son, Diwan Prithivi Chand, had three sons, Diwan Sardar Chand, Harjas Rai and Romesh Chander. Diwan Sardar Chand had two sons, Jagdish Chander and Harish Chander.

Diwan Harjas Rai had one son, Ranjeet Rai. Diwan Romesh Chander had one son, Anil.

KARYALA

THE BIRTH PLACE OF CHHIBBER SAVANTS AND MARTYERS

Traditionally, the Mohyals mainly inhabited the semimountainous tract between the upper courses of the rivers Indus and Jhelum: principally the area between Kalabagh and Attock in the north-west to Bhera-Khushab in the South-East. The strategic route from Afghanistan to India passing through this region was traversed by Afghan hordes raiding in search of India's wealth and Mohyals, along with other tribes like the Khokhars, periodically faced turmoil.

One Raja Tharpal Chhibber, son of Raja Gaj Sain or Gajju, descended from the stock of Raja Dahar of Sindh, was in search of a suitable place that would be safe when the marauding Mongols or Afghans passed that way—which was very often. He selected a place in the cradle of the Salt Range, not far from Nandana, the garrison fort of Trilochana Pala Vaid, destroyed by Mahmud Ghanznavi in 1024 CE. Raja Tharpal built a fort there called Garh Thar Chack. It was located on the bank of Gambir *nadi* (river). This was during the rule of Bahlol Lodhi (1451-1489). But the family could not enjoy peace for too long. During Babar's campaign to Bhera in 1519, Goutam son of Tharpal was killed and his fort Thar Chack razed to the ground. Here we skip the political history of the event why Babar targeted Thar Chack that was not on his way.

One of the sons of Raja Goutam, named Prag Das, was then twelve years old. Prag Das was of a saintly disposition and spent several years in *tapassaya*—seeking enlightenment. He met Nanak when the Guru was preaching his message in Kashmir. He was baptised in to the Nank Panth and was renamed Baba Praga. Nanak advised him to lead the life of a *grahasth* (house holder) instead of becoming an ascetic (*sanyasi*) in the prime of his youth. Baba Praga returned to his ancestral place Thar Chack, selected a suitable location (Surla Hill) and established the village Karyala. He married the daughter of Tara Chand Vaid, Dewan of fort Sarang (near present day Campbellpur).

The name KARYALA has been derived from combination of two words: KAREEN and WALIYA. 'Kareen' is a green bush which grows in abundance there, used mostly for burning in *tandoors*. 'Waliya' connotes 'resident of'. A small town, in Tehsil Chakwal, District Jhelum (now in West Punjab, Pakistan), it was six miles away from Chakwal, its Railway station—then connected to it by a *kachha* road. On the other side, this road headed towards Choha Saidan Shah, Katas Raj, Dalwal and Kawan Wala Pind—all in the Salt Range.

On account of his deep devotion, Baba Praga became a member of the inner court of Guru Nanak. After the death of Nanak, Praga remained close to the next five gurus. Praga had a very long life and the gurus continued to avail of the devotional as also martial skills of this Warrior Brahmana. In the year 1638 CE, at the hoary age of 138 years, he was called upon by Guru Har Gobind, the soldier-saint guru, to fight against the forces of Shah Jahan. He responded to the call and, along with Nanda, fought against Painde Khan the governor of Lahore. Painde Khan was slain in the battle in village Rohilla near Kartarpur but Praga was also grievously wounded and died on return to Karyala. His smadhi stands on the outskirts of Karyala. Suraj Parkash, chapter 3, eulogises the role of Baba Praga in these words: Burha Praga chal kar aayo, kirpa drishti te gursaayo, pach sau sewar sang kiyo - keho karo tum aage jang. It is noteworthy that one Chhibber family stayed back in Karyala after the Partition, despite heavy odds, to look after the Smadhi and other affiliated estates. Bhai Ravinder Singh, son of Bhai Jagat Singh son of Bhai Surat Singh is the present caretaker and local leader in his own right (member of District Council Chakwal).

After the expiry of Baba Praga, his son Dwarka Das was appointed as the new dewan of Guru Har Gobind and he continued to hold that office up to the time of Guru Har Rai, the seventh guru. The title of "Bhai" was first conferred on Lakhi Das (Bhai Lakhiya) by Guru Har Gobind. In course of time this title was adopted by all Chhibbers of Karyala and has become their mark of identity. Descendants of Baba Praga continued to be the dewans and commanders of the Sikh Gurus up to the tenth Guru Gobind Singh. Mati Das and Sati Das, great grandsons of Baba Praga, were martyred along with Tegh Bahadur, the ninth Guru. Dewan Sahib Chand/ Singh was killed in a battle when the tenth Guru was consolidating his power in the hilly tracts. The body of Saheb Singh was cremated by Gobind Singh with his own hands: Jit bhai tahi Khalsa ki, aur Saheb Chand ki loth uthai. Pandit Kirpa Ram, a Datta from Kashmir (who had been a teacher of Gobind Singh) and Mukand Rai son of Mati Das, were killed fighting the Mughal army at Chamkor along with Ajit Singh and Jajjhar Singh, sons of Gobind Singh. The Chhibber clan of Karyala has an aura and hallow of sacrifice and martyrdom-which did not end with the Muslim rule. Bhai Balmukand Chhibber, born in Karyala in September 1889, was hanged in the old Central Jail, Delhi on 8 May, 1915 for throwing a bomb on the British Viceroy Lord Harding during his visit to Delhi. Bhai Parmanand Chhibber, born in Karyala on 4 November, 1876 who was a distant cousin of Balmukand, was implicated in the famous Lahore Conspiracy Case. Transported for life to Andaman Cellular Jail, where he spent five years and was released on grounds of ill health. His son Bhai Mahavir was the governor of Madhya Pradesh. (With inputs from the writings of late Bhai Jang Bir and Lt. Gen. Dr. M.L. Chhibber)

DALWAL. Towards the end of the eighteenth century, two Chhibber brothers Sain Ditta and Mohkam Chand migrated from Bhera to Dalwal, where they had some relations of Bhimwal caste. Strong and sturdy young men, they started mining salt from a nearby mine and took it to the market of Lahore. During one of these journeys they came across a commotion, near Kamoke. A mule was stuck in mud and despite strenuous efforts the crowd was unable to get it out. Sain Ditta who was returning with his party from Lahore, volunteered to help. He asked the crowd to withdraw, rested and calmed down the nervous animal and then helped it out of mud on his strong shoulders. Ranjit Singh, who was not till then the ruler of Lahore and was the owner of the animal, had been watching this feat. This was his first association with the valiant Chhibber brothers-that lasted till his death-but at that time both went their own ways. When Ranjit Singh became the Maharaja of Punjab, Sain Ditta was appointed on his personal staff to look after his tosha khana. Mohkam Chand was a brave soldier and a good leader of men. He made rapid progress and was appointed the Subedar of Multan. He led a number of campaigns on behalf of his master and was the leader of the Sikh contingent that marched on Kashmir. I understand that the scions of this Chhibber family have taken to education and are well placed in life. There is a "Sain Ditta-Mohkam Chand Chhibbers of Dalwal Education Trust" with GMS. 
Before moving out of this salubrious area let us also visit the village of **Kanwan Wala Pind**, which was next to Dalwal. One does not know how it got this interesting name. Among others, it had a Datt family. Its head had a thoroughbred mare of which he was very proud. Once, the minor revenue officials approached him to lend the services of the animal for use during the impending visit of the Tehsildar of the area. The haughty Mohyal refused on the plea that "the woman, mare and sword

(run, ghori te ta/war) remain only under its owner and are never shared. The minions of the Raj took this affront seriously and had him locked in jail after implicating him in several fake cases. A Mohan in Ahmedabad village, who had retired from the revenue department, heard about it through the official grapevine. After some time when he went to his tehsil town of Pind Dadan Khan to collect his pension, he came to know that the Datt family was finding it difficult to arrange the marriage of their daughter because of this stigma. Before returning home he visited Kanwan Wala Pind and asked for the hand of their daughter for his younger son, who was employed in the Postal Department. His elder son, employed in the Railways, was married in a Chhibber family from Pind Dadan Khan. The two villages are not connected by rail. The marriage was solemnised on the appointed day. A palki (doli) with eight (two sets of four) kahars carried the bride. After exiting the Salt Range area the party headed towards river Jhelum, where boats were waiting to transport them to Ahmedabad. On arrival at Ahmedabad in the afternoon, the bride was first lodged in the building of girls school on the periphery of the village. She was taken home ceremoniously after sun-set - tarian dian chhawan tale. Handsome and healthy, this damsel from Kanwan Wala Pind raised a large family and died in ripe old age at Lucknow.





My revered Grandparents had three sons and three daughters namely Ch. Thakur Dass Dutt (ex-SHO Anarkali, PS Lahore), Ch. Bansi Dhar Dutt (Ziledar Canal department Punjab, Pakistan) and Ch. Manohar lal Dutt (Assistant Superintendent, Department of DG Health Services, of India). Government daughters Smt. Ram Rakhi Vaid (wife of Raizada Amir Chand Vaid of Chawinda and Rev.
