MOHYAL BHAWAN YAMUNA NAGAR BECKONS YOU FOR **FUNDS!**

My dear Brothers and Sisters,

During the last four decades, whenever I have made an appeal for donations towards any noble cause, its response from all of you and the Community has been spontaneous and generous. In this context, I can never forget one



incident at the time of laying down the Foundation Stone of Mohyal Ashram Haridwar, a donation of about Rs Ten lacs was collected in one day in response to my appeal – a very magnanimous gesture indeed.

Today, it is a matter of pride and profound satisfaction that with your generosity and astute planning, we have created land marks for the Community – with buildings of Mohyal Foundation and Inderpuri Bhawan in Delhi and Mohyal Ashram at Haridwar, Vrindavan and Goverdhan - monuments which will keep our Community alive for centuries to come.

Besides, with Communities charitable disposition we posses over Nine Crores in Benevolent Trust funds created by you in the memory of your near and dear ones, which speaks volumes for the trust and confidence the Community has in the creditably of your Apex body.

Today, once again I seek your benevolence with an appeal for funds for the on-going Mohyal Bhawan presently being built at Yamuna Nagar, for which the Foundation Stone was laid down in Sep 2016. The construction of the Bhawan is in full swing and it is expected, that barring unforeseen circumstances it will be placed at the service of the community in Sep/Oct this vear.

I may like to add that next to Delhi, lot of Mohyal families are settled in Yamuna Nagar, Jagadhari and adjoining areas and the project will not only enhance their image but greatly benefit them as their own assembly point.

The elevation of the building is superb – planned by a renowned Architect and one of our own brethren Shri Satish Bali. It is being built on stilt to provide additional space and parking area, one multiple hall on ground floor to hold about 250 people and on First floor five guest rooms with all modern facilities. The entire project in first phase will incur an expenditure of about Rs.2.25 crores and while GMS will pitch in their might, the project cannot be completed without your active financial support which, I feel sure, will come out in abundance.

It is planned that donations for the project be grouped as under-

- (a) All donations be collected by affiliated local sabhas from members of the biradari in their jurisdiction and remitted to GMS. All donations for Rs 50,000/ and above from each Sabha will be placed on 'Board of Honour'.
- (b) All five guest rooms be placed at the disposal of the community for Rs. 3 lacs (though the cost is almost double) and the name of the donors will be written on the Slab placed, like in other Ashrams.
- (c) Towards the multiple hall, any sizable donation between Rs 25-50 lacs will be welcome. The Hall may be named after the donor or his near and dear ones.
- (d) In addition to above, we will welcome all the donations, of any denomination received at GMS office. It is my desire that at least 'one brick' be donated by everyone for your 'own' project.

I am sure and feel confident that all members of the Community will come forward and donate liberally for a very deserving project. It will be my pleasure to acknowledge each donation personally and would look forward to your liberal and prompt response.



ANNUAL GENERAL BODY MEETING 18 MARCH 2018 Report by the Secretary General, GMS

My Dear Brothers and Sisters, JAI MOHYAL

I am honoured to be part of this August gathering and feel very happy to see members having come from far of places — a very warm welcome to each one of you. Today is a very auspicious day being the first Navratra, A separate food counter has been arranged for members observing Navratras. We have all assembled here today as Sewaks of the Community. We look forward to a meaningful interaction on how to reach the underprivileged members of our Community and help them in all possible ways we can. We should think what we can do for the Community and how to take it forward. Agenda points have already been sent to you. EGM scheduled to be held after lunch has been cancelled in order to give more time for interaction.



I will now update and refresh you on the events which have taken place since the last AGM which was held at Mohyal Foundation on 16 Oct 2016, details of which have been published in Mohyal Mitter Nov 2016 issue

Our top priority is education which is very important to progress and to take the Community forward. Rzd B D Bali, our visionary leader wishes that no mohyal child should be deprived of education for want of funds. I am pleased to inform you that our Schools at Dehradun and Haridwar are running smoothly. Major K R Bali Mohyal School at Dehradun has been upgraded to class 8th and has 220 students and Mohyal Public School at Haridwar has been upgraded to class 5th and has 80 students. CCTV cameras have been installed in the Schools. Financial help is given for education to 74 needy children ie Rs 250/ pm to Rs 3000/ pm depending on the class in which the child is studying. The aid is being sent through money order twice a year We plan to send it through Bank after we receive the bank details of the beneficiaries. Adopt a Child Education Scheme has not yet taken off for want of names of deserving children. The scheme envisages provision of comprehensive support to children from financially weaker sections of the community, from Primary to Graduation stage, and who have also to cope with the unfortunate loss of either one or both the parents.

The world is moving at a very fast pace due to rapid development of technology. One has to excel to find a suitable job placement. We have to motivate our youth to do well academically Pratibhashalee Mohyal Vidyarthee Samman function is being held since 2003, to honour and encourage brilliant students.14th Pratibhashalee Mohyal Vidyarthee Samman was held on 22 Oct 2017 for students of class X and class XII scoring 85 percent and above marks. 84 Students were honoured ie 33 students of class XII (boys 13, girls 20) and 51 students of class X (boys 20, girls 31). 17 Students (boys 6, girls 11) of class XII scored over 90 percent marks and 15 Students (boys 7, girls 8) of class X scored 10 CGPA. A declamation contest is also held during the awards function to encourage students in public speaking.

It has been our endeavour to involve the youth in the Community affairs. A seminar on career guidance and entrepreneurship for mohyal youth was organized by MS Khanna on 27 Nov 2016 and was attended by nearly 800 participants and top technocrats. Experts from different fields addressed the youth, to guide them to choose a career of their choice. The programme was a grand success and was greatly appreciated. In order to improve bonding among the youth, MS Khanna has also been organizing cricket matches and sports activity involving youth of local Sabhas.

We are committed to help the needy widows and the underprivileged members of the community. Financial assistance of Rs 1000/ pm is being given to 477 widows and 94 other needy persons. Financial assistance which was being sent through money order, is now being sent directly to the bank accounts of most of the individuals since June 2017. All beneficiaries have been requested to forward their bank details where they wish to receive the financial aid sent by GMS. We are also committed to help young widows stand on their feet by financially supporting them to acquire skills/ professional training to become financially independent. Financial assistance for medical treatment, is also being given on need to need basis.

125th Sthapna Divas and 52nd Mohyal Conference was held at Talkatora Indoor Stadium on 12 March 2017. The function was a tremendous success with the participation of nearly 3000 mohyal brothers and sisters. The

environment was full of cordiality and brotherhood. The documentary on mohyal history was a big hit. Mohyal Ratna awards were presented posthumously to Padma Shri Sunil Dutt and Shri Anand Bakshi. Sanjay Dutt received the award on behalf of his father and Siddhant Bali received the award on behalf of his grandfather. In addition, members of the Community were honoured by giving them awards for their dedicated services to the community.

In order to encourage and facilitate marriages within the community, quarterly matrimonial get togethers are held at Mohyal Foundation on last Sunday of each quarter. 7th Matrimonial Mela was held on 20 March 2016.

Presidents and Secretaries meet of local affiliated Sabhas was held on 28 Jan 2018, where we had a healthy interaction with the focus on how to take the community forward. Local Sabhas are encouraged to hold Mohyal Milans in their areas and are given a Shagun of Rs 21000/. The aim is to promote brotherhood by giving an opportunity to members to interact with each other. Sabhas have been requested to observe austerity and avoid wasteful expenditure on mementos, shawls, flower bouquets etc. To facilitate interaction in areas having mohyal settlements, new Sabhas have been raised at Bholath, Bhatinda, Jind, Dharamshala and Alwar for which the credit goes to Shri J P Mehta President MS Ambala City, Shri Rit Mohan, Secretary Public Relation and their team. An exercise is underway by local Sabhas to carry out a Mohyal Population Census and is to be completed by 31 March 2018.

Foundation stone of Mohyal Bhawan at Yamuna Nagar was laid on 11 Sep 2016. Construction started on 9 June 2017 and is planned to be completed by Oct 2018. Members are requested to come forward and donate whole heartedly for this prestigious project of the community — Rs 3 lacs for a room and Rs 51,000/ from local Sabhas.

Consecration of idols in the newly built Mandir at Mohyal Ashram Vrindavan was done with vedic rituals from 2nd to 7th May 2017. Shri Narinder Mohan from USA donated Rs. 10 lacs towards this Mandir in memory of his wife Smt Kusum Mohan. Shivlinga Pratishtha (installation) was done at Meditation hall of Mohyal Ashram Haridwar on 22 Feb 2018 with chanting of mantras. Shri O P Mohan former Sr Vice President and President of 52nd Mohyal Conference, donated Rs. 4 lacs for the Mediation Hall of the Ashram A Schindler lift (8 passengers) was installed in B block of Mohyal Ashram Haridwar in July 2017. Three parks around the Ashram were allotted to GMS for development and maintenance by Haridwar Development Authority in Dec 2016 and the work is in progress. We are exploring the possibility of adding one floor each in A and B blocks of the Ashram with a view to cope up with the increased demand of the Community.

Timely delivery of our monthly magazine Mohyal Mitter has been a cause of great concern. After interacting with tech savy youth we learnt that the magazine can be uploaded on our smart phones through Whatsapp, which is being implemented.

Registrar of Trademarks GOI, has registered the General Mohyal Sabha alongwith the logo under the trademarks act 1999. Also renewal has been granted for the trademark MERIT upto 2027.

MERIT was established in 1999 to impart computer education, besides facilitating research in the IT field. It has been accredited to the National Council for Vocational Training for conducting Computer Operator & Programming Assistant course (COPA) since 2008. It is also a Programme Study Centre of IGNOU for conducting their distance education courses in BCA/MCA/CCITSK/ACISE/PGCGI/ PGDAST programmes. It has also been a testing centre for TOEFL (since 2007) and GRE (since 2013) and has set up two State - of Art Computer Labs, in 2014, for conducting these tests. It became an IGNOU Exam Centre in 2014 for conducting exams for all the programmes offered by IGNOU. As an incentive, no fees are charged from the Mohyal students admitted to COPA course in MERIT. Those, who get admission in MERIT study Centre for BCA & MCA courses of IGNOU, will be reimbursed 50% of the fees.

Credibility and financial stability of GMS continues to show steady progress. We have a healthy bank balance and fixed assets in the form of Ashrams/Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri and Mohyal Foundation. No loans have been taken to create these assets which belong to the Community. Trust money is sacrosanct and is not touched, only the interest accrued is used. This is due to our visionary leader Rzd B D Bali and our large hearted Community. The rental income from the portion of premises given on rent in Mohyal Foundation was a major source of our income, which helped us to fund the welfare projects, is not available from the last one year, since we are not getting a suitable tenant in line with our expectations inspite of regular advertisements given in the newspapers. ANNUAL GENERAL BODY MEETING 18 MARCH 2018

Report by the Vice President GMS (Legal & Finance) Account and Budget Proposals

Bakshi B.L. Chhibber I.R.S. (Retd.) Vice President Legal and Finance presented the audited accounts i.e.

Income and Expenditure Statement and Balance Sheet for the F.Y. 2016-17 ended on 31.03.2017, copies of which had been sent to all the members alongwith the notice of the meeting sent by courier service on 11.02.2018. Budget proposals were circulated to all the members present in the meeting.

Shri Chhibber stated that regular books of account have been maintained which were audited by the Chartered Accountants, M/s. Ahuja and Company, New Delhi who are satisfied that the said accounts give a true and fair view of the state of affairs of the society as on 31.03.2017. After extending his best wishes to the audience for the auspicious and happy *Vikrami Samvat 2075*, he gave detailed analysis of the budget and financial position of the GMS and submitted that sound financial policy is being followed by the GMS i.e. income should always be more than the expenditure. In this connection, he cited Sanskrit Shloka from Ramayana containing discussion between Lord Rama and his Younger Brother Bharata wherein Lord Rama said that income should be more and expenditure should be less and Revenue should not go



into the hands of undeserving citizens. Following this sound financial dictum, the accounts reveal excess of income over expenses at Rs.24,00,817/- as against Rs.10,87,273/- of the preceding year- increase of Rs.13,13,544, though there was fall in the rental income from the portion of the rented property by Rs.20,73,600/- because the tenant vacated the premises of the part of the building on 31.01.2017 and the rented portion remained vacant for two months.

Explaining the salient features of the accounts, he submitted that the rental income was Rs.1,38,24,400/- and the interest income was to the tune of Rs.76,82,572/- as against 70,04,385/- in the preceding year - an increase of Rs.6,78,187/-, mainly due to increase in corpus fund of the Trust. As on 31.03.2017 the corpus amount stood at Rs.8,71,92,590/- as against Rs.8,21,34,934/- of the preceding year - an increase of Rs.50,57,656/-. Number of Trusts is as follows:-

During the year under review donations received were to the tune of Rs.1,22,78,379/- as against Rs.1,10,76,694/- of the preceding year - an increase of Rs.12,01,725. Income from Tuition Fees was to the tune of Rs.47,34,405/- as against Rs.41,47,652/- of the preceding year - an increase of Rs.5,46,753/-. Contribution/ Honorarium from Indra Gandhi Open University and Jamia Milia Islamia stood at Rs.16,35,969/-.

After giving analysis of the main sources of income, he analysed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs.54,91,500/- against Rs.47,20,892/- in the preceding year- an increase of Rs.7,17,608/-; Relief and Welfare Fund to Needy and Destitutes - Rs.41,41,805; student welfare- Rs.2,48,362/-; Staff Welfare - Rs.6,93,118/-; total Rs.50,83,285/- as against Rs.40,31,867/- of the preceding year - increase of Rs.10,51,418. Further an amount of Rs.75,51,387/- was paid on account of establishments; a sum of Rs.7,52,679/- was spent on Building and Repair and Maintenance.

Coming to the budget proposals; he submitted that a sum of Rs.60,00,000/- has been earmarked for Widow's Welfare; Rs. 18,00,000/- has been earmarked for Relief Fund; a sum a Rs.55,00,000/- has been earmarked for MERIT and similarly adequate funds have been provided for under different heads in the detailed Budget.

He concluded that the accounts of the GMS were being maintained most meticulously both in traditional form by Double Entry Book keeping as well as through computers and every paisa of money received and expense incurred has been duly accounted for. He called upon the August Audience to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. The total value of such Trusts opened by individuals and the Langer funds exceed Rs. 8 Crores. Only interest thereon is used for activities of the GMS keeping the capital intact. He further added that these trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of Trusts and the Trust Money reflects the confidence of the Community in the working and credibility of the GMS under the visionary, dedicated and

devoted leadership of our illustrious President, Raizada B.D Bali. He further added that Trusts are being augmented and money added everyday by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposit and only the interest accrued thereon is utilizied for the purpose for which the Trust is created.

ACIDITY & ITS EFFECT ON GENERAL & ORAL HEALTH

Before going in detail, I would like to put glimpse on what is pH? & how it's relates to acidity of our body.

The pH is a short for the potential of hydrogen. It is a measure of the acidity or alkalinity of our body's fluids and tissues. Its level quantified on a scale of 0 to 14.

←0 1 2 3 4 5 6 7 8 9 10 11 12 13 14 {N* means neutral pH)

BAD (Lower the pH: more acidic our body) N* (higher the pH: more alkaline our body) GOOD

Healthy level range: 6.0 to 7.5

What are the effects of acidity on general & oral health?

S No.	General Health	Dental Health
1	Allergies, asthma and congestion	Demineralization action resulting in dental enamel erosion
2	Fatigue	Discoloration of teeth
3	Frequent colds	Sensitivity to hot, cold or sugar drinks
4	Headaches	Tooth decay or cavities
5	Inflammation	Gingivitis (inflammation of gums) and other pathological changes in the mouth
6	Joint and muscle pain	Gum recession
7	Skin problems	Broken fillings
8	Ulcers	Loss of calcium
9	Weight gain	Ulcers in mouth

So, over acidity can become a dangerous condition that weakens all body systems & it is very common today.

Human body Produces acid as a byproduct of metabolism (through eating & digestion), all day & every day

Secreted & digested acids eliminated through

Body by either — Blood stream | Filtered by kidneys(urine) | Perspiration(sweating)

The main causes of acidity are higher intakes of refined carbohydrates, acidic foods and beverages, consuming sugar and other high-glycerin foods that affects the body's metabolism, reduces fat burning. Body fat & acidic pH is directly proportional to weight gain & bad oral health. So, our life style & eating habits or our diet is the main cause of ACIDITY OR IMBALANCE BETWEEN ACID – ALKALINE PH IN OUR BODY.

Here are the some tips to rebalance our pH & plan to stay healthy. Because "Our Health is Our Wealth"

By adapting healthy lifestyle and doing some habit adjustments like (reduce stress, proper exercise & good sleep)

- 1. Do not drink sugary soft drink sip it over an extended period of time. Drink it down in one go or quickly. Follow up with water.
- 2. Do not brush teeth immediately after drinking a soft drink, cider or fruit juices.
- 3. If at all possible, when drinking coffee use a form of milk, not a sugary flavored creamer, to counteract the acidity.
- 4. **Go 80/20**. In other words, eat 80% alkaline foods and 20% acidic foods. No refined flour products, junk food or highly salty and sugar coated meals. **You need 8 servings of fresh fruit and vegetables** to keep your body alkaline (spinach, cucumber, bell pepper, papaya, apple, ginger, cinnamon, melons, garlic, onion etc)
- 5. Drink lots of water (pH 7).
- 6. A sufficient amount of chewing (32-40 times)
- 7. Lemons and limes are alkaline foods although they are high in acid. (Lemon water after meal or squeezing lemon over food)
- 8. Broccoli has high water content. Its alkaline pH balance affects weight loss.
- 9. Raw garlic is a natural antibiotic. Garlic is a folk remedy for everything from colds and toothaches to lowering blood pressure.
- 10. **Detoxification** once a week. (Like cucumber mint ginger lemon water)
- 11. Breathe. Do deep breathing exercises three times a day, Exercise for 20 minute every day or brisk walk.

Natural saliva variation

There are times in life when, no matter what you do, saliva seems to become acidic. The hormones of pregnancy appear to change saliva and put women's teeth at risk for acidic damage. Stress and sickness also create times of mouth acidity. Other variations occur like a rhythm, with daily fluctuations in pH and flow rate (diurnal variation). Saliva is least protective at night and in the early hours and most alkaline and protective in the afternoon.

Early signs of acidic body are:- heart burn, metallic taste, dark yellow color & strong smell of urine, fatigue, bloating, constipation, and headache.
