PROCEEDINGS OF ANNUAL GENERAL BODY MEETING HELD ON 10 MARCH 2019

Annual General Body meeting was held at Mohyal Foundation on 10 March 2019. The programme started at 1030 hrs, with Registration wherein members signed their attendance on arrival at the venue. Refreshments were served to members and it was very heartening to see the members interacting with each other and exchanging pleasantries and checking on each others well being. Lt Gen G L Bakshi, PVSM (Retd) Sr Vice President, unfurled the Mohyal Flag, which was followed by chanting of the Mohyal prayer by the members led by Smt Neelima Datta Mehta and roars of 'Jai Mohyal'. The dignitaries were escorted to the dais after Deep Prajwalan by Lt Gen G L Bakshi and honourable members.

Lt Col L R Vaid (Retd), Secretary General welcomed the members and said that he was honoured to be part of this August gathering of the community and looked forward to a meaningful interaction to take the community forward. He said our visionary and revered leader, Rzd B D Bali was indisposed and will not be able to come for today's meeting and prayed for his speedy recovery. He then read out the message from Rzd B D Bali, President GMS.

'My dear brothers and sisters,

The tremendous progress made by the community has been possible because of the unity of the community over the years and that has to be maintained at all cost, to ensure progress and prosperity of the community.

Our top priority is education and no mohyal child should be deprived of education for want of funds.

Wishing the function all the success. God bless you all'

The House wished Rzd B D Bali speedy recovery and responded with loud roars of JAI MOHYAL.

Col Vaid, gave details of the programme and said that the Business Session will include, Report by the Secretary General, Presentation of Accounts and Passing of the Mandatory Resolutions and Points from Members. He said, before we start the Business Session, we will pay homage to all members of our Biradri who have left for their heavenly abode, by observing two minutes silence and pray to God Almighty to grant them eternal peace. The House stood up and observed two minutes silence as a mark of respect for the departed souls.

He said that, Lt Gen G L Bakshi, PVSM Sr Vice President GMS, was a very senior and decorated army officer, will preside over the meeting in the absence of Rzd B D Bali. He then requested Gen Bakshi to give the welcome address. Gen Bakshi said that it was his privilege and pleasure to extend a warm welcome to everyone for the AGM. He said that it was a nice opportunity for members to meet each other. He explained the purpose of the AGM, which was basically to approve the income and expenditure of the GMS, approve the budget for the next financial year

and pass the mandatory resolutions. Points from members concerning policy matters can also be taken up for discussion. He said that the organization was doing very well which was basically due to positive contribution of the members, who all have a common aim to take the community forward.

Lt Col L R Vaid (Retd), Secretary General GMS, read out his report which gave details of the activities of the GMS since the last AGM which was held on 18 March 2018. The report is printed elsewhere in this issue of Mohyal Mitter.

Bakshi B L Chhibber IRS(Retd), Vice President GMS (Finance & Legal), presented the audited accounts for the financial year 2017-18 and the Budget proposals for the financial year 2019-20. After giving item wise explanations in the audited accounts and the budget proposals, he put six resolutions to vote which were passed unanimously. The report is printed elsewhere in this issue of Mohyal Mitter.

Secretary General said, he was pleased to inform the House about the donations received from members of our large hearted community and invited them on stage to say a few words, which they did amongst loud applause from the House.

- Rs 5,00,000/- (Rs Five lacs) from Smt Sangeeta Dutt, wife of Shri Vinod Dutt, Vice President GMS, for education of needy students/ children. The lady was represented by her soft spoken philanthropist husband Shri Vinod Dutt, Vice President GMS.
- Rs 3,00,000/- (Rs Three lacs) from Shri Rahul Mehta, son of Shri Inder Mohan Mehta, towards one room at Mohyal Ashram Haridwar. Donation was received through Shri Bunty Bali, youth Secretary MS Yamuna Paar.
- Rs 2,31,000/- (Rs Two lacs and thirty one thousand) from Mohyal Sabha Ashok Vihar, through its youth President Shri Manu Mehta and his team, as part donation towards one room at Mohyal Ashram Haridwar.
- Rs 2,00,000/- (Rs Two lacs) from Mohyal Sabha Faridabad as final instalment towards one room at Mohyal Ashram Haridwar.
- Rs 5,000/- per month by Smt Prabha Mehta (member Managing Committee GMS), daughter of late Ch G L Datta (Josh), towards Education Fund Trust of GMS, for her lifetime from April 2019 onwards.
- Rs 1000/- per month to support one widow of GMS (amount as decided by GMS from time to time), for his lifetime by Shri Vipin Mohan, President MS Yamuna Nagar. He also appealed to the House for donations for construction of facilities at Mohyal Bhawan at Yamuna Nagar.

Shri Vinod Dutt, Vice President GMS, said that our endeavour is to make our Ashrams self sustaining. However GMS has to subsidise langar funds of Mohyal Ashrams at Haridwar and Vrindavan due to drop in the interest rates of the Banks, as we use only the interest accrued on these donations. He also recommended that local Sabhas should sort out their own problems and elect their team to represent them in various forums.

The House unanimously approved the resolution moved by Shri Vinod Dutt, Vice President GMS, to dispose off our properties (Bhawans) at Inderpuri Delhi and Goverdhan and use the money so collected in the best interests of our Community. Shri P K Datta, in his vote of thanks, said that our Community was our biggest asset and we should all think of taking our community forward and get rid of our ego which is a hindrance to growth and development of the Community. The meeting ended with a vote of thanks by Shri P K Datta, Vice President GMS, which was followed by Shanti Path and lunch.

ANNUAL GENERAL BODY MEETING 10 MARCH 2019

Report by the Vice President GMS (Legal & Finance) Accounts and Budget Proposals

Bakshi B.L. Chhibber IRS (Retd.) Vice President Legal and Finance presented the audited accounts i.e. Income and Expenditure Statement and Balance Sheet for the Financial Year 2017-18 ended on 31.03.2018, copies of which were sent to all the members alongwith the notice of meeting sent by Speed post & Air mail on 06.02.2019. Budget proposals for the Financial Year 2019-20 were circulated to all the members present in the meeting in advance.

Shri Chhibber stated that GMS was registered under the Indian Society Act, 1860, and under Section 12AA of Income Tax Act, 1961 as charitable institution. Accordingly regular books of accounts are being maintained as per the requirements of the legal provisions of the above noted two Acts and were audited by the Chartered Accountants M/s H.S. Ahuja & Company who after thorough examination and scrutiny have certified as follows:

"Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in India. Those Standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

In our opinion and to the best of our information and according to explanations given to us, the said accounts give a true and fair view:-

- (a) *In case of the Balance Sheet, of the state of affairs of the society as at 31st March 2018; and*
- (b) *In case of the Income and Expenditure Account, of the excess of Expenditure over Income for the year ended on that date."*

Explaining the salient features of the accounts he submitted that income from general donations was to the tune of Rs.1,31,28,149/- as against Rs.1,22,78,379/- of the corresponding previous year-an increase of Rs.8,49,700/-. Income from bank interest was to the tune of Rs.63,15,740/-, mainly on the corpus fund of the trusts. As on 31.03.2018 the corpus amount stood at Rs.9,12,03,016/- as against Rs.8,71,92,590/- of the preceding year-an increase of Rs.40,10,426/-. Number of trusts is as follows:

A. Individual Trusts	544
B. Haridwar Langer Fund Trusts	2088
C. Vrindavan Langer Fund Trusts	578
Total	3210

During the year under review income from tuition fee was to the tune of Rs.54,66,708/- as against Rs.47,34,504/- of the preceding year. Contribution/Honorarium from Indira Gandhi Open University was to the tune of Rs.14,68,264/-.



After giving analysis of the main sources of income, he analysed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs.55,41,250/- as against Rs.54,91,500/- in the preceding year; Relief and welfare to Needy and Destitutes was to the tune of Rs.46,38,637/-. Financial aid for education was to the tune of Rs.10,84,225/-. Expenditure on staff welfare stood at Rs.1,95,049/-. Further an amount of Rs.97,45,778/- was paid on account of establishment-a sum of Rs.14,79,539/- was spent on Building and Repair and Maintenance.

Coming to the budget proposals, he submitted that a sum of Rs.60,00,000/- has been earmarked for widows welfare; Rs.18,00,000/- has been earmarked for relief fund. A sum of Rs.51,69,000/- for MERIT, a sum of Rs.75,00,000/- for Ashram Fund at Haridwar, a sum of Rs.48,00,000/- for Vrindavan Ashram, provisions of Rs.50,00,000/- Yamuna Nagar Community Hall Fund. Similarly adequate funds have been provided under different heads in the detailed budget. The budget estimates for the Financial Year 2019-20 show a surplus of Rs.36,98,725/- (Receipts Rs.4,89,67,725/- expenditure Rs.4,52,69,000/-).

In conclusion he reiterated that the accounts of the GMS are being maintained most meticulously both in traditional form by Double Entry Book Keeping as well as through computer and every paisa of money received and expenses incurred have been duly accounted for as per the statutory provisions and under the guidance of expert chartered accountants. He reminded the August audience that the small sapling planted by our visionary ancestors one hundred twenty eight year ago in 1891 has grown into a Big Banyan Tree-healthy and strong providing soothing shade under which the members of community rejoice. He called upon the members to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. The total value of the Trusts opened by the individuals and Langer funds Trusts exceed Rupees 9 crores. Only interest is used

for activities of the GMS keeping the capital intact. He further added that these trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of trusts and the Trust Money reflects the confidence of the Community in the working and creditability of the GMS under the visionary, dedicated and devoted leadership of our illustrious President Rzd B. D. Bali and his dedicated team and all present in this meeting. He further added that Trusts are being augmented and money added every day by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposits and only interest accrued thereon is utilized for the purpose for which the Trust is created. He exhorted the audience to be proud of the legacy of our illustrious and foresighted forefathers and count on their blessings and put concerted efforts to carry on the rich legacy for further generations to come. He concluded by invoking the following shloka of Riga Veda.

REPORT BY SECRETARY GENERAL GMS

My Dear Brothers and Sisters, JAI MOHYAL

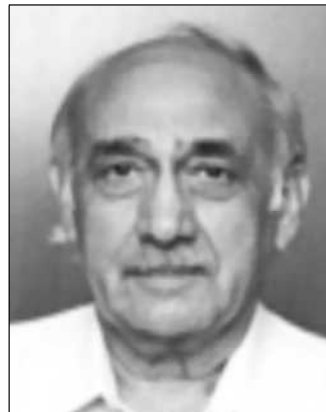
I am honoured to be part of this August gathering of the community and extend a very warm welcome to each one of you. We look forward to a meaningful interaction on how to reach the underprivileged members of our Community and help them in every possible way. We should continue to think, what we can do for the Community and how to take it forward. I will now update and refresh you on the events which have taken place since the last AGM which was held at Mohyal Foundation on 18 March 2018, details of which have been published in our monthly magazine, Mohyal Mitter April 2018 issue.

Our top priority is education, which is essential to make progress and to take the Community forward. Rzd B D Bali, our visionary leader, desires that no mohyal child should be deprived of education for want of funds. I am pleased to inform you that our Schools at Dehradun and Haridwar are running smoothly. Major K R Bali Mohyal School at Dehradun upto class 8 has 263 students and Mohyal Public School at Haridwar upto class 5 has 118 students. A School Education Committee has been constituted to look into all aspects of education in the schools being run by the GMS and they have started working with full enthusiasm. Financial help is being given for education to 79 needy children ie Rs 250/ pm to Rs. 3000/ pm depending on the class in which the child is studying. The financial aid is being sent twice a year. Adopt a Child Education Scheme – adopt a child means to take full responsibility of the child till he /she can stand on its own feet. Identification of the child is a sensitive issue since GMS is already giving financial aid for education to children, some of them do not have a parent. Local Sabha's need to identify deserving children for this scheme and also find a volunteer to take care of the child. We have received 62 donations of Rs 11,000/ each, under this scheme, which works out to Rs 6,82000/-.

The world is moving at a very fast pace due to rapid development of technology which is easily available to all. One has to excel to find a suitable job placement. We have therefore to motivate our children to do very well academically. Pratibhashalee Mohyal Vidyarthee Samman function to honour and encourage brilliant students, was held on 21 Oct 2018 for students of class X and class XII scoring 85 percent and above marks. 53 Students were honoured ie 27 students of class XII (boys 7, girls 20) and 26 students of class X (boys 12, girls 14). 15 students (boys 5, girls 10) of class XII scored over 90 percent marks and 13 students (boys 8, girls 5) of class X scored 10 CGPA. A declamation contest is

also held during the awards function, to encourage students in public speaking.

It has been our constant endeavour to involve the youth in the Community affairs. A youth interaction pgme was organized at Mohyal Foundation on 23 Sep 2018 which was well attended. Local Sabha's have been organizing cricket matches and sports activity involving the youth and have also been honouring their meritorious students. A Youth Camp is planned to be held after the exams of our children.



We are committed to help the needy widows and the underprivileged members of the community. Financial assistance of Rs 1000/ pm has been given to 461 widows and 96 underprivileged persons. Financial assistance which was earlier being sent through money order, is now being sent directly to the bank accounts of most of the individuals since June 2017. All beneficiaries have been requested to forward their bank details where they wish to receive the financial aid sent by GMS. We are committed to help young widows stand on their feet by financially supporting them to acquire skills/ professional training to become financially independent. Financial assistance for medical treatment, is also being given on, need to need basis.

In order to encourage and facilitate marriages within the community, quarterly matrimonial get togethers are held at Mohyal Foundation on last Sunday of each quarter. Particulars of boys and girls for matrimonial alliance are being published in the Mohyal Mitter every month.

Presidents and Secretaries meet of local affiliated Sabhas was held on 16 Dec 2018, where we had a healthy interaction with the focus on how to take the community forward. Local Sabhas are encouraged to hold Mohyal Milans in their areas and are given a Shagun of Rs 21000. The aim is to promote brotherhood by giving an opportunity to members to interact with each other. Sabhas are requested to observe austerity and avoid wasteful expenditure on mementos, shawls, flower bouquets etc. Mohyal Diwas and Pratibhashalee Mohyal Vidyarthee Samman was organized by Mohyal Sabha Faridabad on 21 Oct 2018, which was a grand show. Mohyal Population Census was to be completed in 2018. Local Sabha's are requested to kindly expedite action.

Foundation stone of Mohyal Bhawan at Yamuna Nagar was laid on 11 Sep 2016. Construction started on 9 June 2017 and is now planned to be completed by Aug 2019. Members are requested to come forward and donate whole heartedly for this prestigious project of the community— Rs 3 lacs for a room and Rs 51,000/- from local Sabhas. The proposal of adding third floor in A and B blocks of Mohyal Ashram Haridwar is taking shape, and construction will start on completion of Mohyal Bhawan at Yamuna Nagar. Property B 64 Defence Colony Meerut, which was donated to GMS by Major Amar Nath Chhibber, has been renovated and we are looking for suitable tenants.

The Prime Minister appreciated and conveyed his gratitude to us , for donating Rs 2.50 lacs to Prime Ministers National Relief Fund for victims of flash floods in Kerala in Sep 2018.

MERIT was established in 1999 to impart computer education, besides facilitating research in the IT field. It has been accredited to the National Council for Vocational Training for conducting Computer Operator & Programming Assistant course (COPA) since 2008. It is also a Programme Study Centre of IGNOU for conducting their distance education courses in BCA/ MCA/CCITSK/ACISE/PGCGI/ PGDAST programmes. It has also been a testing centre for TOEFL (since 2007) and GRE (since 2013) and has set up two state of art computer labs in 2014, for conducting these tests. It became an IGNOU Exam Centre in 2014 for conducting exams for all the programmes offered by IGNOU. There are around 350 students enrolled in MERIT for various courses . As an incentive, no fees are charged from the Mohyal students admitted to COPA course in MERIT. Those, who get admission in MERIT study Centre for BCA & MCA courses of IGNOU, will be reimbursed 50% of the fees. It has recently launched courses in Journalism and Mass Communication, which will give exposure to students in live telecasting in the media world.

Credibility and financial stability of GMS continues to be high and we have a healthy bank balance and fixed assets in the form of Ashrams / Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri, Mohyal Foundation and Yamuna Nagar. No loans have been taken to create these assets which belong to the Community. We want our Ashrams to be self sustaining so that the funds available can be used more for welfare activities. Portion of phase 1 of Mohyal Foundation has been given on rent wef 16 Jan 2019, which is a major source of our income and is used to fund the welfare projects of the community.

2. Bookings can also be done on telephone and at the counter.
3. Rooms can be booked on twin sharing basis (2 adults and a child below 12 yrs) for a maximum of 3 days. Check in / Check out time is 12 noon.
4. Bookings can be done after payment of 50% of room donation. The amount will be forfeited if booking is not cancelled at least 48 hrs before booking date. The donation can be kept in suspense for two months for future booking if cancellation is done 48 hrs in advance.
5. Bulk booking (more than 3 rooms) can be done only after prior written approval of GMS.
6. Room donors to donate 25% of the standard room rates (Non Mohyal rates).
7. Consumption of tobacco, liquor and non-vegetarian food in the premises of the Ashram is strictly prohibited.
8. Persons in inebriated condition will be denied entry to the Ashrams.

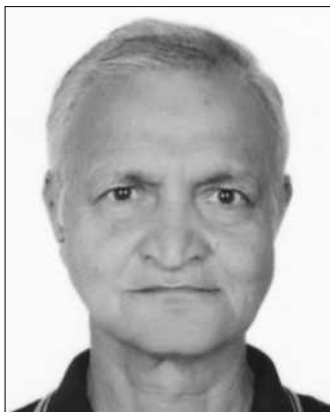

नवरात्रों पर विशेष

इस वर्ष विक्रम सम्वत् 2076 का आरम्भ 6 अप्रैल 2019 से होगा। घट स्थापित करने का शुभ समय सूर्योदय से (6:15) बाद एक घंटा तक या सुबह 7:46 से 9:20 तक कभी भी कर सकते हैं।

नवरात्र वर्ष में दो बार आते हैं। प्रथम चैत्र में द्वितीय अश्विन में। यह शुक्ल पक्ष की प्रतिपदा से शुरू होकर नवमी तक होते हैं। इस प्रकार माँ दुर्गा के नौ रूपों की नौ दिनों तक पूजा होती है। नौ दिनों तक नवदुर्गा की पूजा होने के कारण इसे नवरात्र कहते हैं। स्नानादि से शुद्ध होकर मण्डप में दुर्गाजी की मूर्ति स्थापित करें। दायीं ओर कलश की स्थापना करें, कलश के सामने मिट्टी और रेत मिलाकर जौ बोएँ। मण्डप के पूर्वी छोर पर दीपक स्थापित करें। प्रथम गणेश जी की पूजा व फिर शेष देवी-देवताओं का पूजन करें। दुर्गा सप्तशती का पाठ लाभकारी होता है।

कुमारी पूजन

आठ या नौ दिनों तक पूजा के बाद कुमारी कन्याओं को खिलाना चाहिए। संख्या में दो से नौ तक तथा आयु 1-10 वर्ष तक होनी चाहिए। पूजन व कुमारी भोजन के पश्चात् सिर पर अक्षत छुड़वाएँ व उन्हें दक्षिणा दें। इस प्रकार माँ भगवती प्रसन्न होती हैं और मनोरथ पूर्ण करती हैं।

माँ शैलपुत्री

प्रथम पर्वतराज हिमालय की पुत्री पार्वती के रूप में हैं। ये समस्त वन्य जीव-जन्तुओं की रक्षक हैं।

माँ ब्रह्मचारिणी

द्वितीय ब्रह्मचारिणी माँ की समस्त विद्याओं का ज्ञाता माना जाता है। इनकी अराधना से अनन्त फल की प्राप्ति होती है। पूर्व जन्म में यह पार्वती रूप में थी।

माँ चन्द्रघण्टा

तृतीय माँ चन्द्रघण्टा मस्तक पर घण्टे के आकार का चन्द्रमा धारण करती हैं। माँ चिरायु, आरोग्य, सुख व सम्पन्नता का वरदान देती है।

माँ कुष्माण्डा

चतुर्थ देवी भक्तों की रोग, शोक व विनाश से मुक्त करके आयु, यश, बल व बुद्धि प्रदान करती हैं। जीवनी शक्ति भी देती हैं।

माँ स्कन्दमाता

भगवान् स्कन्द की माता होने के कारण यह पंचम रूप स्कन्दमाता कहलाता है। माता की गोद में उन्हीं का सूक्ष्म रूप छः सिर वाली देवी का है अतः इनकी पूजा में छः मूर्तियाँ सजानी चाहिए।

माँ कात्यायनी

षष्ठ रूप देवताओं व ऋषियों के कार्यों को सिद्ध करने के लिए महर्षि कात्यायन के आश्रम में प्रकट हुई थी उनकी पुत्री होने के कारण इन्हें माँ कात्यायनी कहते हैं। यह दानवों व पापियों का नाश करने वाली माँ है।

माँ कालरात्रि

सातवाँ रूप देखने में भयावह अवश्य है किन्तु शुभफल देने वाला है। इन्हें शुभकारी भी कहते हैं। शत्रु व दुष्टों का संहार करती हैं।

माँ महागौरी

अष्टम माँ उत्पात्ती के समय आठ वर्षों की थी इसी कारण इनकी पूजा आठवें दिन की जाती है। यह अन्नपूर्णा के समान है इसलिए आठवें दिन कन्या पूजन का विधान है।

माँ सिद्धिदात्री

नौवीं माँ सिद्धिदात्री हैं। यह सभी सिद्धियों की दाती हैं। इनकी पूजा से सभी मनोकामना पूर्ण होते हैं।

अप्रैल 2019 नवरात्र

5 अप्रैल को चैत्र अमावस है। इस दिन पूर्वजों की पूजा की जाती है। संवत्सर की पहली अमावस्या होने के कारण इसका बहुत महत्व है। पितरों की शांति के लिए तर्पण करें। 6 अप्रैल से चैत्र नवरात्र आरंभ होंगे। चैत्र माह के शुक्ल पक्ष की प्रतिपक्ष से नवमी तक चैत्र नवरात्र मनाए जाते हैं। इनमें माँ दुर्गा के नौ रूपों का पूजन होता है। नवरात्र 6 अप्रैल से 14 अप्रैल तक हैं। रामायण के अनुसार भगवान राम ने इस महीने देवी दुर्गा की उपासना करके रावण का वध किया था। 6 अप्रैल माता शैलपुत्री, 7 अप्रैल—माता ब्रह्मचारिणी, 8 अप्रैल—माता चंद्रघंटा, 9 अप्रैल—माता कूस्मांडा, 10 अप्रैल—माता स्कंदमाता, 11 अप्रैल—माता कात्यायनी, 12 अप्रैल—माता कालरात्रि, 13 अप्रैल—माता महागौरी, 14 अप्रैल—माता सिद्धिदात्री की पूजा की जाती है।

नवरात्रि के पहले तीन दिनों को ऊर्जा माँ दुर्गा को समर्पित है। अगले तीन दिन धन की देवी माँ लक्ष्मी और अंतिम तीन दिन ज्ञान की देवी माता सरस्वती को समर्पित हैं। नवरात्र के पहले दिन घट स्थापना करें। प्रतिदिन देसी घी का दीपक जलाएँ। कुछ लोग जौ की बुवाई करते हैं। नौ दिन के भोग—

पहला दिन—केला, दूसरा दिन—देसी घी से बने पकवान, तीसरा दिन—नमकीन मक्खन, चौथा दिन—मिश्री, पाँचावाँ दिन—खीर या दूध, छठा दिन—मालपुआ, सातवाँ दिन—शहद, आठवाँ दिन—गुड़ या नारियल, नौवाँ दिन—धान का हलवा।

नौ दिनों तक दुर्गा सप्तशती का पाठ करें। कन्या—पूजन करें। उन्हें फूल, इलायची, पान, फल सुपारी, मिठाई, श्रृंगार सामग्री, कपड़े घर का भोजन—हलवा, काले चने, पूरी कराएँ। ललिता सहस्रनाम में देवी के एक हजार नामों का जप करें।

13 अप्रैल—रामनवमी, 15 अप्रैल—कामदा एकादशी, 19 अप्रैल हनुमान जयंती, पूर्णिमा।

बैसाखी 14 अप्रैल को मनाई जाएगी। पद्म पुराण में इस दिन स्नान का महत्व बताया गया है। सूर्य के मेष राशि में प्रवेश पर यह त्योहार मनाया जाता है। यह गेहूँ के पकने पर मनाया जाता है। इस दिन नव वर्ष को मनाते हैं।

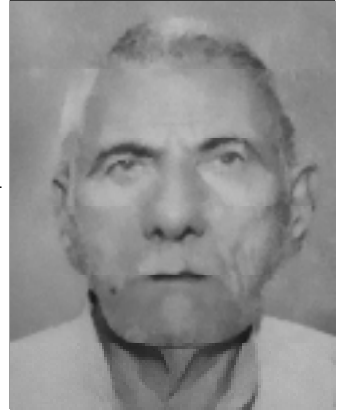
