

#### OPEN FORUM

**(a) Pratibhashalee Mohyal Vidyarthee Samman** Pratibhashalee Mohyal Vidyarthee Samman for the Academic Year 2020 and 2021, was scheduled to be held at Ambala on 13 Feb 2022. In view of the spread of Coronavirus and highly contagious Omicron, the House decided to postpone conduct of this event. #### RESOLUTION PROPOSED, PASSED AND ADOPTED IN THE MANAGING COMMITTEE MEETING OF GENERAL MOHYAL SABHA (REGD) ON 9 JAN 2022.

##### RESOLUTION

The Meeting of the Managing Committee of the General Mohyal Sabha (Regd.) held on 9 Jan 2022 resolves that as adumbrated in the GMS constitution, the Sabha is committed to rendering all possible aid to deserving widows, the destitute, the aged, the sick, deserving students, to establish centers of learning, ashrams and homes for the disabled and the aged and also extending aid during calamities, charitable dispensaries and that after meeting the aforesaid obligations the surplus funds of Rs. 39,59,296/- derived by it by way of donations, rents or income from investments etc shall be utilized for building (i) of the Mohyal Foundation Complex (ii) Ashrams (iii) Schools (iv) Charitable dispensaries (v) homes for the aged and other capital projects within the next five years (up to 31.03.2026). The amount rendered surplus as such shall be deposited in the Scheduled Banks in accordance with Section 11(2) of the Income Tax Act 1961.

The meeting ended with a vote of thanks to the Chair, and recitation of Shanti Path. The next monthly meeting of GMS Managing Committee, will also be held in virtual format, on 13 Feb 2022.

#### OLD WAYS DON'T OPEN NEW DOORS

Empowering its women and making them self-reliant ought to be the vision of every ideal society. General Mohyal Sabha, not being an exception has been persistently working to make the females of our community self sufficient ever since the establishment of the organization at Lahore in the year 1891.

Initially, our ancestors contributed an amount of Rs.5 to the widows for their livelihood which was considered a decent amount for the survival of a family back then. Post-Independence, situations changed drastically over time, but the noble deeds continued. Under the able presidentship of Mohyal Ratna Rzd. B.D. Bali Ji, the pensions were reinstated and currently nearly 500 Mohyal ladies are availing the benefit of the Widow Pension scheme.

On August 30<sup>th</sup>, the results of the GMS elections were announced and Shri Vinod Dutt Ji became the President of our apex body, unopposed. An industrialist par-excellence, a philanthropist, a visionary leader and the most humble person got the reins in his control. He felt that at present, any amount given as help would not be sufficient for a comfortable and secure life. According to him the growth of ladies is attainable only if they become financially and socially stable. To achieve this the following points can be implemented:

- GMS may provide support to ladies for the accomplishment of their educational or vocational training.
- The ladies must be encouraged to get suitable jobs to make them self-sufficient and independent.
- They can be encouraged and supported both monetarily and socially to become entrepreneurs. The Local Sabhas and distinguished Mohyals of the area can use their contacts and play a vital role in this.
- The matrimonial cell can help them find a suitable match and settle down.

Lastly, for the ladies, be independent on your own terms, achieve it by your own rules, and build a life you are proud to live, while GMS remains pledged to strengthen the females and stand by them to the best of its capacity.

My Dear Brothers and Sisters,



Covid 19 pandemic struck the world in Dec 2019, which has been a harrowing experience for mankind. We were also adversely affected due to this deadly virus. Nationwide lockdown was announced wef 22 March 2020, initially for 21 days, to check the spread of the novel corona virus. Days ran into weeks and weeks into months. It resulted in problems like unemployment, fear of contracting corona virus, lack of social contact, inability to travel and lifestyle changes. Life literally came to a standstill and it has been the most humbling time of our lives. We have realized that our earthly possessions are of no use and have learnt the dignity of labour. Hand wash, social distancing and wearing a mask is a must now. 'Dekh tere sansar ki halat kya hogi Bhagwan, kitna badal gaya Insaan'.

As a precautionary measure against the spread of coronavirus, our Institutions had to be closed and were managed with minimum staff. The needy mohyal families were helped by the local Sabhas by providing rations etc and two of our Philanthropists, Shri Vinod Kumar Dutt and Shri P K Dutta went out of their way, to help the needy in all possible ways.

Education is very essential to make progress and to take the Community forward. GMS is committed to ensure that no Mohyal child is deprived of education for want of funds. Our Schools at Dehradun and Haridwar are running smoothly. Classes are being conducted mostly online. Major K R Bali Mohyal Public School at Dehradun, started in 2007, upto class 8, has 190/ 250 students. It has recently started running in two shifts, Sr classes (5<sup>th</sup> to 8<sup>th</sup>) from 0900 hrs to 1130 hrs and Jr classes (Nursery to 4<sup>th</sup>) from 1130 hrs to 1430 hrs. Dr Avdesh Mehta Dutt, grandson of late Major K R Bali and late Smt Kaushal Bali (donors of this property) and his mother Smt Shanta Mehta, are here with us today. Mohyal Public School at Haridwar, started in 2012, upto class 5 has 73 students. Classes are held online from 0930 hrs to 1230 hrs. The activities of the School are regularly being printed in Mohyal Mitter. Financial help is being given for education to 62 needy students ie Rs 250/- pm to Rs 3000/- pm, depending on the class in which the child is studying. The financial aid is sent twice a year ie from Apr to Sep and from Oct to Mar.

The world is moving at a very fast pace, due to rapid development of technology, which is easily available to all. Children have to face tough competition, initially to get admission in colleges of their choice and later for suitable job placements. Our children have therefore to be motivated to excel academically, in sports, as well as in cultural activities. Pratibhashalee Mohyal Vidyarthee Samman function



is organized by GMS every year, where students scoring 85% and above marks, are honoured. A declamation contest is also held during the awards function, to encourage the students in public speaking. Unfortunately, due to the Covid pandemic, we could not hold the function last year. Pratibhashalee Mohyal Vidyarthee Samman, for the academic year 2020 and 2021, will now be held at Ambala, kind courtesy MS Ambala City, on 13 Feb 2022. It has been heartening to see our youth, being actively involved in all the activities of their respective Sabhas. However, the planned sports activities could not be held due to the pandemic. We plan to organize sports events for the youth now, since that is a good platform to encourage interaction between the local Sabhas.

GMS is committed to help the needy widows and the underprivileged members of the community. Financial assistance of Rs 1000/- pm has been given to 430 widows and 89 underprivileged persons. Financial assistance is being sent directly to the bank accounts of the individuals. The unfortunate young widows, will be helped to stand on their feet, by supporting them to acquire skills / professional training to become financially independent. Financial assistance for medical treatment, is also being given to the needy mohyals on, need to need basis.

Particulars of boys and girls for matrimonial alliance are being regularly published in the Mohyal Mitter, in order to encourage and facilitate marriages within the community, which has given us good results. With the efforts of the parents and matrimonial websites, finding mohyal spouses for their children has been possible and is praise worthy. An upgraded Mohyal Matrimonial website will soon be launched by the GMS.

Presidents and Secretaries meet of local affiliated Sabhas, was held at Chandigarh on 3 Oct 2021 kind courtesy MS Chandigarh. It is a matter of great honour for the Community, that Lt Gen B K N Chhibber, PVSM, AVSM, VSM (Retd), former Governor of Punjab and Administrator of Chandigarh attended the meeting. Local Sabhas are encouraged to hold Mohyal Milans in their areas and are

given a Shagun of Rs 21000/, from GMS. The aim is to promote brotherhood by giving an opportunity to the Biradri to interact with each other. MS Chandigarh organized Mohyal Milan at Chandigarh Club on 3<sup>rd</sup> October, where Shri Vinod Kumar Dutt, President GMS, was the Chief Guest. It was a grand function, where you could see Mohyalist in full swing. Effort put in by Shri Judge Bali, President MS Chandigarh, and his entire team are greatly appreciated.

A small function – foundation stone laying, for the construction of third floor on A and B blocks of Mohyal Ashram Haridwar, was held on 20 Oct 2021, and was blessed by Shri Vinod Kumar Dutt, President GMS and many mohyals. The foundation stone was laid by Smt Nita Bali, wife of late, Mohyal Ratna Rzd B D Bali. Construction work on this prestigious project of the Community will be started soon. Maintenance/ Renovation work at Mohyal Ashram Haridwar is in progress, and the work at Mohyal Ashram Vrindavan is scheduled to start shortly. On an appeal made by Shri Vinod Dutt, President GMS, donations have been received in cash and in kind — Rs One lac each from Shri Vinod Dutt and MS Ashok Vihar, Rs Fifty thousand each from MS Ambala City, MS Meerut, MS Yamuna Paar, Rs 5100/ from Shri Rakesh Kumar Bali, Sec MS Jaipur. Shri Rit Mohan, President MS Panipat & Secretary Public Relations, organized donation of Linen items for our Ashrams at Haridwar and Vrindavan. Shri Pritam Vaid, Cultural Secretary MS Ashok Vihar, has offered to donate one functional Generator Set each for our Ashrams at Haridwar and Vrindavan and has also committed to maintain them. In addition, he will sponsor pension for 5 widows of GMS every year. Shri Ramesh Bali from Mumbai, has offered to donate Air Conditioners for Mohyal Ashram Vrindavan.

Local Sabhas, kept in touch with their members through phone, online and where required by physically meeting the needy families. MS Jalandhar laid the foundation stone of their Bhawan on 11 March 2020 and MS Mehrauli laid the foundation stone of their Bhawan on 5 Aug 2020. Construction of the Bhawan at Jalandhar has been completed and construction of the Bhawan at Mehrauli is near completion.

MERIT was established at Delhi in Oct 1999 by GMS. It has been accredited to the National Council for Vocational Training for conducting Computer Operator & Programming Assistant course (COPA) since 2008. It is also a Programme Study Centre of IGNOU for conducting their distance education courses in BCA/MCA/IT Skill etc and a testing centre for Test of English as a foreign language (TOEFL since 2007) and Graduate Record Examination (GRE since 2013). It became an IGNOU Exam Centre in 2014 for conducting exams for all the programmes offered by IGNOU. As an incentive, no fees are charged from Mohyal students admitted to COPA course in MERIT. Mohyal students, who get admission in MERIT study Centre for BCA & MCA courses of IGNOU, are reimbursed 50% of the fees.

Credibility and financial stability of GMS continues to be high and we have fixed assets in the form of Ashrams/

Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri, Mohyal Foundation and Yamuna Nagar. It is a matter of great pride, that no loans have been taken to create these assets, which has been done through donations by the Community. We plan to make our Ashrams and Institutions to be self sustaining so that the available funds can be used, more for welfare activities. Portion of phase 1 of Mohyal Foundation has been given on rent for Rs Ten lacs per month, less 10% given to DDA, wef 16 Jan 2019, which is a major source of our income and is used to fund the welfare projects of the community. Property, B 64 Defence Colony Meerut, donated to GMS by late Major Amar Nath Chhibber, has been given on rent for Rs 17,000/ pm.

GMS Managing Committee Elections were announced on 13 Dec 2020. The Election process was completed on 30 Aug 2021, with the declaration of results by GMS Election Committee, headed by Shri K K Bali and his team. Shri Vinod Kumar Dutt, was declared elected unopposed, as President of GMS, unanimously, in a meeting of the newly elected members on 5 Sep 2021. Names of the Office Bearers of GMS, were announced by Shri Vinod Kumar Dutt, after approval of the GMS Election Committee, in the Managing Committee Meeting held on 14 Nov 2021.

It is now Our responsibility, to maintain our assets and to carry out charity work started by late Rzd B D Bali and his team, and work together in the best interests of the Community, as we have been doing so far.



# ANNUAL GENERAL BODY MEETING 19 DECEMBER 2021

## Report by the Secretary Finance GMS

### Accounts and Budget Proposals

GMS was founded at Lahore on 24 May 1891 by our illustrious forefathers amongst them was late Shri Ganesh Dutt, grand-father of Shri Vinod Kumar Dutt, President GMS and it has completed 130 years of its glorious existence and service to the community and humanity. It is a proud moment for all present in this august meeting. Thereafter, Shri Ashok Chhibber presented the audited accounts i.e. Income and Expenditure Statement and Balance Sheet for the Financial Year 2019-20 ended on 31.03.2020 and Financial Year 2020-21, ended on 31.03.2021, copies of which were sent to all the members along with the notice of meeting sent by speed post on 17.11.2021. Budget proposals for the Financial Year 2021-22 were circulated to all the members present in the meeting in advance.



Shri Ashok Chhibber stated that GMS is registered under the Indian Societies Act, 1860, and under Section 12AA of Income Tax Act, 1961 as “charitable” institution. Accordingly, regular books of accounts are being maintained as per the requirements of the legal provisions of the above noted two Acts and were audited by the Chartered Accountants M/s. H.S. Ahuja & Company who after thorough examination and scrutiny have certified as follows (though not sent alongwith agenda notice to keep low volume of agenda notice):

“We have examined the balance sheet of GENERAL MOHYAL SABHA (REGD) AAATG5350R [name and PAN of the trust or institution] as at 31.03.2020 and 31.03.2021 and the Income and Expenditure account for the year ended on that date which are in agreement with the books of account maintained by the said trust or institution.

We have obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of the audit. In our opinion, proper books of account have been kept by the head office and the branches of the above-named trust visited by us so far as appears from our examination of the books, and proper Returns adequate for the purposes of audit have been received from branches not visited by us subject to the comments given below.

In our opinion and to the best of our information, and according to explanations given to us, the said accounts give a true and fair view:-

- In case of the balance sheet of the state of affairs of the above-named trust as at 31.03.2020 and 31.03.2021.
- In the case of the Income and Expenditure account, of the Income and Expenditure of its accounting year ending on 31.03.2020 and 31.03.2021.

Explaining the salient features of the accounts, he submitted that main source of income is from rent which during the year 2019-2020 was Rs. 1,12,94,250/- and in the year 2020-21 it was Rs 1,31,88,000/- as against NIL income from this source in the preceding years 2019. It was because the part of the Mohyal Foundation building remained vacant for lack of suitable tenant in the preceding two years. It could be let out only from 16<sup>th</sup> January 2019 to 31<sup>st</sup> March 2019 i.e. for a period of two and half months at monthly rent of Rs. 10 Lakhs. Now the building is duly rented out. Income from general donations was Rs.1,33,57,377/- in the year 2019-20 and Rs 46,92,461/- in the year 2020-2021. This downward trend was due to Covid-19 pandemic. Income from bank deposits also decreased was Rs. 64,90,887/- (in the year 2019-20) to Rs 49,68,832/- (in the year 2020-21) mainly on account of lowering of fixed deposit rates by the banks. The corpus fund of the trusts stood at Rs 9,44,58,236/- as on 31.03.2020 and during the year 2020-21 it is shown as Rs 9,34,33,814/- and Rs 85,85,000/- as corpus fund against Goverdhan Bhawan. Similarly subscription and membership fee also declined Rs 4,42,300/- to 1,37,840/ mainly due to Covid-19. Number of trusts is as follows:

During the aforesaid years income from tuition fees also declined from Rs 71,34,613/- to Rs 28,54,932/-. Contribution from Indira Gandhi Open University also declined from Rs.24,98,037/- to Rs 3,14,525/-. Others receipts income also decreased Rs 5,51,151/- to Rs 2130/-. The downward trend has been due to Covid-19.

After giving analysis of the main sources of income, Shri Ashok Chhibber analyzed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs. 51,51,550/- to 478 widows in the year 2019-20 and Rs 49,58,500/- to 430 in the year 2020-21. Relief and welfare to Needy and Destitutes was to the tune of Rs.10,38,700/ in the year 2019-20 to 93 beneficiaries and Rs 19,02,000/- in the year 2020-21 to 89 beneficiaries. Relief and welfare by way of free Langar at the Ashrams was to the tune of Rs. 37,82,776/-in the year 2019-20 and Rs 12, 23,139/- in the year 2020-21. Financial aid for education was to the tune of Rs. 7,20,225/- in the year 2019-20 to 76 beneficiaries and Rs 7,21,500/- in the year 2020-21 to 62 beneficiaries. Expenditure on staff welfare stood at Rs. 1,92,326/- in the year 2019-20 and Rs 1,12,368/- in the year 2020-21. Further an amount of Rs. 1,22,92,402/- was spent on account of establishment in the year 2019-20 and Rs 67,31,795/-in the year 2020-21. A sum of Rs. 1,04,224/- was spent on Building Repair and Maintenance in the year 2019-20 and Rs 5,68,653/-in the year 2020-21 and Rs. 7,89,672/- was spent on property tax in the year 2019-20 and Rs 7,42,347/- in the year 2020-21. A sum of Rs. 2,18,574/- was spent on insurance of buildings in the year 2019-20 and Rs 2,63,566/- in the year 2020-21. A sum of Rs. 8,32,500/- was spent towards lease and ground rent of Mohyal Foundation building in the year 2019-20 and Rs 9,82,500/- in the year 2020-21.

Coming to the budget proposals, Shri Ashok Chhibber submitted that a sum of Rs.51,05,617/- has been earmarked for widows welfare; Rs.13,98,050/- has been earmarked for relief fund. A sum of Rs.42,23,587/- for MERIT; a sum of Rs. 48,67,504/- for Ashram Fund at Haridwar; a sum of Rs. 28,06,845/- for Vrindavan Ashram; provisions of Rs. 1,95,863/- Yamuna Nagar Community Hall Fund. Similarly adequate funds have been provided under different heads in the detailed budget. The budget estimates for the Financial Year 2021-22 show a surplus of Rs. 52,21,180/- (Receipts Rs. 5,19,71,180/- expenditure Rs. 4,67,50,000/-).

In conclusion he reiterated that the accounts of the GMS are being maintained most meticulously both in traditional form by Double Entry Book Keeping as well as through computer and every paisa of money received and expenses incurred have been duly accounted for as per the statutory provisions and under the guidance of expert chartered accountants. He called upon the members to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. Only interest on trust money is used for activities of the GMS keeping the capital intact. He further added that these Trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of Trusts and the Trust Money reflects the confidence of the Community in the working and credibility of the GMS under the visionary, dedicated and devoted leadership of our late illustrious President Mohyal Ratna Rzd B.D. Bali.

He further added that Trusts are being augmented and money added every day by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposits and only interest accrued thereon is utilized for the purpose for which the Trust is created. He exhorted the Audience to be proud of the legacy of our illustrious and farsighted forefathers and count on their blessings and put concerted efforts to carry on the rich legacy for further generations to come.

The resolution was proposed by Shri Ramesh Datta and seconded by Shri Nand Lal Vaid and the House approved it unanimously.

#### **RESOLUTION – II**

Resolved, that audited Balance Sheet and Income & Expenditure statement for the Financial Years 2019-2020 and 2020-2021 are hereby approved and adopted.

The resolution was proposed by Shri Rakesh Kumar Bali and seconded by Shri Harshbir Mehta (Lau) and the House approved it unanimously.

### RESOLUTION – III

Resolved, that the general body of the General Mohyal Sabha (Regd.), in its meeting held on 19 December 2021, at Mohyal Foundation, New Delhi, appreciates and approves the report for the period 2019 – 2021, submitted by the Secretary General of the Sabha.

The resolution was proposed by Shri Raj Kumar Bakshi (Chhibber) and seconded by Shri Vijant Bali and the House approved it unanimously.

### RESOLUTION – IV

Resolved, that M/s. H.S. 

■ **Shri Servejit Bali**, former President, Mohyal Sabha







Lohri was overwhelmingly celebrated by Mohyals staying in Hiranandani Gardens joined by other residents. The festival was celebrated by lighting





## COMMERCIAL AWARENESS A MUST HAVE SKILL FOR YOUNG LAWYERS

This is important because a law firm is itself a business at its core. Firms also need to retain clients and generate revenue. As an employee, you need to be able to add value to the business of the law firm in this way. Being commercially aware demonstrates that graduates, who may not have loads of industry experience, are ready and able to work in a business environment. Thus, firms look for these traits in candidates so that they know they are hiring someone right for the role.

To show that you would be a good lawyer and an asset to the firm, you need to be able to show that you are capable of thinking commercially and able to provide advice that will keep clients coming back for more.

He was a preacher of Arya Samaj and Vedic Dharma and a Historian also. Revolutionaries like Sardar Bhagat Singh, Sukhdev, Pandit Ram Prasad Bismil, derived inspiration from Bhai Ji. He was disciple of Swami Dayanand Saraswati. Bhai Ji was born on 4 November 1876 in the lineage of Bhai Mati Dass at village Kariala in Pakistan. Due to his revolutionary activities, the British Govt awarded him death sentence. There was big opposition to this in the country as a result the British Govt converted it to life imprisonment at Kala Pani where he was tortured a lot. Due to efforts of Mahatma Gandhi he was pardoned and during last years of his life Bhai Ji settled at Jalandhar where he breathed his last on 8<sup>th</sup> of December 1947.

Shri G.K. Bali, Sr Vice President of the Sabha, while offering tributes at the occasion said that it was a sheer coincidence that General Bipin Rawat, his wife Madhulika Rawat and eleven other army men of his team were martyred in a Helicopter crash in Nilgiri Hills, Coonoor Tamil Nadu on 8 Dec. Shri Rawat originally from Dehradun, joined army as Second Lieutenant. He became Brigadier in 2007 and rose to the rank of Army Chief in 2017. The post Chief of Defence Staff was planned by the Indian Govt some 20 years back but it came into being only in the tenure of the present Modi Govt. Shri Rawat being senior most of all the three Defence chiefs was designated as Chief of Defence Staff in 2019. The purpose of this post was a better coordination between the three Defence Arms namely Army, Air Force and Navy. Credit of modernisation of forces and surgical strikes like Balakot goes to General Rawat. Departure of General Rawat was a big loss to the

Nation as countries like China and Pakistan and certain enemies of nation within the country were afraid of General Rawat. On their martyrdom the entire Nation was in tears and specially on the day after this mishap the city of Coonoor was totally shut down as a mark of respect to the departed souls. On the day of cremation of Smt & Shri Rawat, two strong Veer Vadhus, Smt Lidder the wife of late Defence Advisor to the CDS and Smt Harjinder Kaur wife of one of the late Group Captains, displayed their strength by attending the cremation ceremony of Smt & Shri Rawat, despite their own big loss. Daughters of Shri Rawat performed their last rites. Big gesture that Smt Kaur resolved to act as their mother.

Shri G.K. Bali requested all the Managing Committee members to stand up at their seats to observe two minutes silence for the peace of departed souls. The members prayed that God may take all the departed souls straight into his Arena and give courage to the bereaved families and the Nation as well to bear this irreparable loss.



## **Shri Ashok Narain Chhibber** **(24 Mar 1950 – 1 Dec 2021)**





Ekansh Devgan & Akansha Devgan. The family donated to several religious organizations and Rs 1100/- to GMS, in his fond memory.


## **Rzd Jaswant Rai Bali** **(03 Aug 1947 – 16 Nov 2021)**



Smt Jasbir Chhibber, wife of Shri Om Parkash Chhibber, who was born on 1 Sep 1947 left for her heavenly abode







## MOHYAL ASHRAMS HARIDWAR AND VRINDAVAN

1. Rooms can be booked by Yatri's, 30 days in advance, which can be done online, on telephone and also at the counter, in the respective Ashrams.
2. Rooms can be booked on twin sharing basis (2 adults and a child below 12 yrs) for a maximum of 3 days. Check in / Check out time is 12 noon.
3. Room bookings will be confirmed, only after payment of 50% of room donation. The amount will be forfeited if booking is not cancelled at least 48 hrs before booking date. The donation can be kept in suspense for two months for future booking, if cancellation is done 48 hrs in advance.
4. Bulk booking (more than 3 rooms) can be done only after prior written approval of GMS.
5. Room donors can donate 25% of the standard room rates (non mohyal rates) or pay the prevalent room donation as per their discretion.
6. Donations can be made only in Indian currency. Booking of rooms for foreign nationals (does not include NRI), can only be done after written approval of GMS.
7. Consumption of tobacco, liquor and non-vegetarian food in the premises of the Ashrams is strictly prohibited.
8. Persons in inebriated condition will be denied entry to the Ashrams.
9. There is no room service — meals have to be taken in the Dinning Hall of the Ashram.
10. Pets (Animals) are NOT allowed in the premises of the Ashram.
11. Yatri's are requested to bring alongwith them their photo identity — same is required for each occupant, of each room.
12. Yatri's are requested not to keep the mortal remains (Asthis) of their near and dear ones in their rooms in the Ashram. In order to avoid inconvenience to guests coming from long distances, four lockers have been installed at Mohyal Ashram Haridwar.
13. Online booking facility for rooms in Sewa Sadan, Haridwar is not available. Rooms can be booked for one month, extendable by 15 days depending on availability of accommodation.
14. Yatri's are responsible for safe custody of their belongings.
15. All payments to the Food Contractor will be made only through coupons issued by the Manager of the Ashram.
16. Facility of free langar (all meals), is available only to yatri's staying in the Ashram.
17. Premises of the Ashrams are meant only for boarding / lodging of the Yatri's and NO other activity is permitted.
18. In case of any inconvenience, Yatri's are requested to speak to the Manager of the Ashram / Office bearer of GMS. Yatri's are requested to fill the feedback form before their departure.
19. Yatri's are requested to help in keeping the rooms and the premises of the Ashram clean. Yatri's are also requested to maintain decorum, while dealing with the staff posted at the Ashrams.
20. Yatri's are requested to follow Covid 19 guidelines, and to also carry with them Vaccination Certificate indicating they have taken both doses of the vaccination.

## झिड़ी देवस्थान-बावा जितो और बुआ कौड़ी का मंदिर

जम्मू ऋषियों, मुनियों, पीरों—फकीरों की धरती है। इसी पावन धरा पर विभिन्न स्थानों पर देवी—देवता, लोक देवताओं की याद में मेले लगते हैं जो आस्था का नयी परिभाषा देते हैं। जम्मू से 15—20 कि. मी. की दूरी पर झिड़ी है जहाँ लोकदेवता बावा जितमल और बुआ कौड़ी (गौरी) का कार्तिक पूर्णिमा पर तीन दिन तक भक्तों की आस्था का सैलाब परवान पर होता है।

इनकी कथा का आरंभ गुरु मछेंन्द्रनाथ जो ब्रह्मा जी के वीर्य जो मछली ने गटक लिया था के उदर से उत्पन्न हुए। वे माता हिंगलाज और शिव के भक्त थे। इनके परम शिष्य गुरु गोरखनाथ जी हुए। इन्हें हरिनारायण का अवतार माना जाता है। इन्होंने ने ही गोरखनाथ पंथ आरंभ किया। यह राजा मंडलिक के मंत्रियों के सलाहकार भी रहे। इसके बाद श्री कालीवीर का जिक्र आता है। इन्हें शेषनाथ का अवतार माना जाता है। जम्मू में कुलदेवता को बावा भी कहा जाता है। जम्मू कटुआ, डोडा, राजौरी आदि जिलों में श्री कालीवीर जी के मंदिर हैं। इसी क्रम में 1478 संवत कार्तिक महीना कृष्ण पक्ष की अष्टमी तिथि में वृश्चिक लग्न व पुष्य नक्षत्र के दिन अगार गाँव के रूपो ब्राह्मण व सत्यवती पत्नी के घर जितमल का जन्म हुआ। यह बालक चंचल, बुद्धिमान और धार्मिक प्रवृत्ति का था। गाँव वाले उसे मुनि कहते थे। वे अगार से रोज माता वैष्णवों देवी के मंदिर में माथा टेकने जाते थे। इन्होंने चौबीस साल कठोर तप किया। तब माता वैष्णवों ने उन्हें वरदान दिया कि वो उनके घर में जन्म लेंगी और पाँच वर्षों तक साथ रहेंगी। संवत 1507 में बुआ कौड़ी (गौरी) का जन्म हुआ। पुत्री जन्म के समय पत्नी माया देवी का निधन हो गया। कुछ साल गौरी बीमार रही। उसकी चाची जॉजा भी उन्हें विभिन्न तरीके से परेशान करती थी। दुखी होकर जितमल गाँव कानाचक्क के इलाके में पिंजौर क्षेत्र में अपने दोस्त रूलो लोहार के पास गए। रूलो लोहार ने जागीरदार बीर सिंह मेहता के साथ बात करके जितमल के लिए किसानों के लिए जमीन चाही। बीर सिंह राजा अजायबदेव का धूर्त वजीर था। उसने बावा जितमल को बंजर जमीन इस शर्त पर दी कि जितो जागीरदार को अपनी खेती की पैदावर का एक चौथाई हिस्सा देगा। बावा जितो धर्मपरायण और नेकदिल इंसान था। माता वैष्णवों का नाम लेकर बीज बोये और कड़ी कर खेत की देखभाल की। अच्छी फसल देखकर जागीरदार का मन बेईमान हो गया। उसने आधी फसल की माँग की। लेकिन वचन और कर्म के सच्चे जितमल ने इंकार किया। जिस कारण जागीरदार ने करिंदों को संपूर्ण अनाज उठाने का आदेश दिया। बावा ने जागीरदार को समझाया कि पाप कमाई फलती नहीं है पर घमंडी बीर सिंह बाहुबल से गरीब ब्राह्मण किसान को नीचा दिखाना चाहता था। दोनों के बीच वाक्युद्ध हुआ और करिंदों ने बावा जितो को चोटिल कर दिया। इससे जितमल ने बीर सिंह को रूखी कनक ले जाने नहीं देगा कह कर कनक के ढेर पर बैठ कर अपने सीने में कटार घोंप दी। बावा जितमल ने अन्याय के खिलाफ अपनी जान कुर्बान कर दी। ऐसा कहते हैं कि उसी समय भयानक तूफान व वर्षा हुई। जिससे वह अनाज बिखर गया और सारी कनक खेत, नालों, नदियों में बावा के खून से रची हुई कई स्थानों पर पहुँची। जिस—जिस ने भी उस कनक के दाने से उगे गेंहू खाया, उस परिवार के लोग आज भी बावा जितो के स्थान पर माथा टेकने आते हैं। उनकी बेटी बुआ

दाती ने पिता की चिता को अग्नि दी और खुद भी उसमें भरम हो गयी। यह घटना संवत 1515 की है। तब से ही जितमल बावा जितो और सती बुआ दाती कहलाने लगे। हर साल कार्तिक पूर्णिमा को शहीद अर्चना होती है। यहाँ पूर्वजों की याद में समाधियाँ भी बनी हुई हैं। इस क्षेत्र को बावेदा झाड़ भी कहते हैं लोकदेवता बावा जितो पुण्यात्मा का जीवन चरित्र जम्मू के इतिहासकारों ने भी लिखा है। बुआ बावे दी अर्चना पूजा की विशेष विधि है। यहाँ बावा जितों के भक्त जो गुरु पद पा लेते थे। उनके अपने चेले और डेरे होते थे। झिड़ी में तीन दिन का विशेष पूजन होता है। चौदही पूनम अर्थात् पूर्णिमा के एक दिन पूर्व डेरों के गुरु और चेले दोपहर बाद झिड़ी मंदिर के पास के बाग में इकट्ठा होकर सबसे पहले गुरु डोगरी पौशाक (सफेद रंग) की पहनते हैं। सिर पर सफेद पगड़ी हाथ में लोहे का झूंडा लेते थे। उसके बाद चेले भी पौशाक पहन कर ढोल नगाड़ो के साथ कारकें (बावा जितों) के जीवन चरित्र और चमत्कारों को एक विशेष विधि से गाते हुए कुँएँ पर पहुँचते हैं। वहाँ पर पूजन कर फिर चौकी होती है। दूसरे दिन प्रातःकाल पुनः गुरु, चेले, भक्तगण कारकें गाते हुए तालाब पर जाते हैं। इस तालाब का विशेष महत्व है। यहाँ स्नान करने से मानसिक और शारिरिक व्याधियाँ दूर होती हैं। इसकी तलहटी में जो काली मिट्टी है उसे शक्कर कहा जाता है। यह अनगिनत गुणों से युक्त है। यहाँ स्नान पूजन के बाद डेरे पर खिचड़ी का लंगर लगता है। सबसे पहले कन्यापूजन फिर पंडितों को भोजन और अंत में आमजन प्रसाद ग्रहण करते हैं। संध्या के समय पूरी झिड़ी और मंदिर परिसर मोमबती और दीपकों की लौ से जगमगा उठता है।


