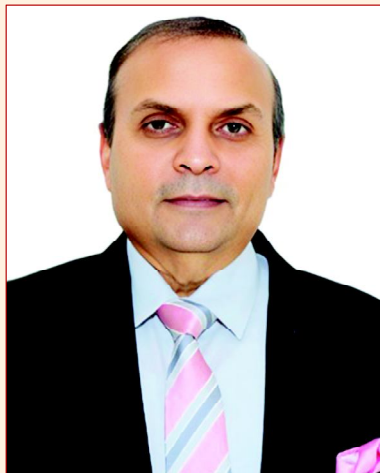

8. In December 2025, over 60 students appeared for TOEFL/GRE tests at MERIT.

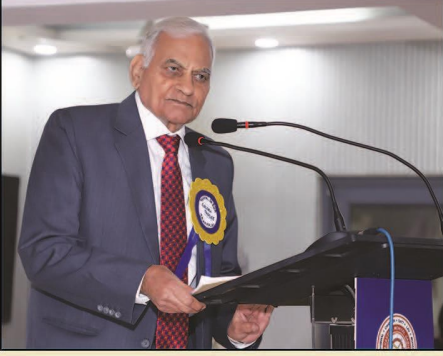

Gurdial Singh Bali who is an entrepreneur and deals in the manufacturing of soap, phenyl,



and floor cleaning liquid and consented to impart all necessary technics and know-how to the budding or interested members free of cost.

The last date for submission of names of interested candidates is 15th January 2026. The date for the Skill Development Workshop shall be notified after 15th January 2026, and we hope the participants will definitely be benefitted out of this programme. This will also help the desirable and interested Baradari persons to start their earnings.

**3. Mohyal Mela 2025 Accounts:** The income and expenditure statement of Mohyal Mela 2025 has been approved. Under the guidance of the Chartered Accountant, the accounts have been properly classified as per extant accounting standards.

**4. Building Fund Account:** A separate bank account titled "J&K Mohyal Sabha (Building Fund)" has been opened at J&K Bank, Medical College Branch. The account details and QR code for contributions will be circulated on all social media platforms. The funds collected shall be exclusively utilized for the development of Mandir and the building.

**5. Installation of Sapt Rishi Idols:** The Biradari has wholeheartedly supported the proposal to install the idols of Sapt Rishis, from whom the respective clans and lineage the Biradari originates.

**6. Balance Sheet FY 2024-25:** The EC meeting for the month could not be held as members were engaged in finalizing the Balance Sheet for FY 2024-25 with the Chartered Accountant. An amount of approximately Rs 1.29 lakh, shown as TDS recoverable but never recovered from the Income Tax Department, has been written off. Income Tax return has been filed inter-alia applying for the refund of approximately Rs 18893. The CA has also been requested to explore the possibility of claiming TDS refund of earlier years under provisions of Income Tax laws and any amount extracted/ refunded will be the benefit for the Sabha.

The President also apprised the house about the LED TV donated to the Sabha by the General Secretary, Shri M. M. Bakshi. House thanked and applauded Mr. Bakshi for this benevolent gesture.

**General Secretary's Report:** The President then requested the General Secretary to brief the house about activities carried out during December 2025.

After exchanging New Year greetings and pleasantries the general secretary opened the session expressing the hope that continued support of the Biradari in the New Year 2026 would register another remarkable year of accomplishments for the Sabha.

**Key points highlighted:** There is a strong demand from the Biradari for the installation of Sapt Rishi idols in the Mandir premises. This will not only provide

consultations accessible to the baradari youth/ students but can also generate income for the Sabha.

House was also informed that discussions with Dr. Susheel (HOD, Cardiology) organize a Medical Camp for the baradari, offering free medical advice, medicines, and heart-related tests. This was a dream project of our Senior Vice President Late Shri Rajinder Vaid, which will be given practical shape as per pledge taken by the Sabha while paying last respect to the departed soul.

The Sabha is also exploring other community-beneficial programmes, with support from Shri Vikas Dutta, who runs a professional training institute for prospective jobseekers within the community.

It was assured that the Balance Sheet for FY 2024-25 will be shared with the Biradari during the current month through social media platforms as and when signed copy received from the auditor.

**Financial Statement:** The Joint Treasurer, Shri Vijay Bakshi Chhibber, presented the income and expenditure statement for December 2025, which was noted by the house.

**Vote of Thanks:** The President thanked Mr. Ashok C. Vaid for his kind gesture of sponsoring and treating the gathering with sumptuous tea/ snacks and sweets during the meeting.

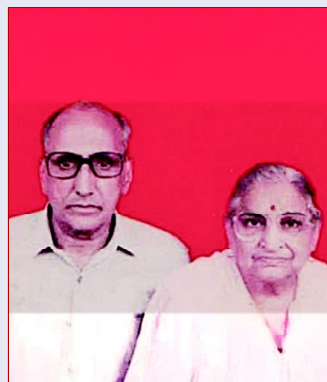

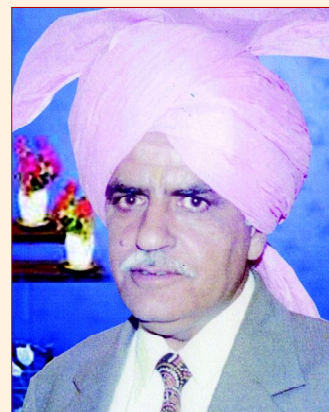
She was a truthful and a creative art and craft teacher

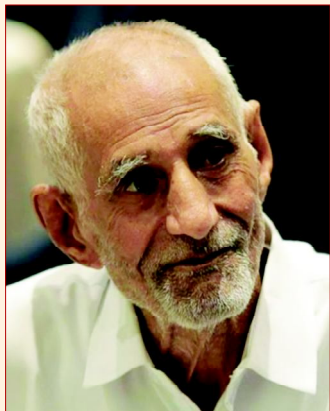

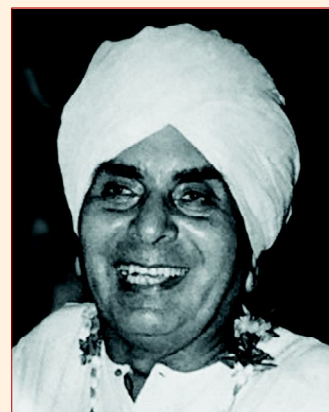

भाई गणपत राय छिब्बर का जन्म वर्ष 1878 में ग्राम करयाला, जिला झेलम (वर्तमान पाकिस्तान) में एक प्रतिष्ठित एवं संपन्न छिब्बर परिवार में हुआ। यह ग्राम सुरला पहाड़ियों की चोटी पर स्थित है तथा चकवाल से लगभग दस किलोमीटर की दूरी पर कटास राज तीर्थ के मार्ग में पड़ता है। ग्राम करयाला की स्थापना सोलहवीं शताब्दी में बाबा प्रागा (1507-1621) द्वारा की गई थी। भारत के विभाजन (1947) तक लगभग 400 वर्षों तक यह ग्राम छिब्बर वंश का प्रमुख निवास-स्थल रहा।

भाई गणपत राय, भाई तेजा सिंह के सुपुत्र तथा भाई राम रख्खा के पौत्र थे। उनके परदादा भाई श्याम दास थे। उनके छोटे भ्राता भाई लखपत राय थे। यह वंश परंपरागत रूप से कर्मठ, स्वाभिमानी तथा सामाजिक उत्तरदायित्वों के प्रति सजग रहा है।

भाई गणपत राय एक समृद्ध जमींदार परिवार से संबंधित थे। उनके पास ग्राम करयाला में घोड़ी पाल मुरब्बे की कृषि भूमि थी। वे अनुशासित जीवनशैली, परिश्रम, सरलता और पारिवारिक मूल्यों के प्रति अपनी दृढ़ निष्ठा के लिए जाने जाते थे। सामाजिक मर्यादाओं का पालन और परंपराओं के प्रति सम्मान उनके व्यक्तित्व की विशेष पहचान थी।

उनके पारिवारिक जीवन में तीन पुत्र एवं दो पुत्रियाँ थीं, जिनके माध्यम से उनका वंश आज भी विविध क्षेत्रों—प्रशासन, रक्षा सेवाएँ, चिकित्सा, शिक्षा एवं समाज सेवा—में प्रतिष्ठित योगदान दे रहा है। उनकी संतानों, पौत्रों एवं प्रपौत्रों ने परिवार की गरिमा और संस्कारों को निरंतर आगे बढ़ाया।

भारत के विभाजन के पश्चात उत्पन्न विषम परिस्थितियों में भाई गणपत राय को अपने पैतृक ग्राम करयाला से विस्थापित होना पड़ा। इस कठिन कालखंड में उन्हें ग्राम तंदवाल, तहसील बराड़ा, जिला अंबाला में कृषि भूमि आवंटित की गई। विस्थापन की पीड़ा के बावजूद उन्होंने अदम्य साहस, धैर्य और कर्मठता के साथ नए जीवन की शुरुआत की तथा पुनः आत्मनिर्भरता स्थापित की।

भाई गणपत राय दीर्घायु रहे और लगभग नब्बे वर्ष की आयु तक पूर्णतः स्वस्थ जीवन व्यतीत किया। उनका देहांत ग्राम

तंदवाल में हुआ। उनका जीवन सत्यनिष्ठा, परिश्रम, पारिवारिक एकता और सामाजिक उत्तरदायित्व का प्रेरक उदाहरण है। वे अपने पीछे एक विशाल, सुसंस्कृत एवं सुव्यवस्थित परिवार छोड़ गए, जो आज भी उनके मूल्यों और आदर्शों से प्रेरणा प्राप्त करता है।

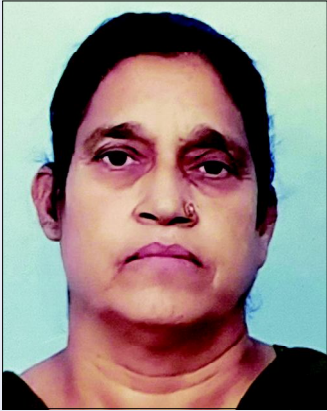
