MERIT


- 1. Result of our COPA students of session 2020-21 was announced on 27th February 2022. All the students who appeared for the exam have passed and we have got 100% result. Hard work of all the faculty members and students of MERIT has made this possible. The outstanding performance of the students under these challenging times is highly appreciable.
- 2. More than 1800 students were allotted by IGNOU to our study center in the MCA, BCA, PGDCA, PGCGI, PGDAST, CIT and CCITSK programmes conducted at MERIT for the academic session July-December 2021. The classes were conducted during November 2021 to January 2022 in online mode. Total of 44 academic counselors (both professors from School of Sciences-IGNOU as well as IGNOU approved academic counselors of MERIT) conducted more than 900 theory and practical sessions during this period.
- 3. TCS ion conducted National Qualifier Test on 23rd February 2022. The online test with free registration fee was attended by many of our staff & students. MERIT had registered 77 students for the same. However due to some technical problem, some of the students & staff could complete the test. For those who could not complete TCS ion is rescheduling the test.
- 4. MERIT is registered as TCS ion learning partner and further steps in this regard are under process.
- 5. MERIT organized industrial visit for the ITI students. Staff & Students of MERIT visited Khanna & Amritsar on 26th 28th February 2022. We thank for the support extended by Sh. Vinod Dutt, President, GMS. Also we would like to mention the help & support extended during the industrial visit by Baba Bhag Singh University for providing very good accommodation, Mr. Ajay Dubey, additional DG Police for arranging VVIP pass for Wagah Border Parade. We were really honored when they announced the names of our director Dr. Rattan K Datta & Ms. Meena Datta during the parade. Dr. Rattan K Datta delivered a lecture on Big Data Analytics to the students of Baba Bhag Singh University.
- After seeing very low registrations for TOEFL/GRE tests in the months of June, July & August 2021 due to COVID, there is a steady increase in the number of tests conducted at our center.
- 7. The CIPS Foundation provides support to the communities across the globe, through procurement and supply best practice. They conduct CIPS exam to qualify for **Procurement and supply.** 16 candidates given test during 14th to 23rd March 2022 at MERIT.

Chaudhary Gurcharan Lal Datta 'JOSH' 'Man with a Mission' (Sept.1928 - Feb.2015)

Born on 4th September, 1928 to Smt Vidyawati Datta and Ch. Manohar Lal Datta, in the village Kanjrur Dattan (now in Pakistan), Chaudhary Gurcharan Lal Datta grew up in a illustrious family where various members held public office. His devotion to serving and uplifting people can be attributed to his family background. He completed his schooling in his native village and continued his scholarly aptitude to S.D. College, Lahore where he hailed as an exemplary student.

During the initial years of his career, he got posted in the Special Post Offices opened to cater to the postal demands of various foreign dignitaries and aristocrats who visited

India. He showed great promise and tact to make sure that the classified mail reached its recipient without any trouble. When the Duke of Edinburgh along with Queen Elizabeth visited India, he was lauded for his efficiency and received a memento for providing efficient postal services to the Royal Couple.



Throughout his career, spanning more than three decades, he proved himself to be a diligent subordinate, efficient administrator, capable administrator and a true leader. He was awarded for his consistent profession excellence with First Meghdoot Sewa Award of Indian Postal Department on 9th October 1985 consisting of scroll of honour and cash prize.

Ch. G.L. Datta remained President of Malviya Nagar RWA for 35 years. Being an early settler, educated and well versed with the functioning of Government agencies, people used to approach him for help and guidance. He would listen to their problems, guide them for the right action and helped them to approach the relevant department. He was so well connected with the masses and because of the dedication and hard work, he was admired by the local MPs, MLAS,, Councilors and Principals of Government and Public Schools. He was called upon to voice his opinion on the development projects by the Administrators and Politicians too. Post retirement, Ch. G.L. Datta approached the P&T department and had another sub Post Office established at H-1/12 to facilitate the services to the neighborhood far away from the main Post Office

In 1960, Shri Datta began his journey with General Mohyal Sabha, a tryst that would last more than five decades. He worked tirelessly and selflessly because he felt so strongly for the betterment of the community. Through decades of unwavering devotion, he nurtured the GMS and brought it to the dizzying heights that it is at today. During a span of 50 years, he had received much love and good wishes from the entire Mohyal community without any ill-will, wrath or snub from any quarter. He left no stone unturned in the service of the community and earned kudos from his colleagues and leaders of the community.

Noted Historian Rzd P.N. Bali who compiled the History of Mohyals'

Contains the following words of appreciation:

"Ch. G.L. Datta 'Josh' was a man of all seasons associated with General Mohyal Sabha for decades, he was the volunteer leader ready to take up any assignments. His daughter late Uma Datta travelled the same path, made name, left a memory. She was the first editor of Mohyal Mitter Hindi section (1982-87) rejuvenated and mothered it for 6 years."

The Area Councillor and political leadership paid homage and remembered his outstanding contribution for planning, coordination and rendering support for the implementation of community/infrastructure projects. Ch. G.L. Datta Marg will inspire not only the present generation but also the future generations too for dedicating themselves for social upliftment.

The function was conducted by his daughter, Smt Prabha Mehta Vaid by remembering his father's note-worthy contribution to GMS and area development in Malviya Nagar, New Delhi. She concluded and paid her emotional tribute to her father in the following few lines:

MOHYAL ASHRAMS HARIDWAR AND VRINDAVAN

- Rooms can be booked by Yatris, 30 days in advance, which can be done online, on telephone and also at the counter, in the respective Ashrams.
- Rooms can be booked on twin sharing basis (2 adults and a child below 12 yrs) for a maximum of 3 days. Check in / Check out time is 12 noon.
- Room bookings will be confirmed, only after payment of 50% of room donation. The amount will be forfeited if booking is not cancelled at least 48 hrs before booking date. The donation can be kept in suspense for two months for future booking, if cancellation is done 48 hrs in advance.
- Bulk booking (more than 3 rooms) can be done only after prior written approval of GMS.
- Room donors can donate 25% of the standard room rates (non mohyal rates) or pay the prevalent room donation as per their discretion.
- Donations can be made only in Indian currency. Booking of rooms for foreign nationals (does not include NRI), can only be done after written approval of GMS.
- Consumption of tobacco, liquor and non-vegetarian food in the premises of the Ashrams is strictly prohibited. Persons in inebriated condition will be denied entry to the Ashrams.
- 8. Yatri's coming for Asthivisajaranwill be given one room on complementary basis, and complementary langar for all members who return back same day after Asthivisajaran.
- There is no room service meals have to be taken in the Dinning Hall of the Ashram.
- Pets (Animals) are NOT allowed in the premises of the Ashram.
- 11. Yatri's are requested to bring alongwith them their photo identity same is required for each occupant, of each room.
