


It is with great grief and sorrow, we learnt about the sad demise of, Shri Joginder Pal Mehta (Lau), President MS Ambala City and Member of GMS Managing Committee, who left for his heavenly abode on 8 March 2025. As per his wishes, the family handed over his body, to PGI Chandigarh on 8 March 2025, which was done by his son, Shri Sandeep Mehta, grandson Ankur Dutta, grand-daughter Mehak Vaid, son-in-law Shri Rajeev Vaid, Shri Vijay Mehta Chhibber and Shri Subhash Chhibber, member of GMS Managing Committee. Shradhanjali Sabha and Rasam Pagri, was held at Aggarwal Bhawan, Sector-9, Ambala City at 2 pm on 17 March 2025, which was attended by a large number of members of mohyal community, family friends, relatives and all those who had come in contact with Shri J.P. Mehta, who had assembled to pay their tributes to a staunch mohyal, very good human being and a great "Son of the Soil", who was totally dedicated towards the welfare of the Community, and prayed to God Almighty to grant him Eternal peace / Moksha. Condolence messages were received from most of the Local affiliated Sabhas and other organizations with which he was associated.

Shri J.P. Mehta, son of late Shri Vaishno Das Mehta and late Smt Sita Wanti Mehta, was born on 11 May 1944 at village Chhoranwala, Gujrat. He married Smt Neelam Mehta (Lau), daughter of late Shri Madan Gopal Chhibber and late Smt Yashoda Datta, Distt Jhelum on 9 March 1969. He leaves behind a well settled family with high moral values, son, Shri Sandeep Mehta – Smt Ritu Mehta, daughters, Smt Sangeeta Dutta – Shri Bhupinder Dutta and Smt Rajni Vaid – Shri Rajeev Vaid and grandchildren - Deeksha Dutta, Muskaan Vaid, Ankur Dutta, Mehak Vaid, Serena Mehta, Rishabh Mehta, Manya Mehta and Rishabh Vaid.

Shri J.P. Mehta, served in the Indian Air Force from 12 Sep 1961 to 30 Sep 1982. After retirement, he served as District Manager of Haryana Women Development Corporation of Social Welfare Department of Haryana, from 2 Nov 1982 to 31 May 2002. He was appointed as Administrator by Haryana Government for six registered Societies, dealing with education and Residents Welfare Association. He was President of Mohyal Sabha Ambala City since 26 April 1992. He had served as Secretary GMS from 2004 to 2010 and was at present Member of GMS Managing Committee. Through his efforts and goodwill enjoyed by him, place for Mohyal Bhawan Ambala City was donated to the Sabha, by Smt Shakuntla Devi Vaid, 95 yrs (popularly known as 'Matajee'), wife of late Sub Mehta Lal Chand Vaid, who bequeathed her house to MS Ambala City. Sewa of Matajee was an obsession with Shri J.P. Mehta and his team, who treated her house as a place of pilgrimage and were always concerned about her welfare. Matajee left for her heavenly abode on 12 May 2002. Shri J.P. Mehta and his dedicated team went on a war footing and constructed Mohyal Bhawan Ambala City, within a year.

Shri J.P. Mehta, was socially very active, who made a tremendous contribution towards all activities of GMS, for more than three decades. He was honoured by GMS with the Lifetime Achievement Award during 125th GMS, held on 12 March 2017, and with 'Pride of Mohyals Award' at Ambala City on 17 April 2022, for his selfless contribution and dedicated services to the Community.

Shri Vinod Kumar Dutt, President GMS and Mohyal Ratna Shri P.K. Dutta, Sr Vice President GMS, and members of GMS Managing Committee, convey their heartfelt condolences to the bereaved family, and pray to God Almighty, to grant eternal peace to the departed noble soul, and to give strength to the family members, to bear with this tragic loss.

It chokes drains and pollutes water bodies like rivers, canals, ponds and even seas due to which water animals die. Dairy animals like cow eat such littered plastic, get choked and many times die. It pollutes the atmosphere. It takes 200 to 300 years for the plastic to get finally disposed. Microplastic is also a cause of cancer in humans. The outcome of discussion was that for eradicating single use plastic, we should start using paper carry bags, jute bags, glass or metallic utensils.

Shri G K Bali stressed that our Mahila Shakti could play a pivotal role for spreading awareness in this matter. All the members assured to take steps in this direction. Both President and General Secretary appreciated the endeavor of Shri G K Bali.





श्री नरेंद्र मेहता छिब्बर ने बताया कि मुगल सम्राट औरंगज़ेब के शासनकाल में हिंदुओं पर घोर अत्याचार एवं अमानवीय व्यवहार हो रहा था। जो इस्लाम कबूल न करता उसे यातनाएं देकर मृत्युदंड दिया जाता था। इस बात से गुरु तेगबहादुर बहुत दुखी थे। एक बार कश्मीरी पंडितों का जत्था पंडित कृपाराम दत्त के साथ आया और बताया कि कश्मीर में उन पर जुल्म हो रहे हैं। इस्लाम स्वीकार न करने पर यातनाएं दी जा रही हैं। इसलिए गुरु तेगबहादुर की मदद चाहिए। भाई मितदास ने सारा विवरण गुरु तेगबहादुर को सुनाया। गुरु तेगबहादुर ने कहा, जाओ औरंगज़ेब को संदेश दो कि पहले गुरुजी को इस्लाम कबूल कराओ तो सभी इस्लाम स्वीकार कर लेंगे। औरंगजेब को जब यह मालुम पड़ा तो आग बबूला हो गया। गुरु तेगबहादुर और भाई मितदास अनेक समर्थकों के साथ औरंगजेब से बदला लेने के लिए दिल्ली रवाना हो गए। परन्तु मुगल सम्राट की विशाल सेना ने गुरु तेगबहादुर, भाई मितदास उनके छोटे भाई सितदास और दयाला को बंदी बना लिया। औरंगज़ेब के काजी ने दो शर्ते रखी या तो इस्लाम स्वीकार कर लो अन्यथा मृत्यु को अंगीकार कर ले। गुरु तेगबहादुर और भाई मितदास ने पहली शर्त मानने से इन्कार कर दिया। औरंगज़ेब ने गुरु जी में भय उत्पन्न करने के लिए भाई मितदास को आरे से चीरने का आदेश दिया और इस्लाम कबूल करने के अनेक प्रलोभन दिए परन्तु मितदास अपने फैसले पर अडिग रहे।

9 नवंबर 1675 को दिल्ली के चाँदनी चौक में भाई मितदास को लकड़ी के दो पाटों के बीच बांध कर जल्लाद क्रूरता से आरे से चीरता रहा जबिक मितदास सुखमनी साहब का वाचन करते रहे, 10 नवंबर को भाई सतीदास को गर्म तेल में डाला गया तथा 11 नवंबर को भाई दयाला को रूई में लपेट कर जलाया गया। फिर भी गुरु तेगबहादुर विचलित नहीं हुए। फलस्वरूप गुरु तेगबहादुर का सर कलम कर दिया गया। आज वही स्थान शीशगंज गुरुद्वारा है। तथा वहीं भाई मितदास का चाँदनी चौक में स्मारक भी है। इसी वंश के क्रांतिकारी शहीद भाई बाल मुकंद, भाई परमानंद है जो देश और धर्म के लिए समर्पित हो गए।


