PROCEEDINGS OF ANNUAL GENERAL BODY MEETING HELD IN AUDITORIUM AT A-2 QUTAB INSTITUTIONAL AREA NEW DELHI, ON SUNDAY 17 NOVEMBER 2024

The Programme started at 0900 hrs on 17 Nov 2024, wherein members signed their attendance on arrival at the venue. Refreshments were served to the members, who interacted with each other and exchanged pleasantries. Members were requested to assemble for the Flag hoisting, which was done at Mohyal Foundation. Lt Col L R Vaid (Retd), Secretary General GMS, extended a warm welcome to members and then read out his report, giving details of the activities of the GMS since the last AGM, which was held at Mohyal Foundation on 19 Nov 2023, details of which have been published in Mohyal Mitter, Nov 2023 Issue. The present report is printed, in this Issue of Mohyal Mitter. Chartered Accountant Jaswant Singh, from M/S H S Ahuja & Co New Delhi, was invited to give his report. He said that, they have audited and prepared the Balance Sheet of GMS and that all Government Compliances are being followed, and if there were any questions, he will be glad to answer. There were no questions from members. Shri Ashok Chhibber, Secretary Finance GMS, presented the audited accounts of GMS for the Financial Year 2023 to 2024, and the Budget Proposals for the financial year 2024 to 2025. After this, he put five resolutions to vote, which were passed unanimously. The Report is printed in this Issue of Mohyal Mitter.

Shri Vinod Kumar Dutt, President GMS, extended a warm welcome to members, and said if any member has any question to ask, he will be glad to answer the same, but there were no questions from the members. He said that, he and his colleagues were working selflessly, to uplift the community, specially the underprivileged members of the community and plan to make them financially independent in a time frame of ten years. We plan to empower young widows to become financially self sufficient by encouraging them to enhance their skills, by joining skill training programmes of their choice, and ensuring that no Mohyal child is deprived of education due to lack of funds. He also shared the financial viability of our properties

- (a) B-64 Defence Colony Meerut there is no income, and we are spending money on its repair and maintenance. We propose to sell this property and buy a property at a hill station (Kangra in Himachal Pradesh etc) and name it Major Amar Nath Chhibber and Smt Nirmala Chhibber Bhawan. Property will only be considered for sale, after identifying suitable alternate site. The same was approved by the House.
- (b) Mohyal Bhawan Inderpuri there is no income, and we are running in a loss. We propose to open a primary school / accommodation for long time stay for working women / students in this complex. The same was approved by the House.
- (c) Mohyal Bhawan Goverdhan It is under renovation and we hope to complete it shortly, after which we will review its usage. The same was approved by the House.

Shri Vinod Kumar Dutt, President GMS, then, put forward, four minor Constitutional Amendment Resolutions to vote, which were also passed unanimously.

RESOLUTION - I

Resolved, that the general body of the General Mohyal Sabha, at its meeting held on 17th November 2024, at A-2, Qutab Institutional Area, New Delhi, approves to discontinue Annual Membership with voting rights.

The resolution was proposed by Shri P.L. Mehta (Lau) and seconded by Smt Neelima Datta Mehta and the House approved it unanimously.


ANNUAL GENERAL BODY MEETING – 2024 HELD IN AUDITORIUM AT A-2, QUTAB INSTITUTIONAL AREA, NEW DELHI ON 17 NOVEMBER 2024 REPORT BY SECRETARY GENERAL GMS

My Dear Brothers and Sisters, JAI MOHYAL

It gives me great pleasure to welcome each one of you, some of you having travelled long distances to be part of this prestigious event. We look forward to having a healthy interaction as a family, to finding workable solutions for the welfare, progress and prosperity of our closely knit community. We need to reach out to the underprivileged members of our community, and help them in every possible way.

I will now update you on the events, which have taken place, since the last AGM, which was held at Mohyal Foundation, New Delhi on 19 Nov 2023, details of which have been published in our monthly magazine, Mohyal Mitter, Nov 2023 Issue.

Business Session will include, Report by the Secretary General, Presentation of Accounts by Secretary Finance, Points from members and Resolutions to be adopted. After



completing the AGM proceedings, we will have the Awards Function, wherein we will honour, Shri P.K. Dutta, Sr Vice President, with the highest award of the Community, "Mohyal Ratna", for his tremendous contribution in uplifting the Mohyal Community, and also honour some members of our Community and local affiliated Sabhas.

Education is very important to make progress and to take the Community forward. GMS is committed to ensure that, no mohyal child is deprived of education, for want of funds. I am pleased to inform you, that our schools at Dehradun and Haridwar are running smoothly. Major KR Bali Mohyal School at Dehradun started in 2007 is upto class 8th and has 319 students. It is functioning under the guidance of our Managing Committee Member, Shri Pramod Mehta (Vaid), President MS Dehradun. Mohyal Public School at Haridwar started in 2012, is upto class 5th has 140 students. It is functioning under the guidance of our Managing Committee Member, Chartered Accountant Shri Girish Mohan. The activities of the schools, are regularly being printed in our monthly magazine, Mohyal Mitter. Financial aid is being given to 69 needy students ie Rs 250/- pm (Class KG) to Rs 3000/- pm (Professional / Post Graduation), depending on the class in which the child is studying. The financial aid is sent directly to the Banks of beneficiaries, twice a year ie Apr to Sep and Oct to March.

It is a very competitive world, due to rapid development of technology which is easily available to all. We have therefore to motivate our children to excel in their studies, so that they can get admissions in the college of their choice. Pratibhashalee Mohyal Vidyarthee Samman was held at Mohyal Foundation, New Delhi on 15 Sep 2024, where students scoring 80% and above marks in Class X and Class XII Board Exams were honoured. There were a total of 55 students, 28 from Class XII (boys 10, girls 18) and 27 from Class X (boys 16, girls 11). 14 students from Class XII (boys 6, girls 8) and 11 students from Class X (boys 6, girls 5) scored 90% and above marks.

Our youth are actively involved in all the activities of their Sabhas and GMS events, which is a very healthy sign. Mohyal Youth Camp was organized by MS Dehradun on 26-27 May 2023, which included adventure activity (Shivpuri river rafting). Youth (age group of 15 to 30 yrs), took the initiative to organize a trip to Haridwar and Rishikesh from 5-7 July 2024, which is greatly appreciated.

GMS is committed to help the needy widows and the underprivileged members of our community. Financial assistance of Rs 1500/- pm has been given to 538 widows and 111 underprivileged persons in this financial year. Financial aid is sent directly to the banks of beneficiaries, once a quarter.

Mohyal Match Making get-togethers are being held regularly. The last get-together was held at Mohyal Foundation on 10 Feb 2024, which was very well attended and a grand success. The next Mohyal Match Making Get-Together is scheduled to be held at Mohyal Foundation on 7 Dec 2024. Particulars of boys and girls, for matrimonial alliance are

being regularly published, in our monthly magazine Mohyal Mitter, in order to encourage and facilitate marriages within the Community.

Local Sabhas are encouraged to hold Mohyal Milans in their areas and are given a Shagun of Rs 21,000/-. Aim is to promote brotherhood, and is an important platform for interaction to further bind the Community together. Mohyal Parivar Milan was organized by MS Hoshiarpur on 7 Jan 2024 and by MS Karnal on 27 Oct 2024.

Presidents and Secretaries Meet is an important event for interaction, with the focus on how to take the community forward. The last Presidents and Secretaries meet was held at Mohyal Foundation on 10 March 2024.

Inauguration of Newly constructed Third floor at Mohyal Ashram Haridwar and unveiling Bust of Mohyal Ratna Rzd B D Bali was done on 11 Aug 2024. It was a matter of great honour for the Community to host, Smt Nita Bali Ji, wife of Mohyal Ratna, late Rzd B D Bali Ji, who inaugurated the newly constructed Third floor of the Ashram. The function was conducted smoothly despite the inclement weather. The function was a grand success, which was very well attended and everyone was in a festive mood. Mohyaliat was clearly visible.

MERIT was established at Delhi in Oct 1999 by GMS, to impart computer education, with emphasis on Information technology. MERIT is committed to advancing IT education across various age groups, and focuses on equipping students with essential skills in Information Technology, contributing significantly to the knowledge revolution. In an era, where information drives development, MERIT empowers individuals with tools to harness IT's transformative power for both professional and societal growth. Since its inception, MERIT has developed a range of initiatives in IT education, training, and research, details of which are being regularly printed in our monthly magazine Mohyal Mitter.

GMS has created fixed assets over a period of time, in the form of Ashrams/Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri, Mohyal Foundation and Yamuna Nagar. I am pleased to inform you, that it is a matter of great pride for all of us, that no loans have been taken to create these assets, which has been done through donations received from our very large hearted Community.

Portion of phase 1 of Mohyal Foundation has been given on rent for Rs Eleven lacs per month, less 10% given to DDA, wef 16 Jan 2019, which is a major and regular source of our income and is used to supplement, the welfare projects of the community. Property, B-64 Defence Colony Meerut, donated to GMS by late Major Amar Nath Chhibber, has been given on rent for Rs 19,000/- per month. This property is being looked after by our Managing Committee Member, Col S.K. Vaid, President Mohyal Sabha Meerut, for which we are grateful to him.

Our Community has made tremendous progress, only because of our unity and contributions made by all of us, over a long period of time. I wish to put on record, our appreciation to the selfless services, put in by our predecessors and creating monuments like Ashrams / Bhawans/ Mohyal Foundation. All this has been possible due to our revered leader, great visionary, late Mohyal Ratna Rzd B D Bali Ji, former President GMS for more than four decades. Let us resolve to continue, to follow his footprints and the roadmap set by him.

ANNUAL GENERAL BODY MEETING - 2024 HELD IN AUDITORIUM AT A-2, QUTAB INSTITUTIONAL AREA, NEW DELHI ON 17 NOVEMBER 2024

Report by the Secretary Finance GMS Accounts and Budget Proposals


GMS was founded at Lahore on 24 May 1891 by our illustrious forefathers, amongst them was late Shri Ganesh Dutt,

grand-father of Shri Vinod Kumar Dutt, President GMS and it has completed 133 years of its glorious existence and service to the community and humanity. It is a proud moment for all present in this august meeting. Thereafter, Shri Ashok Chhibber presented the audited accounts i.e. Income and Expenditure Statement and Balance Sheet for the Financial Year 2023-24, ended on 31.03.2024, copies of which were sent to all the members along with the notice of meeting and Budget proposals for the Financial Year 2024-25 sent by speed post on 16 Oct 2024.

Shri Ashok Chhibber stated that GMS is registered under the Indian Societies Act, 1860, and under Section 12AA of Income Tax Act, 1961 as "charitable" institution. Accordingly, regular books of accounts are being maintained as per the requirements of the legal provisions of the above noted two Acts and were audited by the Chartered Accountants M/s. H.S. Ahuja & Company who after thorough examination and scrutiny have certified as follows (though not sent alongwith agenda notice to keep low volume of agenda notice):

"We have examined the balance sheet of GENERAL MOHYAL SABHA (REGD) AAATG5350R [name and PAN of the trust or institution] as at 31.03.2024 and the Income and Expenditure

account for the year ended on that date which are in agreement with the books of account maintained by the said trust or institution.



In our opinion and to the best of our information, and according to explanations given to us, the said accounts give a true and fair view:-

- (a) In case of the balance sheet of the state of affairs of the above-named trust as at 31.03.2024.
- (b) In the case of the Income and Expenditure account, of the Income and Expenditure of its accounting year ending on 31.03.2024.

Explaining the salient features of the accounts, he submitted that main source of income is from rent which during the year 2023-24 was Rs 1,34,08,910/-. Income from general donations was Rs.2,62,11,622.20, in the year 2023-24. Interest income from bank deposits was Rs. 72,58,085/- during the year 2023-24, which was low mainly on account of lowering of fixed deposit rates by the Banks.Similarly, subscription and membership fee was Rs 2,81,400/-. During the aforesaid year, income from tuition fees/grant increased to Rs 1,04,70,960/-. Contribution from Indira Gandhi National Open University (IGNOU) was Rs 46,76,785/-. Affiliation Fee was Rs 64,000/-. The corpus fund of the trusts stood at Rs 9,95,25,279.97, as on 31.03.2024. Number of trusts, as on 31 March 2024, is as follows:

After giving analysis of the main sources of income, Shri Ashok Chhibber analyzed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs. 1,12,05,000/- to 520 widows in the year 2023-24. Financial Relief and welfare to Needy and Destitutes was to the tune of Rs. 26,03,000/- in the year 2023-24 to 112 beneficiaries. Financial aid for education was to the tune of Rs. 8,13,500/- in the year 2023-24 to 66 beneficiaries. Relief and welfare by way of free Langar at the Ashrams was to the tune of Rs. 62,51,425/- in the year 2023-24. Expenditure on staff welfare

stood at Rs. 1,89,079/- in the year 2023-24. Further an amount of Rs. 1,07,56,234/- was spent on account of establishment in the year 2023-24. A sum of Rs. 44,56,876/- was spent on Building Repair and Maintenance in the year 2023-24 and Rs. 8,27,681/- was spent on property tax in the year 2023-24. A sum of Rs. 1,61,109/- was spent on insurance of buildings in the year 2023-24. A sum of Rs. 10,80,000/- was spent towards lease and ground rent of Mohyal Foundation building in the year 2023-24.

Coming to the budget proposals, Shri Ashok Chhibber submitted that a sum of Rs. 99,00,000/-has been earmarked for widows welfare; Rs. 20,00,000/- has been earmarked for relief fund. A sum of Rs.60,00,000/- for MERIT; a sum of Rs. 1,10,00,000/- for Ashram Fund at Haridwar; a sum of Rs. 50,00,000/- for Vrindavan Ashram; provisions of Rs. 12,00,000/ Yamuna Nagar Community Hall Fund. Similarly adequate funds have been provided under different heads in the detailed budget. The budget estimates for the Financial Year 2024-25 shows a surplus of Rs. 1,09,14,206.93 (Receipts Rs. 8,57,14,206.93 and expenditure Rs. 7,48,00,000/-).

In conclusion, he reiterated that the accounts of the GMS are being maintained most meticulously both in traditional form by Double Entry Book Keeping as well as through computer and every paisa of money received and expenses incurred have been duly accounted for as per the statutory provisions and under the guidance of expert chartered accountants. He called upon the members to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. Only interest on trust money is used for activities of the GMS keeping the capital intact. He further added that these Trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of Trusts and the Trust Money reflects the confidence of the Community in the working and credibility of the GMS under the visionary, dedicated and devoted leadership of our late illustrious President Mohyal Ratna Rzd B.D. Bali, which has been continued by Shri Vinod Kumar Dutt, President GMS

He further added that Trusts are being augmented and money added every day by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposits and only interest accrued thereon is utilized for the purpose for which the Trust is created. He exhorted the Audience to be proud of the legacy of our illustrious and farsighted forefathers and count on their blessings and put concerted efforts to carry on the rich legacy for further generations to come.

Order No. 22- DMRRR of 2017 dated 27.03.2017 (read with Govt. 


