## **PROCEEDINGS OF ANNUAL GENERAL BODY MEETING HELD IN AUDITORIUM AT A-2 QUTAB INSTITUTIONAL AREA NEW DELHI, ON SUNDAY 9 NOVEMBER 2025**

Annual General Body Meeting, was held in Auditorium at A-2 Qutab Institutional Area, Building next to Mohyal Foundation, A-9 Qutab Institutional Area, USO Road New Delhi. Members signed their attendance on arrival at the venue. After refreshments they assembled for the Flag hoisting and Mohyal Prayer, which was done at Mohyal Foundation. Shri Vinod Kumar Dutt, President GMS alongwith Mohyal Ratna Shri P K Dutta, Sr Vice President GMS, unfurled the Mohyal Flag, with repeated roars of Jai Mohyal, after which, the members moved to the Auditorium. Since the quorum was not complete at the stipulated time, the meeting was adjourned for 15 minutes. Thereafter, the House reassembled and the meeting recommenced.

Shri Rit Mohan, Stage Secretary, welcomed the members and proceeded to conduct the business of the House. Shri Vinod Kumar Dutt, President GMS, Mohyal Ratna Shri P K Dutta, Sr Vice President GMS and honorable members were escorted to the dais, after Deep Prajwalan, lighting of the traditional lamp. Floral tributes were paid to Bhai Mati Dass, who was born on 13 Jan 1641 and was martyred on 9 Nov 1675, at young age of 34 years.

Bhai Mati Dass was a disciple of Guru Tegh Bahadur and fought against the Mughal rule. He was arrested on charge of sedition in 1675 and was tried in Kotwali Chandni Chowk. He rejected the option to embrace Islam, as a result he was bolted between two planks of wood and brutally bifurcated into twain from top to trunk with a saw on 9 Nov 1675. Bhai Mati Dass started reciting the Sukhmani Sahib and his voice continued to come from the two parts of his body till the prayer was completed. The supreme sacrifice of Bhai Mati Dass is unique and unparalleled in history. We bow our heads in great reverence to our revered ancestor.

The programme started, with the singing of the National Anthem by members standing at their seats, which was followed by homage to our revered members who have left for their heavenly abode. The House stood up and observed two minutes silence as a mark of respect for the departed noble souls and prayed to God Almighty to grant them eternal peace. Mohyal Ratna Shri P K Dutta, Sr Vice President, in his welcome address, extended a warm welcome to the members and appreciated the progress made by the Community. He said that we are here to serve the Community and that Shri Vinod Kumar Dutt, President GMS and his team have done a wonderful job. Future of Mohyaliat is in safe hands. He appealed to the Local Sabhas to form Istri Wings in their Sabhas and to continue to regularly hold their monthly meetings.

Lt Col L R Vaid (Retd), Secretary General GMS, extended a warm welcome to members and then read out his report, giving details of the activities of the GMS since the last AGM, which was held on 17 Nov 2024. The report is printed, in this Issue of Mohyal Mitter. Shri Ashok Chhibber, Secretary Finance GMS, presented the audited accounts of GMS for the Financial Year 2024-2025, and the Budget Proposals for the Financial Year 2025-2026. Chartered Accountant Jaswant Singh, from M/S H S Ahuja & Co New Delhi, was invited to give his report, which he gave in detail and said that, they have audited and prepared the Balance Sheet of GMS and that all Government Compliances are being followed, and if there were still any questions, he will be glad to answer. Members who had forwarded their points by 30 Oct 2025, were invited on the dais to put across their views. After this, Shri Ashok Chhibber, Secretary Finance, put resolutions to vote, which were passed unanimously. The Report is printed in this Issue of Mohyal Mitter.

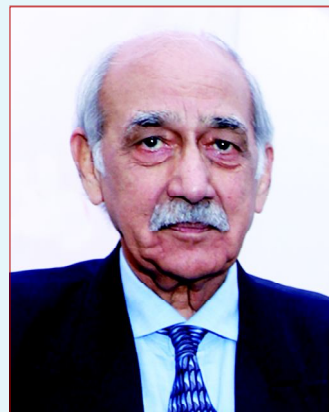

**REPORT BY SECRETARY GENERAL GMS**

My Dear Brothers and Sisters, JAI MOHYAL

It gives me great pleasure to welcome you all for our Annual General Body Meeting 2025, some of you having travelled long distances to be part of this prestigious event. We look forward to having a healthy interaction, to further promote welfare, progress and prosperity of our closely knit Community. Underprivileged members of our community, should continued to be identified, and Needy / Deserving Members, should be helped in every possible way, so that they can live with dignity. The meeting had to be adjourned for 15 minutes, since the quorum was not complete.

I will now update you on the events, which have taken place, since the last AGM, which was held at A-2, Qutab Institutional Area, New Delhi on 17 Nov 2024, details of which have been published in our monthly magazine, Mohyal Mitter, Nov 2024 Issue. We are extremely grateful to Philanthropist, Mohyal Ratna Shri P.K. Dutta, Sr Vice President GMS, who has sponsored the rent for the auditorium, which he did last year also. Medical Relief Fund Account has been opened by GMS, kind courtesy Shri P.K. Dutta, Sr Vice President GMS, to provide medical support to the needy members of the Community, towards which he is contributing Rs 1,78,750/- once a quarter. The Community is requested to contribute whole heartedly towards this fund. Shri Ramesh Datta, President MS Faridabad has now contributed Rs One lac towards this fund. We are extremely grateful to Shri Vinod Kumar Dutt, President GMS, for sending food products made in his own factories to Mohyal Sabhas holding Mohyal Milan and holding Mohyal events.



During the Business Session, we will discuss and decide matters, as already notified in the Agenda, which has been sent to you, and includes Report by the Secretary General, Presentation of Accounts by Secretary Finance, Points from members and Resolutions to be adopted. After completing the AGM proceedings, we will have the Awards function to honour, the local affiliated Mohyal Sabhas, Members of the Community and Winners of Mohyal Talent Hunt - Singing Competition, which is being held for the first time.

Education is of utmost importance to make progress and to take the family and the community forward. We are committed to ensure that, no mohyal child is deprived of education, for lack of funds. I am happy to inform you, that our schools at Dehradun and Haridwar are being run in a professional manner. Major K R Bali Mohyal School Dehradun which was started in 2007 is upto class 8th has 296 students. It is functioning under the guidance of our Managing Committee Member, Shri Pramod Mehta (Vaid), President MS Dehradun. Mohyal Public School Haridwar which was started in 2012, is upto class 5th has 156 students. It is functioning under the guidance of our Managing Committee Member, Chartered Accountant Shri Girish Mohan. The activities of the schools, are regularly being printed in our monthly magazine, Mohyal Mitter. Financial aid is being given to 86 needy students ie Rs 250/- pm (Class KG) to Rs 3000/- pm (Professional / Post Graduation), depending on the class in which the child is studying. The financial aid is sent directly to the Banks of beneficiaries, twice a year ie Apr to Sep and Oct to March, which was sent to 86 students.

We propose to get a plot of land (minimum 5 acres) for construction of an Education Facility for education of our Mohyal children, to include boarding and lodging facilities and Playgrounds.

Due to rapid development of technology, which is easily available to all. the world has become very competitive. We have therefore to motivate our children to excel in their studies and also extra curricular activities (Sports, Art and Culture), so that they can get admissions in the college of their choice and later join professions of their choice. Pratibhashalee Mohyal Vidyarthi Samman which was scheduled to be held at Haridwar 5 Sep 2025 to 7 Sep 2025, had to be postponed due to unprecedented rains in the country. It will now be held at Haridwar from 21 Nov 2025 to 23 Nov 2025, where students scoring 80% and above marks in Class X and Class XII Board Exams will be honoured. 66 (24 Boys and 42 Girls) Applications have been received, out of which 30 Students (10 Boys and 20 Girls) have scored 90% and above marks. This includes 8 students in extra curricular activities.

Mohyal Sabha Yamuna Nagar, organized Youth Cricket Tournament at Yamuna Nagar from 13 June 2025 to 15 June 2025 in which Eight Teams participated, MS Faridabad were the Winners and MS Ludhiana were Runners up. It was a grand youth get together, and it was heartening to see the comradeship among the youth. Gunjan Mohan, son of Shri Vipan Mohan was the Organizing Secretary, who went into the minutest details of the tournament and conducted the event in a professional manner which is praise worthy. Shri Vipan Mohan, President MS Yamuna Nagar and his entire team went out of their way, to make the event memorable and a grand success. Role of Shri Sandeep Bali (Guru Bhai) as a Commentator is commendable. As a follow up, Mohyal Youth Meeting was held at Mohyal Foundation, on 24 Aug 2025, at the initiative of Shri Manu Mehta (Vaid), Secretary Youth & Cultural Affairs, which was very fruitful.



GMS is committed to help the needy widows and the underprivileged members of our community. Financial assistance of Rs 1500/- pm has been given to 577 widows and 114 underprivileged persons in this financial year. Financial aid is sent directly to the banks of beneficiaries, once a quarter.

Mohyal Match Making get-togethers which are very well attended, are being held regularly. They are ably organized by Smt Neelima Datta Mehta whose efforts are praise worthy. Match Making get-togethers were held at Mohyal Foundation on 7 Dec 2024 and on 27 July 2025 at Faridabad kind courtesy MS Faridabad. Particulars of boys and girls, for matrimonial alliance are being regularly published, in our monthly magazine Mohyal Mitter, in order to encourage and facilitate marriages within the Community.

Local Sabhas are encouraged to hold Mohyal Milans in their areas and are given a Shagun of Rs 21,000/-. Aim is to promote brotherhood, and it is an important platform for interaction to further bind the Community together. Mohyal Parivar Milan were organized by MS Prem Nagar Dehradun on 1 Dec 2024, MS Karnal on 27 Oct 2024, MS Dehradun on 20 Apr 2025, MS Mehrauli on 18 May 2025, MS Faridabad on 27 July 2025, and by MS Jammu on 5 Oct 2025. MS Karnal will be holding Mohyal Milan on 30 Nov 2025 and MS Janakpuri will be holding Mohyal Milan on 21 Dec 2025.

Presidents and Secretaries Meeting is an important event for interaction, with the focus on how to take the community forward. Presidents and Secretaries Meeting was held at Mohyal Foundation on 9 Feb 2025. This was followed by Extraordinary General Meeting, which was held at the same venue after completion of Presidents and Secretaries Meeting. The next Presidents and Secretaries Meeting is scheduled to be held at Haridwar on 21 Feb 2026 to 22 Feb 2026. Presidents and Secretaries of affiliated local Sabhas are cordially invited alongwith their spouses to grace the occasion.

Ishta Puja of our Rishis and Ancestors was held at Mohyal Foundation, on 2 Jan 2025. Diwali Puja was held at Mohyal Foundation, on 17 Oct 2025.

MERIT was established at Delhi in Oct 1999 by GMS, to impart computer education, with emphasis on Information technology. MERIT is dedicated to delivering high-quality education in Computer Science and Information Technology, empowering learners across all age groups. In a world shaped by the modern "Knowledge Revolution," MERIT equips students with the skills required to excel in a rapidly evolving digital landscape by fostering IT literacy, innovation, and lifelong learning. Since its inception, MERIT has offered a wide range of IT programs to the community. The institute has successfully trained students under NIELIT's O, A, and B Level courses, as well as the Basic Computer Course. In 2008, MERIT became an NCVT-affiliated Private ITI, offering the COPA trade, and expanded its offerings in 2019 to include the DBSA trade. Demonstrating excellence, MERIT students achieved national recognition by securing the 1st and 2nd positions in the DBSA trade at the National Level in 2024-2025. Continuing its commitment to social responsibility, MERIT also provides free education to Mohyal students. Since 2010, MERIT has been a Programme Study Centre of IGNOU, presently supporting multiple undergraduate and postgraduate programs and guiding more than 5000 learners. MERIT is also a designated IGNOU Exam Centre and a trusted online testing hub for globally recognized assessments such as TOEFL, GRE, and the UK Chartered Accountant examinations. Additionally, MERIT is a member of the Microsoft Imagine Academy, offering industry-aligned technology training.

GMS has created fixed assets over a period of time, in the form of Ashrams / Bhawans at Haridwar, Vrindavan, Goverdhan, Inderpuri, Mohyal Foundation and Yamuna Nagar. I am pleased to inform you, that it is a matter of great pride for all of us, that no loans have been taken to create these assets, which has been done through donations received from our very large hearted Community.

Portion of phase 1 of Mohyal Foundation has been given on rent which is now Rs Twelve lacs Sixty Five Thousand per month, less 10% given to DDA, wef 16 Jan 2019, which is a major and regular source of our income and is used to supplement, the welfare projects of the community. Property, B-64 Defence Colony Meerut, donated to GMS by late Major Amar Nath Chhibber, was given on rent for Rs 27,000/- per month (Rs 20,000/- for ground floor and Rs 7000/- for first floor). This property is being looked after by our Managing Committee Member, Col S.K. Vaid, President Mohyal Sabha Meerut, for which we are grateful to him. Mohyal Bhawan at Goverdhan has been given on rent to ISKCON, Vrindavan for Rs 50,000/- per month wef 7 March 2025. This property and Mohyal Ashram Vrindavan is being looked after by our Managing Committee Member, Shri Kamran Datt, for which we are grateful to him. Mohyal Bhawan Yamuna Nagar is being looked after by our Managing Committee Member, Shri Vipin Mohan, President MS Yamuna Nagar, for which we are grateful to him. Mohyal Bhawan Inderpuri is being looked after by Shri K.G. Mohan, Secretary GMS and President MS West Zone, for which we are grateful to him.

Tremendous progress has been made by our Community, only because of our unity and contributions made by all of us, over a long period of time. I wish to put on record, our appreciation to the selfless services, put in by our predecessors and for creating monuments like Ashrams / Bhawans/ Mohyal Foundation. All this has been possible due to foresight of our revered leader, great visionary, late Mohyal Ratna Rzd B D Bali Ji, former President GMS for more than four decades. The present Managing Committee, working under the guidance of Shri Vinod Kumar Dutt, President GMS and Mohyal Ratna Shri P.K. ### REPORT BY SECRETARY FINANCE GMS

### Accounts and Budget Proposals

GMS was founded at Lahore on 24 May 1891 by our illustrious forefathers, amongst them was late Shri Ganesh Dutt, grand-father of Shri Vinod Kumar Dutt, President GMS and it has completed 134 years of its glorious existence and service to the community and humanity. It is a proud moment for all present in this august meeting. Thereafter, Shri Ashok Chhibber presented the audited accounts i.e. Income and Expenditure Statement and Balance Sheet for the Financial Year 2024-25, ended on 31.03.2025, copies of which were sent to all the members along with the notice of meeting and Budget proposals for the Financial Year 2025-26 sent by speed post on 04 Oct 2025.

He stated that GMS is registered under the Indian Societies Act, 1860, and under Section 12AA of Income Tax Act, 1961 as "charitable" institution. Accordingly, regular books of accounts are being maintained as per the requirements of the legal provisions of the above noted two Acts and were audited by the Chartered Accountants M/s. H.S. Ahuja & Company who after thorough examination and scrutiny have certified as follows.

We have audited the accompanying financial statements of **GENERAL MOHYAL SABHA (REGD.), USO ROAD, JEET SINGH MARG, QUTAB INSTITUTIONAL AREA, NEW DELHI-110067**, (entity), which comprise the Balance Sheet as at March 31, 2025 and the Income & Expenditure Account for the year then ended, and notes to the financial statements, including a summary of the significant accounting policies.

In our opinion and to the best of our information and according to explanations given to us, the said accompanying financial statements of the entity are prepared, in all material respects, in accordance with the Society Registration Act, 1860.

- (a) In case of the Balance sheet, of the state of affairs of the entity as at 31st March, 2025; and
- (b) In the case of the Income and Expenditure Account, of the excess of Expenditure over Income for the year ended on that date.

Explaining the salient features of the accounts, he submitted that main source of income is from rent which during the year 2024-25 was Rs 1,37,97,136/-. Income from general donations was Rs.2,56,39,543.10, in the year 2024-25. Interest income from bank deposits was Rs. 66,93,563/- during the year 2024-25, which was low mainly on account of lowering of fixed deposit rates by the Banks. Similarly, subscription and membership fee was Rs 91,100/-. During the aforesaid year, income from tuition fees/grant Rs 81,06,657/-. Contribution from Indira Gandhi National Open University (IGNOU) was Rs 56,94,697. Affiliation Fee was Rs 38,000/-. The corpus fund of the trusts stood at Rs 10,29,53,233.97, as on 31.03.2025. Total number of trusts, as on 31.03.2025, is 4289 as per details given below:

After giving analysis of the main sources of income, Shri Ashok Chhibber analyzed the salient features of expenditure during the year. Pension to widows was given to the tune of Rs. 95,76,000/- to 558 widows in the year 2024-25. Financial Relief and welfare to Needy and Destitutes was to the tune of Rs.27,80,400/- in the year 2024-25 to 113 beneficiaries. Financial aid for education was to the tune of Rs. 8,67,000/- in the year 2024-25 to 81 beneficiaries. Relief and welfare by way of free Langar at the Ashrams was to the tune of Rs. 62,51,425/- in the year 2024-25. Expenditure on staff welfare stood at Rs. 1,72,391/- in the year 2024-25. A sum of Rs.52,75,678/- was spent on Building Repair and Maintenance in the year 2024-25 and Rs. 8,27,681/- was spent on property tax in the year 2024-25. A sum of Rs. 1,79,795/- was spent on insurance of buildings in the year 2024-25. A sum of Rs. 9,13,387/- was spent towards lease and ground rent of Mohyal Foundation building in the year 2024-25.

Coming to the budget proposals, Shri Ashok Chhibber submitted that a sum of Rs.1,00,00,000/-has been earmarked for widows' welfare; Rs.30,00,000/- has been earmarked for relief fund. A sum of Rs.1,35,00,000/- for MERIT; a sum of Rs. 1,15,00,000/- for Ashram Fund at Haridwar; a sum of Rs. 75,00,000/- for Vrindavan Ashram; provisions of Rs. 7,50,000/- Yamuna Nagar Community Hall Fund. Similarly adequate funds have been provided under different heads in the detailed budget. The budget estimates for the Financial Year 2025-26 shows a surplus of Rs. 49,01,711.87 (Receipts Rs. 10,24,51,711.87 and expenditure Rs. 9,75,50,000/-).

In conclusion, he reiterated that the accounts of the GMS are being maintained most meticulously both in traditional form by Double Entry Book Keeping as well as through computer and every paisa of money received and expenses incurred have been duly accounted for as per the statutory provisions and under the guidance of expert chartered accountants. He called upon the members to donate generously and augment the various funds of the Sabha by opening Trusts in the memory of their ancestors and dear and near ones. Only interest on trust money is used for activities of the GMS keeping the capital intact. He further added that these Trusts are a matter of sacred faith and all possible care has been taken to maintain these and carry out the wishes of the donors in letter and spirit. The way the Community has added to the number of Trusts and the Trust Money reflects the confidence of the Community in the working and credibility of the GMS under the visionary, dedicated and devoted leadership of our late illustrious President Mohyal Ratna Rzd B.D. Bali, which has been continued by Shri Vinod Kumar Dutt, President GMS

He further added that Trusts are being augmented and money added every day by more and more donors. Trust money is sacred, eternal and perpetual; the donations are put in fixed deposits and only interest accrued thereon is utilized for the purpose for which the Trust is created. He exhorted the Audience to be proud of the legacy of our illustrious and farsighted forefathers and count on their blessings and put concerted efforts to carry on the rich legacy for further generations to come.
