### **HEARTY WELCOME**



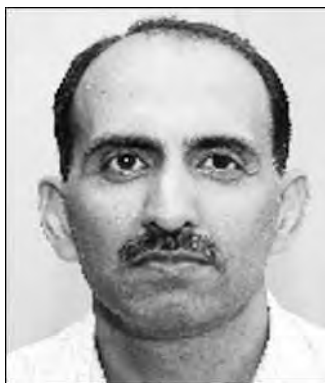
I am confident that you will benefit from these teachings to make your youthful presence felt by society, by rendering "Yeoman Service" to your own brothers & sisters.

## Courage and Valour of a Youthful & Joshila Ch. G.L. Dutta 'Josh' at the Mohyal Conference

While witnessing some acrimony & disobedience to the August body of Mohyals (G.M.S) a 47-year old Josh Sahib mounted the dais disregarding the objections from the Stage Secretary.



How young Ch. G.L. Dutta 'Josh' (Vice President, G.M.S) became the cynosure of all eyes way back in 1977, when the young courageous 'Josh Sahib' climbed on stage & took the mike, in front of Mohyal stalwarts like Bhisham Pitamah of Mohyals, the late Ch. D.N. Datta (Pioneer in Indian Photography) Sh. P.C. Mohan Ji, Magnetic Host Sh. Surinder Singh Bali Ji & the entire team of Jammu Mohyal Sabha and Sh. Roshan Lal Dutta Ji! President G.M.S. Sh. RB. Bakshi Badri Nath Chhibber & General Secretary Sh. B. Dass Chhibber, also adorned the stage. Also, there were Professor R.K. Chhibber, Sh. Sukh Raj Datta Ji & other office bearers of J&K Mohyal Sabha. Ch. Harnam Das Dutt and his wife, who were sitting near him, paid compliments to him. Thereafter, Ms. Brij Bala Chhibber also suggested the inclusion of women in the G.M.S Managing Committee.

An exuberant Josh Sahib insisted on speaking his heart out and mesmerized the audience by his love for Mohyal causes, in general, & the G.M.S., in particular. Though he spoke only for a few minutes, but he was listened to with rapt attention for the content of his youthful message.

We can all learn from this act of courage and commitment shown by "Josh Sahib" to the G.M.S. leadership till date & in the service of Mohyaliat.

In this very meeting, and at his behest, it was decided that there would be a Managing Committee of the G.M.S. of 40 members, and, out of 40 members, 5 will be female members. The election would be held by ballot and by independent Returning Officers. This Resolution was implemented in 1978 and still is in force. "Josh Sahib" was elected in the G.M.S. Managing committee, in 1978, and continues to serve the Mohyal *Biradari* till date. This incident was most heartening and the G.M.S. office bearers like Sh. Sushil Bali, Sh. J.N. Bali and many others complimented him for this courageous step "in the interest of unity and solidarity" of the *Biradari*.

The venue of the Conference was Gulab Bhawan, Jammu, and it was the 46<sup>th</sup> "All India Mohyal Conference" held in 1978, which was attended by close to 4,000 delegates.

## MOHYAL YOUTH— In the Service of the Nation

*Some youth Mohyals who sacrificed their lives very young for the sake of Nation, Motherland, Community & Humanity. My Head bows in obeisance, Heart gets filled with pride for the following young Mohyal's spirits:*

The youngest of Mohyal Warriors was 2<sup>nd</sup> Lt. Puneet Dutta, who sacrificed his life with Valour at the age of 24 years, fighting terrorists. The proud son of Major Pramod Nath Dutta



followed in the footsteps of his father. He was posthumously awarded "Ashok Chakra" on 26.01.1997, the highest Bravery Award. Puneet Dutta Memorial Garden, in Defence Colony, New Delhi, stands in his honour as a Hallmark of Bravery. He was indeed a Courageous, Fearless, Committed, true Mohyal, who will always inspire generations of Mohyal Youth.

**Major Nitin Bali** (age 27 years) laid down his life in the honour

of Motherland on 25<sup>th</sup> October' 1998. He was decorated with posthumous Bravery award by the Indian Army i.e. "Sena Medal". During his life time, he was highly decorated for establishing many records in Water Sports & Shooting. He was the only son of very distinguished & proud parents Dr. Shanti Sarup Bali & Smt. Adarsh Bali. In his memory stand Shaheed Major Nitin Bali Marg, Shaheed Major Nitin Bali Swimming Pool and Shaheed Major Nitin Bali Memorial, inspiring the Indian youth to join the services.

**Major Rohit Dutta**, at the age of 31 years, died fighting for the Motherland on 1.07.1997. He was also recipient of **Seva Medal** for Extreme Bravery and a postal envelope commemorating his valour was issued. He was a Badminton Champion & was always a Champion in real life as well. His proud father, himself a distinguished & well accomplished Mohyal in the field of Super Computer, instilled in him the Mohyali Ethos & Values, which were, displayed by this young Mohyal till his very end. He can be an example for young Mohyals as a born Leader & Champion.

Other young Mohyals, who sacrificed their lives for Mother India & its honour and who fought injustices against humanity, were **Bhai Mati Dass** (Chhibber)-34 years, **Banda Vir Biragi** (Chhibber)-46 years, **Bhai Bal Mukand** (Chhibber)-26 years, **Ram Rakha Bali**-33 years, **Major Sunil Dutt**-37 years, **Major Sunil Bakshi**-37 years, **Brig Ravi Dutt Mehta**-50 years, **Havaladar Navin Mehta**-36 years, **Lt. Mohan Bakshi**-28 years, **Capt. Raman Bakshi**-35 years, **Capt. Sudhir Mehta**-34 years & **Capt. Hitesh Mehta**-35 years.

The ABOVE EXEMPLIFIES WHAT YOU can do and achieve if you practise the Right values at the Right time. Youth are the future of the Country & the Community. The ABOVE MENTIONED YOUTH, with their valour, have assured a great present for all of us through their sacrifices. 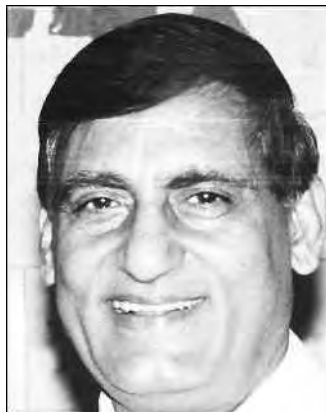

## SOME ILLUMINATING FACTS ABOUT SANSKRIT

■ As per Sir Monier Monier-Williams (1819-1899), famous for his Sanskrit-English dictionary, "India's national character is cast in a Sanskrit mould and in Sanskrit language. Its literature is a key to its vast religious system. Sanskrit is one medium of approach to the hearts of Indians."

■ On September 10, 1949, Dr. B.R. Ambedkar even sponsored an amendment making Sanskrit as the official language of India. But the said amendment was defeated in the Constituent Assembly. However, Sanskrit was included in the Eighth Schedule of Indian Constitution.

■ Sanskrit contains sublime thoughts in sublime words. All the Vedas, Upanishads, Aadi Kavi Maharishi Valmiki's Aadi kavyam Ramayana with 24,000 stanzas, Mahabharata, the longest poem in the world with over 1,00,000 stanzas, eighteen Puranas and several other holy books are all written in Sanskrit. Mahabharata also contains Bhagavad Gita.

■ A verse of Mahabharata proclaims that what is found in Mahabharata may appear elsewhere but what is not in Mahabharata would be found nowhere.

■ To understand and appreciate beauty of Vedas, Sanskrit provides six Vedangs: Shiksha (phonetics), Vyakarana (grammar), Chhanda (metre), Nirukta (etymology), Kalpa (religious practice) and Jyotisha (astronomy).

■ Sanskrit has the oldest and richest literature in the world. First Mantra of Rig Veda (1.1.1) is the first known poem in the world. English language prides having just one Shakespeare. Sanskrit has got thousands of Shakespeares. It is pitiable that the educated Indian knows nothing about them or about Sanskrit.

■ Sanskrit contains vast knowledge also about astronomy, astrology and mathematics. And Aryabhatt's *Aryabhatiyam* can be cited in this regard. Sanskrit also has *Ayurveda* (medical science) and *Dhanur Veda*.

■ Sanskrit is an impeccable language. It is a scientific and systematic language with a perfect grammar. It is computer compatible.

■ As per Sir William Jones (1746-1794), Sanskrit is "more perfect than Greek, more copious than Latin, and more exquisitely refined than either". Sanskrit is independent, and is not derived from any other language. Sanskrit easily explains complex thoughts in a simple manner. The single theme of 'sublime' permeates Sanskrit literature.

■ As per NASA, Sanskrit is "the only unambiguous language on earth". Even translated Sanskrit works have won admiration of scholars all over the world.

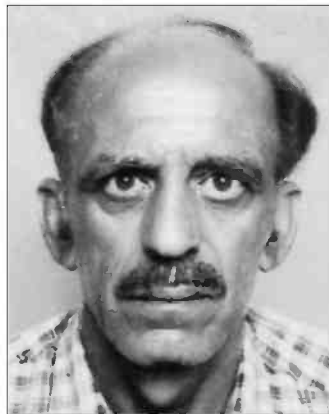

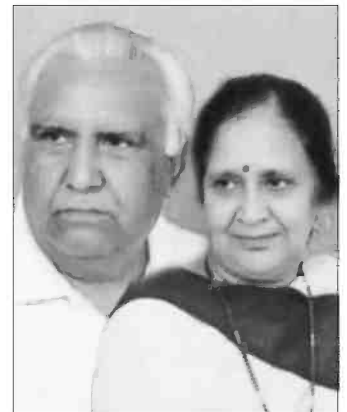

## MEANING OF OM: 'OM' ACROSS RELIGIONS

(This article tells us about the meaning of **OM**, and many other interesting facts about **OM (Aum)**, such as its origin, and its reference, in some form or the other, across almost all religions of the world.)

"Om" is the cosmic sound ever present in the Universe. Its physical manifestation in sonic vibrations has existed forever. Physical perception of this sound is described to be similar to what one would hear from the resonant notes of the tinkling vibrations of a big gong struck by a wooden hammer in a consistent manner.

In terms of phonetics, the pronunciation of 'Om' is described as *Au....3m*: 'Au' stretched with a stress almost three times higher than the 'ordinary' short or long vowels, followed by the *anuswara*-sound of the nasal sign(m). The syllable 'Om'/'Aum' is a monogram of this sound. All the activities and the order in this world are said to be generated and harmoniously regulated through the origin of this omnipresent subliminal sound.

Interestingly reference to this primordial omnipresent sound *Aum* is present in some form, in almost all religious texts in the world. *Om (Aum)* became the sacred word *hum* of the Tibetans, *amin* of the Muslims, and *amen* of the Egyptians, the Greeks, the Romans and the Christians.

The 'Om' sound of the self-inspired evolutionary pulse of the omnipresent supreme consciousness force (Brahm) has three divine manifestations in the sublime domains of nature; (1) those of creation( Brahma), (2)those of preservation (Vishnu) and, (3) those of transformation (Shiva). The vibrations and cosmic energy of this eternal sound regenerates the life force and vital spiritual energy of the one, who utters it repeatedly at consistent, rhythmic pace, accompanied by deep breathing, mental concentration and reverence. As a consequence, one experiences calming of emotions and rejuvenation of the mind and body system.

The syllable and sound 'Om' is a vital part of the science of Yoga. It's a tool and a phenomenon by itself, a mystery. To many people in the modern times, 'Om' (*Aum*) is just a word chanted in meditation, or as a closing prayer in yoga practice. Barbara Miller, a translator and scholar of the Bhagvad Gita, notes that ".....According to ancient Indian traditions preserved in the Upanishads, all speech and thought are derived from the one and only self existing sound-'Om'. It expresses the ultimate reality."

The Amrita -Bindu Upanishad states that "The eternal sound ('Om') is the supreme Absolute". It is the musical sound (*Nada*) generated by the cosmic vibration of Brahm that resulted in the manifestation of Nature and all creation."

The phonemes of the Vedic hymns and the seven fundamental notes – Sa, Re, Ga, Ma, Pa, Dha, Ni, of the Indian classical music have originated (recognized by the Indian Rishis) from the vibrations of the sublime sound of 'Om' in nature. The Vedic quote –"*Ekoham Bahusyami*" implies that all sounds, all energies, all motion and everything existing in the Universe have originated from the vibrations of this single *anahata nada*.

Paramhansa Yogananda referred to *Om* as "the vibration of the cosmic motor". The great pioneer of Yoga, Patanjali advised using 'Om' to overcome the obstacles and distractions in life that are stonewalls in the path of enlightenment.

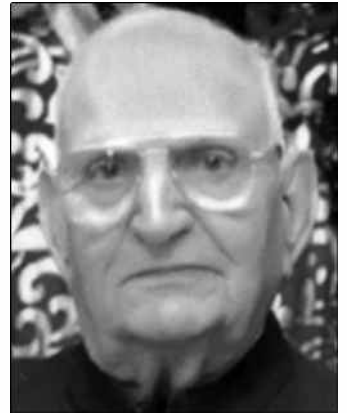

## MOHYALI FABLES

During the reign of Emperor Akbar (1556-1605), a pious man, named Baba Beram Shah Datt, was born in Village Keni in Mirpur in Jammu State and was widely known for his nobility and spiritual attributes. He was verily a miracle monger and was known to levitate in the air astride a horse, and to transmute copper into virgin gold, by a mere touch of his hand. Even Akbar was impressed by his spiritual powers and awarded him an Ornamental Plaque of honour and gifted to him the town of Shimbar as Jagir. Beram Shah had predicted his own death eight days in advance.



Baba Garib Dass, whiz kid son of Baba Beram Shah, was an equally renowned figure of his time, during the reign of Jehangir (1605-1627). He led a rather ritzy life and celebrated three nuptials. He was a prodigy of supernatural art and once stepped into a cauldron of boiling oil in the presence of Guru Govind Singh and the oil turned cold instantly. He died in an accidental fire as exactly predicted by his father.

While the Marathas had their Joan of Arc in Rani Lakshmi Bai, the Mohyals too had their heroine in Karmo Mai Dattani. Shortly before the rule of Maharaja Ranjit Singh (1792-1839), Sardar Jaimal Singh was the head of the Kanihya Missal in Amritsar (Missal was a squad led by a powerful personality and there were a dozen Missals at that time). Jaimal Singh appointed Mai Karmo as Chief of Katra Kanihyas. The intrepid lady held her court in the open, in a jostling Market Square of Amritsar, which is known by her name till today, viz. "Karmo Ki Deodi". She was a terror to the local ruffians & desperadoes, and used to administer justice, without fear or favour. She once took part in a battle wearing the Coat of Arms. The Seal of her high office is believed to be still in the possession of her progenies. Near Karmo Ki Deodi, plots of land were acquired, mostly by Mohyals, and a street parallel to Katra Jaimal Singh came up, which is still known as "Kucha Mai Karmo".

After exodus from Arabia, some Datts settled at a place called Hasan Abdal near Nankana Sahib (now in Pak.). It was here that, in the closing decade of the tenth century, an interesting incident took place, involving one Pir, called Wahun, a trickster Chess Player, and Shiv Datt (also known as Sidh Datt), Helmsman of the Datts. Wahun was known for his knack of invariably winning games. According to the bet fixed by him, the loser would either pay the price with his head, or, alternatively, embrace Islam. In this way, he had converted a large number of Hindus to the Muslim faith, till he met his match in Shiv Datt. The latter challenged the Pir to a game of Chess and defeated him three times over, in a row, thereby claiming the heads of his wife and one son, as per the stakes. The flabbergasted Pir had to eat crow. However, out of sheer magnanimity, Shiv Datt spared their lives. When Wahun later came to know that one of the ancestors of Shiv Datt had sacrificed his seven sons for the sake of the Prophet in the battle of Karbala, he became very obliging to Shiv Datt and took a solemn vow that, in future, he would never convert any Hindus, by coercion, to Islam. It was on this occasion that the Pir uttered the famous words from his heart "Wah Datt Sultan - Hindu Ka Dharam Mussalman Ka Iman".

## Preeti Mohan Selected as 'Brand Ambassador of Hyderabad Metro Rail'

It was her sheer merit, determination, strong will and organized hard work, spread over eleven months, from Jan to Nov. 13, that brought glorious success to Smt. She had to undergo various levels of activities, including audition, and aptitude tests in cultural, social and academic performances, for months together. ## **MOHYAL HABITAT-II**

### **BHERA – CHHIBBERAN DI RAJDHANI**

The original town of Bhera was situated on the right, i.e. the western bank of river Jhelum. It had always been the principal city in Singhpura or the Salt Range area (Koh-i-Jud of the Muslim chroniclers). In 326 BCE, Alexander had fought a battle with Porus in this general area. Pliny states that the kings of the country derived greater revenue from the rock salt than either from gold or pearls. Being on the trade routes connecting Kannauj to Kabul and Kashmir to Multan, the traders, travelers and invaders, coming to India, passed through it. At Bhera the Chinese pilgrim FaHian crossed the Jhelum river in 400 CE. In May 631 CE, Hueun Tsang also visited Singhpura.

Chach, an ancestor of Chhibbers, acquired the throne of Sindh, in 632 CE. In his first campaign, he turned eastward. Fighting and subduing recalcitrant chieftains at Pabia, Sikka and Multan, and crossing West Punjab, he reached the frontier of Kashmir. There he planted two saplings – a poplar and a deodar – and said that it was the boundary between him & Kashmir, and beyond that, he would not go. He made firm treaties with the chief rulers of the area and securely established that part of his kingdom. His kinsmen – the Chhibbers – must have been the beneficiaries. He next went westward up to Kirman and, likewise, established “the boundary of Hind in the time of Chach”.

This Chhibber dynasty ruled up to 712 CE, when the Arabs conquered Sindh, during the reign of Dahar, son of Chach. However, the area between Multan and Kashmir remained outside the Arab administration. According to Mohyal History, sons of Dahar managed to retain control of this region. Maharaj Jaya Singh established himself at (old) Bhera, Narayan at Pathankot and Bhawan with Chham at Bhatner (now called Hanumangarh). Possibly, it was a single kingdom (the unconquered part of the monarchy of Sindh), with the younger brothers posted as governors on the borders, adjoining Multan and Kashmir, for better administration. Later, in the ninth century, a VAID family acquired control over the whole area between the rivers Sindh and Satluj, till they were displaced by Mahmud Ghaznavi, in the beginning of the eleventh century.

Bhera was sacked by Mahmud Ghaznavi, and, two centuries later, by the armies of Chingis Khan. Its importance is shown by the fact that Babur conducted his first major Indian expedition to Bhera, in 1519 CE, and collected 400,000 *Shahrukhis* from its inhabitants as ransom (*mal-i-aman*, i.e., the price of peace). This old town had to face extinction when Sher Shah Suri (1540-1545) defeated Humayun and the Pathan forces took revenge on the then pro-Mughal town of Bhera. When Sher Shah visited the place, he was distressed to see its plight. He encamped at the left bank of the river Jhelum and constructed the first building there, thus laying the foundation of new Bhera. During the reign of Mughal Emperor Akbar, Bhera regained its glory, but, with the Mughal decline, it was plundered and laid waste by Ahmad Shah Abdali's general, Nur-ud-din, in 1757 CE. Bhera was re-populated by the Sikh Chieftains of the Sukar Chakia and Bhangi *misls*, when they took over the Salt Range area, in 1767 CE.

With the annexation of the Punjab, Bhera came under British rule. Gradually, a network of railways was established in the country. It became cheaper to transport men and materials through trains. Trade caravans, which had, for centuries, moved along the land routes passing through Bhera, gradually ceased to operate. Bhera thus lost its renown as a commercial hub. The rail connection is Lahore-Lala Musa-Malakwal-Bhera. A newly constructed highway, connecting Lahore and Islamabad, now passes through Bhera.

There must have been a sizeable population of Mohyals in Bhera – mainly Chhibbers and Datts – during the beginning of the British rule. Their younger generations took to modern education early

(Bhera had two high schools, with boarding houses) and moved out, chasing government jobs. The older generations remained behind. The same was true about *Khatris* (Sahni, Khanna, Kapur, Gandhi, Mallik etc.), the predominant community among the Hindus. There was a “*Chhibberan da Mohalla*”, *Chhibberan dian Hatian* (a small market)” and “*Dattan di Gali*”, in Bhera.

After the carnage at Mamdot, an ancestor of Mohans, had shifted from Kanjgur to Pind Dadan Khan via Bhera, where he had been married. Most of the Mohan families are from that Pind Dadan Khan stock – others are descendants of the few Mohan survivors, who could manage to escape from Mamdot. Roughly, during that period, the family of Dewan Narinjan Das Chhibber, that acquired great acclaim for serving in very high posts under the Amirs (Kings) of Afghanistan, had migrated from Bhera to that country. Bakshi Ram Das Chhibber (co-founder of the General Mohyal Sabha); Bakshi Brij Lal Chhibber, Editor Mohyal Mittar; his son, Bakshi Dhan Raj Chhibber of Inderpuri, New Delhi (Secretary, GMS -1983-1993); Rai Saheb Bakshi Harbans Lal Chhibber, Under Secretary; and Mehta Budh Dev Datta, Superintending Engineer, were some of the well-known figures of recent times.

Present day Mohyals find it difficult to properly pronounce/spell the names of the places of their origin in Pakistan. Here is a list of the names of villages/towns, in which Mohyals lived before Independence in the district of Jhelum (in which old Bhera was located): Ahmedabad, Allawalpur, Bajwalla Dattan, Karyala, Bhaun, Chakwal, Choha Saidan Shah, Katas Raj, Dalelpur, Daska Jalab, Daultala, Dharyala Jalab, Dhidowal, Domeli, Dulmial, Haranpur, Jhelum, Kala Gujran, Kallar Kahar, Karim Pur, Khandoya, Khan Pur, Khurd Chutala, Haran Pur, Latifal, Mandi Mari, Paniad, Pinanwal, Pind Dadan Khan, Ranjha, Rohtas Fort, Sanghoi, Sahuwal, Said Pur, Sarkar Kassar, Thaliwal. ## Mohyal Gaurav Anand Bakshi (Vaid)-Sweet Remembrances

Shri Anand Bakshi was born in Rawalpindi, on July 21, 1930. He started his career, first in the Navy and then in the Army.



He was the most popular lyric writer of Hindi films and had won the coveted Filmfare and Lions Awards, a number of times. His light-hearted ditties have entertained a generation of cine-goers. His songs like '*Bindiya Chamkegi*' in "*Do Raste*" and '*Mere Sapnon ki Rani Kab Ayegi*' in "*Aradhana*" have a teenage zing and are perennial favourites. He also wrote songs for the Indo-Russian production "*Ajooba*", which had a mega star cast. His much toasted '*Dum Maro Dum*', sung by Asha Bhonsle in '*Hare Rama Hare Krishna*', hit the charts.

He got his first break, when Actor-Director Bhagwan Das paid him the princely sum of Rs.150/-, for four songs, in his film "*Bhala Aadmi*". In a career spanning 45 years, he had composed 4500 songs. A singer also, he sang a duet with Lata Mangeshkar, for the film "*Mom-Ki-Gudia*". He also contributed a song in the '*Mohyal Nite*', held in Mumbai. Curiously, his first song had been published in Mohyal Sandesh, Rawalpindi.

He was the winner of the Best Lyricist Award of Filmfare in 1978, 1981, 1996 & 1999. The illustrious poet, who swayed the hearts of millions, for more

than four decades, died on the 30<sup>th</sup> March, 2002, at the age of 72. His death was mourned by the entire film industry, and the vast majority of fans in India and abroad. The leading luminaries of the film industry paid rich tributes to him, not only for his achievements in the music world, but also for his simplicity and loveable nature. Lata Mangeshkar, the illustrious singer, in her tribute, complimented him by saying that most of the songs sung by her were penned by Bakshiiji. Smt. Sushma Swaraj, the then Union I&B Minister, also paid rich tributes to him.

Bakshiiji was a staunch Mohyal. We all cherish his memory and bow our heads in reverence to the noble soul.

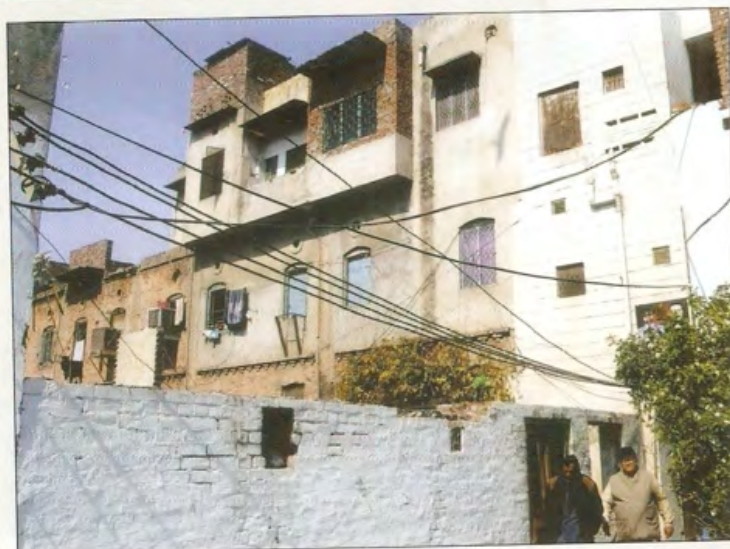
