

PROCEEDINGS OF THE GMS ANNUAL GENERAL BODY MEETING HELD ON 9TH NOVEMBER 2014

The programme started at 10.00 a.m. on 9th Nov. 2014 with Registration, wherein all members signed their attendance on arrival at the venue, where they were given a copy of the report of the Secretary General and a copy of audited Statement of Accounts. Refreshments were served to all members, who had come from all over the country and used this opportunity to meet each other and exchanged pleasantries. Over 450 Mohyal brothers and sisters attended the function.

Lt. Gen. B.K.N Chhibber, PVSM, AVSM, VSM was the Chief Guest, who was given a affectionate welcome by Rzd. B.D. Bali, President GMS and the Mohyal Community. They unfurled the Mohyal Flag, which was followed by chanting of the Mohyal Prayer led by Smt. Krishan Lata Chhibber and Smt. Sunita Mehta and roars of JAI MOHYAL. After this wreaths were placed on the portrait of Bhai Mati Dass by Gen. B.K.N. Chhibber and Rzd. B.D. Bali. Bhai Mati Dass had achieved martyrdom on 9th Nov. 1675. The dignitaries were thereafter escorted to the dais after lighting the inauguration lamp. (Deep Prajwalan).

Lt. Col. L.R. Vaid welcomed the august gathering and said, we look forward to a pleasant and fruitful interaction. He said the Business Session will include, Report by Shri D.V. Mohan Secretary General, followed by presentation of Accounts by Shri B.L. Chhibber IRS and Points from members. He told the House, that the Extraordinary General Body Meeting will not be held since due to an oversight, the agenda for the same was not circulated. He then requested the House to rise and pay homage to all members of the *Biradri* who left for their Heavenly abode. The House stood up and observed two minutes silence as a mark of respect for the departed souls. After the members took their seats, Col. Vaid said that it was a matter of great honour for us to have Lt. Gen. BKN Chhibber former Governor of Punjab amongst the Biradri today, a Mohyal with a very wide expierence who is respected and loved by all. The House formally welcomed him with a thunderous applause. Col. Vaid than said that we are very fortunate that we have Rzd. B D Bali as our Team Leader. When you give so freely your Time, Talent and Treasure you truly make the world a wonderful place and that is exactly what Bali Sahib has done for the community. He has served the community selflessly since 1978. He started literally from a scratch and has created assets for which he will be remembered for generations to come. The House expressed its gratitude to Rzd. B.D. Bali by a thunderous applause and roars of JAI MOHYAL. Col. Vaid than invited Bali Sahib to give his welcome address.

Rzd. B.D. Bali said that he has been involved with GMS for many many years. He reminisced how when he took over the GMS in 1978, there were plenty of blessings from the elders but there was hardly any cash or bank balance. The meetings were conducted in a tin shed in Inderpuri, sitting over the gunny bags with almost no fan. His first action was to create credibility for our parent body and towards this end, he brought in eminent Mohyals with successful background who would not only inspire the community but also give the benefit of their expertise. Unity was another important factor and all the local sabhas had to be set up and reactivated to involve the community in totality for any development and progress in future. Today, looking back, it is a matter of enormous gratification that presently GMS stands at a pedestal of which we all can be proud.

He said that besides GMS there are almost 70 vibrant local sabhas who excepting one, are all affiliated to the GMS and we have their full support in every way and everything. All the projects which we have launched, the community came forward with full financial and moral support because they had confidence in their apex body and a trust that every penny contributed will be judiciously spent for the welfare of the community.

30-40 years is not a long period in the history of any society. India got its independence in 1947 and we are still in the process of development. He beseeched everyone to come forward to achieve the goals to be set up in future and one must ask oneself the question "What I have done for the community and what I am going to do in future?". We have to play a positive role. We may not be there in the future but the community and the institution which we are creating, will continue to be always there. On personal side, he said that he loved every Mohyal and has no malice against anybody but he had regret only for such people who by virtue of their egos and arrogance are hurting the credibility and unity of the community and its apex body.

Lt. Gen. B.K.N. Chhibber, the Chief Guest was requested to address the House. In his opening remarks he described Rzd. B.D. Bali as a friend, philosopher and a guide of the community. He thanked Bali Sahib for personally inviting him for the function and it was a matter of pride for him to be with the family. He confessed that, had he been in Bali Sahibs place he could never have done so much for the community as achieved by Rzd. B.D. Bali. He said that Mohyals stand out in the population and history of India. It was amazing that a community of Brahmins rose to such a height as to rule over vast areas of North & North West India. He said that history shows that Mohyals have been migratory. He gave details of the origin of Chhibbers and their movement from Mathura to Rajasthan to Afghanistan to Iran, to Bera on the banks of river Jhelum. Coming from a ruling class, Mohyals still hold their heads high and are a prospering community, but there is a need to impart modern education and give guidance to the youth in order to better their prospects in life, which is being done by the GMS under the leadership of Rzd. B.D. Bali. He said that it was necessary for Mohyals to write their subcastes with their names so that they can be easily identified. Gen. Chhibbers advice was, Want more - Work more-Get more!

Shri D.V. Mohan, Secretary General read out his report which gave details of the activities of the GMS since the last AGM. The report is printed elsewhere in this issue of Mohyal Mitter.

Shri B.L. Chhibber, IRS (Retd.), started his presentation with the blessings of Lord Parshurama and Saptarishis and of our ancestors, who started the august body of GMS in 1891. He presented the audited Balance Sheets for the financial years 2012-2013 and 2013-2014. The budget proposals for the current financial year 2014-2015, copies of which were distributed to all present. He said that our ancestors had planted a small plant, which has now grown into a big banyan tree, under the shade of which we all are now sitting.

He explained the salient features of the statements of Accounts and said that our motto has been that our income should always be more than our expenditure. In this connection, he cited a Sanskrit *shloka* from Ramayana containing discussion between Lord Rama and his younger brother Bharat, i.e. Income should be more, expenditure less and revenue should not go into the hands of undeserving citizens.

He said that our biggest source of income has been the Rental of a portion of Mohyal Foundation Building, which we have given on rent to an NGO, PATH. Rental income for the year 2012-2013 was Rs.1,32,48,000/-and Rs. 1,38,24,000/- in 2013-2014. Second source of income has been donations. Interest accrued on donations to Trusts is the third source. In 1978, when Rzd. B.D. Bali took over as President of the GMS, the total trust money was around rupees two lacs. We are now reaching a figure of Rs. 7 Crores and our aim is to increase it to Rs. 10 Crores. Our interest income from the trust money, in 2012-2013 was Rs. 75,71,000/- and during 2013-2014, Rs. 63,13,000/-.

Total donations received in 2012-2013 were Rs. 1,33,00,000/- and total donations received in 2013-2014 were Rs.1,27,00,000/- which include donations received for Lunger funds, towards rooms in Ashram and general donations.

The fourth source of income is the fee we receive in MERIT from the various courses conducted in Information & Technology at the institute and tests i.e. TOFEL and GRE we are conducting in our two world class labs as a result of which we are happy to say that MERIT is showing surplus income adding up to the main kitty.

According to the Budget Estimates for 2014-2015, as against receipts of Rs. 5,72,20,000/-, there is an expenditure of Rs. 4,75,00,000/-, (leaving a surplus of around Rs. 1 Crore) which includes relief to widows aid to weaker sections, healthcare and stipend to the students, students and cost of establishment expenses at Mohyal Foundation and various Ashrams.

Shri B.L. Chhibber appealed to the audience to open family trusts to perpetuate memory of their dear ones. As against total Trust amount of Rs. 5,92,00,000/- in

2012-2013, the figures reached Rs. 6,36,00,000/- in (iii) Shri Rakesh Vaid: Let us be proud of Rzd. B.D. 2014-2015 and is projected at Rs. 6,58,00,000/-, at present and our aim is to gradually increase to Rs.10 crores.

Chhibber Sahib explained to certain queries raised by the audience. Subsequently, the following five statutory resolutions were passed by a voice note.

RESOLUTION-I

Resolved that the general body of the General Mohyal to create friends. Resolved, that audited Balance Sheets and Income & Expenditure statements for the Financial Years 2012-2013 and 2013-2014 are hereby approved and adopted.

RESOLUTION-III

Resolved, that the general body of the General Mohyal Sabha (Regd.), in its meeting held on 9th November 2014, at Mohyal Foundation, New Delhi, appreciates and approves the report for the period 2013–2014, submitted by the Secretary General of the Sabha.

RESOLUTION-IV

Resolved, that M/s. H.S. Ahuja & Co., H-61, Gobind Mansion, Connaught Circus, New Delhi-110001, are hereby appointed as auditors of the General Mohyal Sabha to hold office from the conclusion of this General Body Meeting until the conclusion of the next General Body Meeting of the Society on such remunerations and terms and conditions as may be fixed and approved by the Managing Committee of the GMS.

RESOLUTION-V

Resolved, that the general body of the General Mohyal who had come to Lahore, to get education. Every Sabha, at its meeting held on 9th November 2014, at Mohyal Foundation, New Delhi, approves and adopts the Budget proposals for the financial year 2014-2015.

OPEN HOUSE

The following speakers spoke at the Open House:

- (i) Shri Rit Mohan: He said that AGM coincides with the martyrdom day of Bhai Mati Dass ji and we pay our homage to him for his great sacrifice. We are proud to be born as Mohyals.
- (ii) Group Capt. D.C. Mehta: I am as proud as a Mohyal as each one over here. I come from South Zone Sabha and this Sabha has no complaints against the parent body. GMS is a big family. There can be differences of opinion. Problems can be sorted out by mutual discussion. Do not take to street and do not wash dirty linen in public.

- Bali. He has done a great task. However, there should be rules of business, which should be followed strictly. Prepare a road map to be followed strictly. We should help each other and not pull anybody's leg. Membership drive has to increase. We should be more transparent in our working.
- (iv) Shri Bunty Bali: There is misuse of Social Media. I have not come here to create enemies. My purpose is and positive way. Good work being done by GMS should be propagated through Social Media. We all should work for the betterment of the Community.
- (v) Shri P.K. Datta: I have come here to welcome you all. The motto is to progress in the interest of everybody.
- (vi) Shri Himanshu Bali: Live in love. Do not fight or hate others.
- (vii) Shri J.P. Mehta: There is nobody who can point out shortcomings in Rzd. B.D. Bali. I have created Local Sabhas at Sirsa, Naraingarh & Paonta Sahib. I have also helped in reviving the Sabha at Amritsar. The Interaction Committee of the GMS is not active which should be strengthened. It was wrong to stop defeated candidates from becoming Representative Members of the Managing Committee of the GMS.
- (viii) Shri Vinod Dutt: What Rzd. B.D. Bali has done for the GMS, nobody can do. There is need to eradicate illiteracy from the Community. Everybody should adopt at least one child, by name. I went to Naraingarh and helped out the children and GMS gave them scholarships. There was problem at Jalandhar. I sorted out that problem. Similarly, I helped at Lambra and am willing to sort out any problem over there.

His grandfather Ch. Ganesh Dass Dutt was the first Vice President of the GMS, who helped Mohyal students, problem can be solved. He has prepared an online system for booking of rooms at Haridwar. He has made a website of Khanna Mohyal Sabha and has plans to create a website of the GMS. Through an intervention, Rzd. B.D. Bali said that Sh. Vinod Dutt is a very quiet worker and a big donor and the Community is very proud of him.

(ix) Shri Sanjeev Rai Vaid: His son created a website on Ludhiana Mohyals. GMS website is not dynamic. GMS has created assets and credit for this goes to Rzd. B.D. Bali. Membership is less than 1% and it should be increased. Accounts should have been sent along with the letter of invitation of the AGM. (this was agreed upon Let brothers not fight brothers.

The meeting ended with a Vote of Thanks by Sh. O.P. Mohan, Sr. Vice President, GMS, and Shanti Path by Smt. Krishanlata Chhibber followed by Lunch.

REPORT BY THE SECRETARY GENERAL GENERAL MOHYAL SABHA (Regd.) ON SUNDAY 9th NOVEMBER 2014

Dear members,

T is my privilege, once again, to go over the developments in the General Mohyal Sabha since the last AGM held on 26th May 2013. Before I do that, I would like to pay homage to all the members of the society, who, during the period, had left for their heavenly abode. In this connection, I would particularly mention the name of Sh. Virender Pal Singh Bali, Managing Committee Member, from Barara. Let us pay homage to all of them and pray to almighty God to grant eternal peace to their departed souls. We share the grief with all the bereaved families and pray to God Almighty for grant of strength enough to the members of their families to bear their losses.

Mohyal Youth Camp: Mohyal Youth Camp was held at Vrindavan from 28th to 30th March 2014. There were over 400 participants, 70% of whom were youth. All the participants were highly appreciative of the stay and food arrangements as also the recreation facilities. Three interactive groups were formed and the business session was equally meaningful and productive. The Financial Year 2014-2015 has been named as "Year of the Youth". There was complete unanimity in the thought that youth are the real wealth of the country and that their potential is fully developed for the advancement of the community. There was interaction with the Presidents and Secretaries of the local sabhas. The key-note address by Lt. Gen. G.L. Bakshi (Retd.) was thought provoking. It was decided to encourage the youth to join the mainstream of the Community. The response from the youth was equally gratifying and one could feel the urge in their mind to play dynamic role in the affairs of the Community. A new education trust (Adopt a Child) was announced with a onetime donation of Rs. 11,000/-, which will form a corpus fund and the interest accruing thereon will be utilized for the education of the children. Along with the Youth Camp, there was inauguration of Goverdhan Ashram on 30th March 2014 with the performance of Havan and inauguration of the Goverdhan Ashram by Mrs. Nirmal Bansal, wife of late Sh. Beni Parsad Bansal, who had donated the land to the GMS.

As a follow up to the Youth Camp, an interaction with selected Mohyal youth was held at Mohyal Foundation, New Delhi, on 27th July 2014.

Pratibhashali Vidyarthi Samman Samaroh: The last Pratibhashali Vidyarthi Samman Samaroh was held at Mohyal Foundation on 17.11.2013, with an audience of 350 guests. As compared to only 32 awardees in the initial year, the number has increased steadily to 71 awardees in 2011, 82 awardees in 2012 & 106 awardees in 2013.

Uttarakhand Tsunami: GMS team distributes relief material to victims at their doorsteps: A consignment of relief material for victims of Uttarakhand Tsunami was flagged off by Mohyal Rattan Rzd. B.D. Bali, from the Mohyal Foundation, New Delhi, on 19/09/2013. It consisted of blankets, jackets & sweaters, daris, tarpaulin and umbrellas. The relief team, under the leadership of Sh. Yogesh Mehta (Secretary-Youth Wing & Cultural Affairs) and consisting of S/Sh. Ashwani Bakshi, Sanjeev Bali (Bunty), Sanjeev Rai Vaid, Nirmal Vaid & Rakesh Vaid, left Delhi with material on 19/09/2013. The material was distributed to the beneficiaries in some of the affected villages, with the cooperation of local villages' Office Bearers.

Pension to Widows: The number of widow beneficiaries is increasing from year to year. During the Financial Year 2013-2014, there were 362 widow beneficiaries and 75 cases of relief to needy persons/destitute etc. During the Financial Year 2014-2015, the number of widows has increased to 384, while the number of beneficiaries of relief to needy persons/destitute has remained constant at 75.

Educational Relief: The beneficiaries under education scheme are also increasing from year to year. In the year 2012, there were 41 beneficiaries at Undergraduate level and 15 at Graduation & Post graduation levels. The number increased to 57 at Undergraduate and below classes and 16 at Post graduation and Technical courses, during the Financial Year 2013-2014. During the current Financial Year, there are 64 beneficiaries from the Undergraduate and below classes and 21 beneficiaries for Post graduate and Technical & Professional courses.

Trusts: At the time of last AGM, the total trust money with GMS was 5,97,11,682/- (figure as on 31.03.2013). The amount has since increased to 6,54,39,700/- (figure as on 31.07.2014), an increase of Rs. 57 lacs.

Langar Fund Donations: Langar Fund Donations are increasing steadily. As compared to 1456 Langar Fund Donors at Haridwar, at the time of last AGM, the number has increased to 1622, a corresponding figure for Vrindavan are 282 and 386 respectively.

Permanent Membership: As compared to 2182, Patrons, Pratishthith and life members, at the time of last AGM, the number has now increased to 2316.

Adopt a Child Scheme: A new scheme of Adopt a Child by making one time donation of Rs.11,000/- was started at the time of Youth Mela at Vrindavan. The number of donors for the new scheme, which is meant for the

education of underprivileged Mohyal children, has come UNSUNG & UNWEPT HEROES OF to 44.

Gurdaspur Samadhi: A total donation of 3.5 lacs has been given by the GMS for renovation of Holy Samadhi of Baba Thakkar ji Maharaj at Gurdaspur.

Mohyal Play School: Mohyal Play School at Mohyal Ashram Haridwar, which was started on 01.08.2012, has got a very good response and presently there are 42 students of Nursery Play School and Junior KG.

Dehradun School: Sixth standard classes have been added and the total strength of the students now is 152.

Matrimonial Melas: After the sixth grand Matrimonial Mela at Khanna, on 31st march 2013, no annual mela has been held, as yet, but the quarterly Shadi Darbars are being held regularly at the Mohyal Foundation building with good attendance and appreciative results.

Local Sabhas: All Sabhas, except one, have been affiliated with the GMS, that speaks volumes for the credibility of the GMS and the unity of the Community.

Online booking: Online booking of rooms at Mohyal Ashram Haridwar has since been started.

New Mohyal Bhawan at Yamuna Nagar: A new Mohyal Bhawan, in place of the old one, is proposed to be constructed at Yamuna Nagar. Donations have started coming.

MERIT

MERIT has been on an upward swing over the last few years and its productivity has increased manifold. Its net income over expenditure, which was (-) Rs. 1.95 lacs at the end of Fin. Year 2010-2011, has grown and shown a surplus of Rs. 33.47 lacs at the end of Financial Year 2013-2014. It is hoped that this trend will continue and MERIT will continue to show surplus in the coming years

MERIT is accredited to IGNOU & Jamia Milia Islamia for conducting their distance education courses like BCA, MCA, CCCHNT, CCIT, etc.

MERIT is a testing centre for TOEFL & GRE. It is one of the most popular testing centers in Delhi/NCR. In 2013-2014, 220 tests were conducted. In 2014-2015, during April to October 2014, 66 tests have been conducted.

MERIT has set up two world class fully sound proof Computer Labs on the second floor of Mohyal Foundation building. These two world class labs are mainly for conducting online tests.

MERIT has recently launched its new website: http:// www.meritlogics.com. The website is interactive dynamically, with advanced features. Anyone can access information from the website, relating to testing, training and the various courses run by MERIT.

We are planning to set up a branch of MERIT in Yamuna Nagar at the new Mohyal Bhawan, which is likely to be ready in 2-3 years' time.

ZAFFARWAL DATTAN

Woh So Gave Dastan Kahte Kahte

The two brothers Mahasha Karam Chand Datt and Mahasha Hari Chand Datt were known for their geniality and helpful nature. Karam Chand was a staunch Arya Samajist. He was upset when he came to know that a church was going to be built in Zaffarwal. Then one day he saw the ground being dug for the foundation of the church and decided that he will do all that he can to stop its construction. He called his relative Dewan Chand Datt and they both lay on the dug out ground and declared that they will sacrifice their lives but will not allow the construction to take place. Due to their stiff opposition, the plan of building the church was given up.

On the morning of 26th August 1947, there was sudden invasion of Muslim rioters on Zaffawal followed by large scale killing. People left their houses and fled towards river Ravi. They could not cross the river to reach the other bank in search of safety because a portion of the bridge known as Dera Baba Nanak Pul was demolished by the Baluch army. The slaughter of innocent and helpless went on till late in the evening. The wife and daughter of Mahasha Hari Chand were brutally killed and their bodies were lying before him. Even as fleeing people persuaded him to carry away their dead bodies, the noble hearted man paid no attention and kept himself busy in running to closeby water channel to dampen his turban and the little water that it absorbed he squeezed into the mouths of injured men and women lying on ground gasping for life. He carried on the noble deed till he was exhausted. Nobody knows the ultimate fate of the samaritan Mohyal and his dead wife and daughter which became part of the folklore.

Vidyawati was born in Jammu in 1904 and married to Balwant Singh Datt (born 1899) originally of Zaffarwal and later settled in a village near Lyalepur (now Faislabad). Balwant Singh spent his life as freedom fighter and was imprisoned several times and awarded Tamra Patra. During imprisonment in Karnal jail he studied about references to Bhagwad Gita in the holy Granth Sahib and published a book in Urdu titled 'Guru Granth Sahib Mein Krishan Bhakti'-Vidyawati looked after the family during frequent imprisonments of Balwant Singh and though herself studied to low standard, she would teach the children of the village instead of wasting time in aimless pursuits. Later she herself joined a school for higher study and it was a pathetic sight to see her going to school carrying her 3 months baby in one hand and books in the other. She did all this as she did not want to be a hurdle in the way of Balwant Singh in his political activities. After partition, the family settled in a small village near Panipat where there was no school and Vidyawati started teaching the children. She passed away in 1978 and Balwant Singh passed away in 1983.







When we use to read obituary columns in magazines, a fear of uncertainty swept our mind. And when our dearest *Daddiji*



went for his eternal journey on 26th May 2014 and while writing this column that uncertainty has revealed its true picture of sorrow and agony stored within it. Tears trickle down, my hands stumbling and mind shaken down with his memories, a simple question comes to my mind Chithi na koi sandesh, Jane who kaun sa desh jahan tum chale gaye jahan tum chale gaye Daddiji.

Our dearest, respected Daddiji Dr. Madan Mohan Mehta, 32/2 Balkeshwar Colony Agra, left for his heavenly abode on 26th May 2014 at the age of 83 after a brief illness. He was an adorable husband, loving father, caring brother, affectionate dadaji, nanaji, and warm chachaji and mamaji. He was a pious soul and kind but strong hearted man. He was a dedicated Mohyal Brahmin, a true Punjabi, a staunch RSS and VHP member. He used to greet everyone by saying "Jai Parshuram Ji Ki".

Daddiji was a good orator, a man of principles and a very good writer. We still remember





HISTORY OF PAIL BAKHSHIAN

During the reign of Maharaja Gulab Singh of Kashmir, Bakhshi Radha Kishen won laurels for his conquests of Gilgit and Ladakh in 1861. He hailed from village Thoha in Tehsil Kalmata of Rawalpindi District. A commoner by birth, he shot up to the position of Commander of the Kashmir Army in 1861, due to his leadership qualities. His son Bakhshi Moolraj, who earlier served as colonel in the army was made Governor of Ladakh. He had his estate PAIL. Bakhshi Moolraj had two sons, Bakhshi Ram Dass who became Chief Minister of Poonch and Bakhshi Moti Ram was member of the State Assembly and Chairman of the Military Board. Bakhshi Thakar Dass son of Bakhshi Ram Dass was an eminent barrister and retired as Judge of the High Court of J&K. Bakshi Moti Ram had five sons, four of whom have expired. The youngest son Shri Prehalad Bhagat is well settled, doing his own business alongwith his son Shri Sumesh Bakhshi at Baroda (PAIL House opp SRP Group IX, Makarpura road Baroda, 09376219964)

DIABETES – A Life threatening Disease 2

Other reason of diabetes: Beside the pancreas not functioning properly, the other reasons are due to non functioning of our vital organs like adrenal gland, thyroid, pituitary gland and liver. Only tests can confirm this.

Treatment of diabetes by yoga Asans: Doing the following Asans in the supervision of an expert Yoga teacher in the early stages of diabetes would help to cure the disease within week's time.

Asans: Mandukasan, Ardhamasyendrasan, Navasan Konasan, Suryanamaskar, Halasan, Navkasun Janushirasan, Kamarchakra, Bhjujanagasan and Shalabhasan. In the beginning of Asans it is necessary to do the 10 to 15 warm ups exercise. This would open your stiff joints and help in doing the asans.

Shudhi Kriyas (Purification Methods) Kunjal, Anima (Do it if you suffer from constipution), Jalneti, Rubbernati once in week. Put few drops of mustard oil in your nose every day after morning bath and in the night before sleeping.

Pranayams: Kapalbhati, slow deep long breathing, Anulom Vilom, Agnisaar, Bhastrika (only in winter season). Regular morning brisk walks about 3 to 4 kms and slow walk about 1.5 kms in the night after dinner.

Vegetables beneficial for diabetic: Cucumber, Turnip, Garlic, Onion, Lauki, Bittarguard, Spinach Fenugreek, bathua, Chaulai, methi, Amla, tomato, Carrot & Cabbage. In fruits you can take Jamun and Bel. Butter milk, diet rich in fiber is recommended. Whole grain and vegetables (with fiber) are very beneficial because they slow down absorption which helps a rapid rise in blood glucose.

Foods to be avoided: Strictly avoid potatoes in any form, rice, sweet fruits, fried food, all maida made items in any form, oils, meat, fish and non-veg food, Murraba, tobacco in any form, refined sugar, soft drinks and alcohol.

Personal behaviour Avoid Anger, Stress and worry: Ayurvedic Treatment-Tender leaves of the mentioned plants eaten during morning walk reduce the blood sugar level. Leaves of Neem Sadaabahar, Jamun, Gurmaar, Apple guard, Lemon, Karela fruit, Gyloy sticks, Mahua, Aloeveera 4 to 5 leaves only, Black pepper and dry herbs vijaysoar, dry gyloysticks, Paneer Dodaa (dry kashmiri flower) will be very beneficial.

Most important suggestions: For Diabetic patient Food control is necessary. Eat small amount of meal at frequent intervals rather than a few large meal each day. Try to be tension free,

be happy and smiling always. Do regular yoga and morning walk. Be careful eating guava (Amrood) fruit. Peel of the skin (thin), Eating with skin causes immediate rise in blood sugar. Diabetic patient must strictly follow this suggestion, he should attach a small card with his identity card mentioning in bold latters Diabetic Patient in English and Hindi.


